The meeting was called to order by Director Louis Cappelli, Jr. at 7:00 p.m.

The Clerk called the roll and the following Freeholders answered:

The Director stated that adequate notice of this meeting has been provided in accordance with the Open Public Meetings Act.

The Director asked everyone to rise for the Pledge of Allegiance which will be led by Deputy Chief of Police Jim Walsh and the National Anthem which will be sung by Sterling High School Silvertones.

The Director thanked them and asked for a round of applause. He asked all the Veterans in the room to stand and be recognized and said Happy Veteran's Day, and thanked them for their service.

The Director said the County has available if requested large print agendas for the visually impaired. He said if you require a large print agenda please see the clerk seated to his far left.

The Director welcomed everyone to the meeting of the Camden County Board of Freeholders and said we are pleased to be here in Somerdale. He said it is the practice of the Board of Freeholders to hold its meetings each month in one of our municipalities outside of the county seat of Camden, so that all members of the public will have full access to the meetings of the Board. He said they will now ask members of the governing body of Somerdale to come forward.

Director Cappelli said they are very proud to call the governing body in Somerdale their partners in government, and that they have a long tradition of outstanding leadership going back to Councilman Perry's dad in 1971. He said that type of leadership has endured here in Somerdale, he said they are doing a great job in economic development and creating new ratables in town. He said it has always been a wonderful small community and that is because of the leadership of people like them.

Councilman Perry said on behalf of Mayor and Council he thanked them and said they appreciate everything that they do for the Borough. He thanked them again!

PRESENTATIONS

Freeholder Moen said on behalf of the Board of Freeholders they are proud to present to them tonight their annual CDBG funding in the amount of \$26,200.00.

Giavanna Troilo said thank you for having them there tonight and said the Sterling Preforming Arts Booster Association helps them out with their Silvertones program and said they are so lucky to have so many parents that are dedicated to them. She said this is a big deal to them to have the donation go to them. She thanked them again!

COMMUNITY AWARD

Freeholder Shin-Angulo asked the Murrow family to come forward. She said this is unique because we are giving this proclamation to William, and unfortunately William is not here today because he passed away back in July however we know that he is here in spirit. She said William has been an active community member in Somerdale for a long time and they know that he loved Somerdale. She said he was a Vietnam War Veteran and he served in the US Army during WWII, was a member of the Somerdale Fire Department and a past member of the Fire Police, former member of the Somerdale Borough Council and he was Council President. She said William also served on the borough's Planning Board and has been married to his wife, Esther, for sixty-seven years. She said on behalf of the Freeholder Board they would like to present this proclamation to them. She said they are so proud and honored to be here and they know that William is there in spirit.

Esther would like to thank everyone for coming and knows that he is looking down on us and is very proud. She thanked them!

YOUNG COMMUNITY LEADER

Freeholder Young called Gillian Granato up front and said each month as they travel through each municipality they would like to find a young community leader that is very dedicated to his/her community as a youth. He said Gillian is a resident of Somerdale and a student of Sterling High School and has participated in Cross Country and Track at Sterling. He said she is in the schools NJROTC (Navy Junior Reserve Officers Training Corps) program and is an Administration Officer for the Navy Knights and is also responsible for Administrative records of one hundred cadets, she dedicated about thirty hours per week to planning, training and participating in numerous NJROTC events. He said she publishes the course plans of the week and has four cadets working for her and she has accumulated over 150 community service hours for her first two years in NJROTC unit. He said for this accomplishment you are this month's young community leader.

SUSTAINABILITY AWARD

Freeholder Young said Camden County looks forward to trying to change the carbon footprint of the county as well, so each month they do a Sustainable Champion for the month. He asked Ms. Valerie Flynn to come forward, he said she is an active member of the Somerdale Green Committee, contributing both her time and knowledge 2363866.vl

of gardening to our community. He said she is instrumental to the annual Earth Day event and helps to coordinate the operation of Somerdale's Community Garden, he said the Garden is open to all residents and residents are encouraged to take the vegetables in it that are growing throughout the summer. He said every August at Somerdale's outdoor concert series Valerie makes vegetables for the garden available to concert attendees in the "Jersey Fresh" theme night. He said she also creates various dishes with vegetables for attendees to sample. He said each sample has an accompanied recipe card to encourage healthy eating, he said this has become a big hit, and for her efforts going above and beyond for the community, for that you are this month's Sustainable Champion.

Valerie said it is super easy to grow your own little herb garden, she said you can do it with scraps and can create your own little compostable area in your little yard or it can be in a container a front stoop or whatever so just keep in mind it's super easy and you can teach kids. She said one person's trash is another person's treasure.

EMPLOYEE OF THE MONTH

Freeholder Nash said it is his pleasure to present the person of 3,000 Camden County employees who has been selected as the employee of the month and this month that employee is Alfredo Soto. Freeholder Nash said this is exciting for him because if you have noticed in the Camden County Parks System, the county has put an extraordinary amount of time and effort into beautifying each of the twenty county parks. He said if you approach any of the county parks you would see the landscaping that has been greatly improved, and the county grows its own flowers at its Lakeland Facility; through a greenhouse. He said there is a group of people that go out who are nameless and have a special expertise in landscaping and Camden County is so fortunate to have one of those people working in the Parks Department and that is Alfredo Soto, who plants the flowers. He said Alfredo has worked in the Parks Department since 2013, he asked Frank Moran the Director of the Parks Department to come forward. He said Alfredo has devoted his entire career into beautifying our Parks System and we are so appreciative. He said Alfredo is a laborer in the Parks with an expertise in landscaping and he receives all the compliments from the residents who enjoy the parks; he has also been married for twenty-three years to Carmen. He said what makes this story even better is that Alfredo is a survivor of cancer and has been in remission for five years now so if you would think about how significant it is to have fought that battle and to be in remission for five years; for being married for 23 years; having five kids; two grandchildren; and beautifying the county's twenty park systems, you can understand why we have chosen Alfredo from thousands of employees to be our employee of the month with great appreciation. He thanked him again!

Director Moran said he would like to add that Freddy was literally on his death bed and Freddy got out of that death bed, became a seasonal Parks employee. He said the Parks prides itself with hiring individuals as seasonal employees who become employee of the month, he said Alfredo is a true role model for all our employees. He said he is an exceptional worker; and in his prior life he worked for a private landscaper, so he came in as an experienced individual. He said a lot of the work that is being done in the parks, the beautification, the flowers that are planted are due to Freddy and the award meant so much for them to recognize him, knowing what he has been through in life. He thanked him for the work that he does!

Freeholder Nash said for all that Freddy has done for Camden County; and for surviving cancer; raising this beautiful family; Camden County has decided to give you a clock and a small token of appreciation from the Freeholder Board.

Freddy said he gets nervous but he would like to thank everyone for giving him the opportunity to work for the county. He said like Director Moran said he used to work for a small company, he said being here and trying to make a change together, we are going to make that difference.
