### The following Construction Activities took place during the period stated above.

## **Bridge Construction**

On Tuesday, May 29 and Wednesday, May 30, 2018, RE Pierson installed formwork for the bridge parapet.

On Wednesday, May 30, RE Pierson stripped the formwork from the bridge sidewalk and rubbed the front face using mortar mix.

On Thursday, RE Pierson placed 10 CY of NJDOT HPC Concrete with Visocrete 1000 Super P to partially complete the Bridge Parapet at East (40 LF) and West (23.75 LF) sides of the bridge. It should be noted that Craig Testing was notified but did not arrive prior to the concrete placement. The Contractor took 4 cylinders to be tested.

On Friday, June 1, 2018, RE Pierson installed formwork for the North ends of the parapets, on the east and west sides of the bridge. The Contractor partially stripped formwork from the parapets on the east and west sides of the bridge. Additionally, RE Pierson began drilling holes in the top of the northeast wingwall and installing rebars.

## **T-Walls and Roadway Construction**

On Wednesday, May 30, 2018, RE Pierson excavated soil and I-14 material from the South side of East Atlantic Avenue for roadway boxout. Excavated material was used to backfill area behind Retaining Wall, Location No. 2.

On Thursday, May 31, 2018, RE Pierson loaded soil from the roadway boxout and trucked it off site. The Contractor began excavating the roadway boxout at the South side of East Atlantic Avenue, placing I-3 Material (Subbase), leveling with a bulldozer and compacting with a roller. DGA was placed over I-3 material and compacted with a roller.

On Friday, June 1, RE Pierson placed and spread topsoil at the North slope in front of Retaining Wall, Location No. 1.

#### **Utility Relocations**

PSE&G was on site Tuesday, May 29 – Friday, June 1, 2018. Work included installing utility poles at the northwest corner, placing sleeves on existing wires, and installing new wires pole to pole. A Conrail flagman was on site on Wednesday, May 30, 2018. PSE&G decommissioned existing wires on poles on Thursday, May 31, 2018.

#### **Memorial Day**

No work was performed on site, Monday, May 28, 2018 due to the Memorial Day Holiday.
