# CAMDEN COUNTY BOARD OF CHOSEN FREEHOLDERS FREEHOLDER MEETING JULY 16, 2015- 7:00 PM BELLMAWR FIRE HOUSE BALLROOM 29 LEWIS STREET BELLMAWR, NEW JERSEY 08031

The meeting was called to order by Director Louis Cappelli, Jr.at 7:00 P.M.

The clerk called the roll and the following Freeholders answered:

The Director stated that adequate notice of this meeting has been provided in accordance with the Open Public Meetings Act.

The Director called upon the VFW Post 7410 to lead everyone in the Pledge of Allegiance followed by the National Anthem, sung by Saint Joachim Parish Children's Choir.

The Director said there are large print agendas available for those who are visually impaired. If you require the large print agenda, please see the clerk seated to my far right.

The Director welcomed everyone to the meeting of the Board of Freeholders. He said they are very pleased to be in Bellmawr tonight. He said it is the practice of the Board of Freeholders to hold our meeting each month in one of our municipalities outside of our County Seat of Camden so that all members of the public will have full access to the meeting of the Board.

The Director said as is our custom; we will begin tonight by asking the town council members of the governing body to come forward for a presentation. The Director said I don't believe Mayor Filipek is here this evening.

The Director called upon Borough Council to come forward along with Freeholder Rodriguez.

Director Cappelli said we are proud to call this governing body in Bellmawr partners in government. He said they do an outstanding job on behalf of the resident's day in and day out. They have tremendous neighborhoods here in Bellmawr - Athletic Programs and it has always been a real tight community and that is thanks to the leadership of the folks to my left. He said I know Mayor Filipek could not be here tonight. It is also a very progressive governing body with regard to economic development and business development and we thank you for all your hard work. He asked the Council President to come forward and introduce members of council.

Council President Stephen Sauter welcomed everyone and said Mayor Filipek couldn't be here tonight, he had an unfortunate on July  $4^{\rm th}$  - he fractured his shoulder. He is on the mend and taking care of himself and wishes everyone the best. Thank you for being here.

Freeholder Rodriguez said as the Director said this is a community that works together and works hard together to make sure that the community is well served. As a result, you will now receive your CDBG award for the various projects that you have going on to creative improvements throughout Bellmawr and the amount that you will receive is \$35,800.00.

Council President Sauter thanked the Freeholders for this CDBG award. He then introduced Council.

#### CONDOLENCE RESOLUTION

The Director asked for members of the Piontkowski to come forward. The Director said on March 18<sup>th</sup> of this year, Bellmawr lost a true Bellmawrian - someone who lived and breathed for Bellmawr. That was former Councilwoman, Regina Piontkowski. He said her family is here tonight and on behalf of the Freeholder Board read parts of the Condolence Resolution to acknowledge the great things she did for Bellmawr and the entire community here in Camden County.

Director Cappelli said Councilwoman Piontkowski passed away on March 18, 2015 at the age of 82. She was born in Camden City. She was a former educator, graduated from Alliance College in Cambridge Springs, Pennsylvania before teaching at St. Joseph's Elementary School in South Camden for 17 years. She later worked for the Camden County Superintendent of Elections where she worked there until her retirement in 2007. Upon retiring, she volunteered at Holy Redeemer Hospice. He said her community service was tremendous and reached many. She was an active member of Mary Mother of the Church from its beginning and held many volunteer positions including RCIA Director and Choir Director. She was also a member of the Bellmawr Lions Club. The Director said tonight we want to express our deep regrets for your loss and we are presenting you with a copy of this Resolution as a small token of our appreciation for the great things that she did for our community.

Regina's daughter thanked the Freeholders.

### SUSTAINABILITY AWARD

Freeholder Nash welcomed everyone. He asked Michael DiVietro to come forward. Freeholder Nash said Camden County is one of the great leaders in New Jersey in terms of its efforts to encourage sustainability. Every month the County recognizes through the Sustainable Camden County Program and its Director, Michelle Gentek-Mayer, a resident who has gone beyond the call of duty when it comes to protecting our planet, protecting our environment and reducing our carbon footprint. He said this month we are extremely pleased to recognize Michael DiVietro as our Sustainability Champion in Camden County. Freeholder Nash said after you hear about Michael, you will realize that Michael is the Sustainable Champion on a day to day basis in Audubon, one of the neighboring communities and we are recognizing him in Bellmawr because of his incredible track record. Freeholder Nash said in May of 2014, Michael, who is an Audubon resident established the Audubon Green Team. In April, 2015, the team received a \$2,000.00 Sustainable New Jersey Capacity Building Grant. He is currently creating a Green Team page for the Borough's website. His passion for Green Technology and Sustainability was born several years ago when visiting the Museum of Modern Art in New York City and he has since strived to implement sustainable practice where he calls home. He works closely with the staff at Sustainable Jersey by using their concepts to create a framework for green practices in Audubon and he is heading for Audubon a Bronze Level Certification. Michael is a dedicated public servant and has worked as a paramedic at Virtua Health for 10 years and he is now a full time firefighter in the City of Camden. He is pursuing his planner's license while working part-time at a Civil Engineering and Land Use Planning Firm and he is also on the Board of Directors for the Southwestern Chapter of the New Jersey American Red Cross and Treasurer of the Audubon Recreation Executive Center's Board. The Freeholder said we are so

proud to recognize you for not only everything that you've done but to thank you for all you have done not only for Audubon but for Camden County and for all of us. Thank you, Michael!

## PROCLAMATION

Freeholder Rodriguez called upon Sara Kucharski and Koren Norwood, along with Ann Biondi to come forward. Freeholder Rodriguez said these two young ladies did something very, very phenomenal that I definitely wanted brought to the Freeholder Board's attention. They saved a life! She said these two young ladies as they were driving down Route 130 noticed a car accident. They stopped what they were doing - they pulled over. They handled the situation, they took over, they noticed an individual who could not breathe, who was literally dead. They administered CPR, called 9-1-1 and saved a life. The reason why I am extremely proud of these two young ladies in addition to the fact that they saved a life is that they are also Camden County employees. Freeholder Rodriguez said I am so proud when I see our Camden County employees and know day in and day out how hard they work. It makes me even more proud that these individuals give so much to the community inside and outside of the work that they do. Their actions show the compassion, the care that exists within the people that works in this County on behalf of the people in this County. She said I want to commend them because not only did they do something absolutely miraculous, but they also represented their Health Department very well in doing so. Thank you so much!

Ann Biondi, Director of the Health Department, said the Freeholder asked me to say a few words and I would love to do so. She said the two women that you see here are not only Camden County employees but they probably are our brand new shiniest employees. Koren started in March 2014 and Sara started in April 2015. They are rookies and as you can all see off to a rousing start. I am delighted to have them. I had the privilege of sitting in on both of their interviews and I had no doubt that they were going to do a great job. What they do and I don't know if that got mentioned but they drive our Camden County Health Connection Van all over Camden County. It is a 39 ft. trailer - I am in awe!! She said I see it coming down the street with them driving - I would have to quit if I had to drive that. It is awesome that they are able to do this it really is. It is a huge effort. Today, they were at the Boys and Girls Club. They left there, drove our Camden County Health Connection Van's nickname is Betsy. She said Betsy got parked back in Blackwood and they came up here to the meeting. She said the day that the life was saved they were coming from Branch Village. They were helping our most fragile, giving blood pressure screenings and diabetes and everything that we do. She said Koren is a Health Educator in Community Health and Sara is a Registered Nurse. I want to thank them, you are terrific. She said we are doing a new thing with our Employee Connections Program ABCD (Above and Beyond the Call of Duty). I think this is a good way to start. I thank them both!!!

Freeholder Rodriguez said, Ladies, you got off to a great start, I am so proud of you. Thank you so much. On behalf of the Freeholders, you will receive this beautiful Proclamation to recognize what you have done and to memorialize your actions forever in the history books of Camden County.

Sara thanked the Freeholders honoring them for this every day type of outreach that we can do for our community. She said I encourage everyone to get educated on CPR training and also to recognize that the heroin addiction that is out in the community is everywhere, it is not just in Camden City. She said please be aware there are a lot of people in our communities that you wouldn't expect with this addiction and that they need help. I thank you very much.

Koren thanked everyone and said I am very privileged and very humbled. She thanked the Freeholders and to her supervisors who are so caring. She said certainly I wouldn't have this if it wasn't for Sara. Just watching her - it was an amazing sight to see how she responded to the call of duty. She said as we approached the incident and we saw what was happening, I looked over and Sara was gone - I feel like she flew out the window with her cape on!! She was amazing to watch and I realize she would do it all again and I certainly would watch all over again. Thank you, Sara.

The Director recognized Camden County Sheriff Chuck Billingham.

### PRESENTATION

# Bellmawr Hockey Association, Inc.

The Director called back up any members of Council that were still present. Freeholder Young called upon members of the Bellmawr Hockey Association to come forward. He said on behalf of the Freeholder Board, we would like to honor the Bellmawr Hockey Association. Freeholder Young said Bellmawr Hockey has been around since 1988 and it has brought street hockey to kids from around Bellmawr and surrounding areas. It's intent was to teach youth to respect teammates, coaches and parents. They have quickly grown to 900 kids at one time - ages from 3 to 16. There are 9 All-Star Teams, three divisions. He said I understand we have some National Champions as well. The Cadet 18 was undefeated and the Cadet B Team Penguin team also won a National Championship. Parents are very supportive. They do a great deal of fundraising for improvements of the Association. He said this is pretty close to my heart because I do a lot of coaching myself - I deal with youth sports, I love it and I know how much and how tireless it is sometimes. He said the thank you's are never enough but I would like to tell you from one President to another, I appreciate what you do, the sport appreciates what you do and the County appreciates what you do. He said without sports, I truly believe that sports changes youth's lives. They teach respect, they learn He said the Board of Freeholders does hereby honor respect. Bellmawr Hockey Association, Inc. on July 16, 2015.

Chris Brennan, President of the Bellmawr Hockey Association, thanked the Freeholders and said we really appreciate it. He said the boys are now preparing to go to a tournament in Massachusetts next month where we hope the streak will continue for us and they will win that one for us. We will have an undefeated year!! Thank you.

Freeholder Nash called upon Coach Christian Carkeek with some young men from Cherry Hill Township to come forward. Freeholder Nash said last month our Freeholder meeting was in Cherry Hill, New Jersey and we postponed this recognition to this month so we could get some of these young men present at a Freeholder meeting. He said if you live in Cherry Hill like I do, you know that there is a huge sporting event every year and it is called the Mayor's Cup. He said the four Little Leagues in Cherry Hill compete with each other and the winner wins the Mayor's Cup. Freeholder Nash said this month, the Mayor's Cup goes to the Cherry Hill Youth Athletic Association White Sox. #### RESOLUTION 85 NO MOTION MADE-FAILED

The Director said at this time the meeting is open to any member of the public who wishes to address the Board of Freeholders. He declared the public hearing open.

85. Resolution acknowledging personnel actions by or on behalf of constitutional or statutory row offices.

Robert Heckman of Bellmawr addressed the Freeholder Board. Mr. Heckman said I don't know if you people have any involvement about Bellmawr Mayor and Councilmen. He said I have repeatedly gone to the meetings at least once a year about the Bellmawr Public Storage. He said there is already a problem with drugs and riff raff that hang on that street. Mr. Heckman said I was just in Court this morning and, of course, half of them didn't show up so it was postponed again. He said this has been going on for three months. He said I realize that the Mayor and Council don't have anything to do with the Court. He said I have gone on repeatedly about the Bellmawr Public Storage; the overgrown trash. He said years ago we got a notice in the mail that Bellmawr Public Storage was buying the piece of property. They called adjoining residents - every resident said they didn't want that back there and they pushed it through Zoning Board Meeting. He said that ground was designated commercial/residential C property which meant only apartments or houses could be built on it. They changed it to commercial property - I believe the Mayor of Brooklawn bought the property. The Mayor of Bellmawr was the Mayor that had the Zoning Board Meeting called. He said I went in and said that nobody wants this thing - they put it to a vote and it went 5 to 2 against us. He said they did change it to commercial C property and they were telling us it was going to be a parking lot. Mr. Heckman asked, there are not going to be any buildings and they said, no. He said partially that is right, there are no buildings. You don't dig five feet down to put in a parking lot. They were going to build public storage there. He said I told them before it started that the Alcyon Drive people are sick and tired what went on in the front part when they built that. There is an underground well - you can't build on it without running all kinds of sewerage there and everything else. I have gone repeatedly to the Mayor and said it has been overgrown - I've called mosquito control; I've gone to the meetings, I get looked at like I am some kind of deviant or something because I am up there complaining. The weeds and vines are growing up over our fences on Alcyon Drive. I told them when the meeting went on that this was going to be sitting as a hole for a long time. They started digging immediately - no permits or anything so I had it stopped for one day, then the second day they broke a water main. I have been asking for the bill for that water main for over 9 years. That is when this was started in 2005 and it hasn't been maintained. He said I believe they have cut the grass eleven times in the 9 years and I want to know how I can get this taken care of - I've called people in the State and apparently no one wants to know about mosquito problems or erosion on my property. The Director responded and said for the most part it sounds like it is a local enforcement issue. It is up to the local municipality to do that. Mr. Heckman said that in the State of New Jersey people are allowed to build and dig right up to your property and destroy your property? The Director said what I am saying it is a local issue, a municipal issue. The issue of the

mosquitos is something we can help you with and he asked Mr. Heckman to give his contact information to his aide, Anthony Bianco, so we can call you and get the mosquito control out. Mr. Heckman said I am about ready to bring Eyewitness News in - I want an investigation. He said I know everyone is getting awards up here and I don't mean to put a damper on that. I have been going to these council meetings for 10 years and they just laugh at me. The Director said we do not have jurisdiction over local code enforcement issues and what you are describing so far tonight is a local code enforcement issue. We just don't have jurisdiction but the mosquito problem, we may be able to help you with that.

Sandy Bengel of Gloucester Township, addressed the Freeholder Board. Ms. Bengel said I am a production assistant, I am working on a show called Ciao Bella - Living Italian Style. She asked if anyone remembered the Al Alberts' Show. She said I am working from the producer of the Al Alberts' Show, Barbara Ann Zippy and she is Executive Producer of Ciao Bella Living Italian Style and she is Al Albert's niece. She said we are doing a show all about Italian lifestyle - it is cooking, it is older people that are in the kitchen and we are doing an Italian Movie Night, where people come in and see different films. She said right now we are on Radner 21, which is the local access channel in the Philadelphia suburbs and the mainline. She said we are in about 100,000 households. Our sponsor is the Italian American Herald. We have about 20,000 subscribers to that. Ms. Bengel said what I am looking for - we are trying to branch our demographic - we are trying to get some more households in New Jersey. We have none in New Jersey. She said we are doing pretty well with Delaware and we are probably going to get Philadelphia. We are looking for not only a public access channel but the local channels. It would be free of charge, just like a flip of a switch. We can do any type of link; any type of format. It is a half hour program. She said our last guest was Charlie Gracie. He said we have pretty good guests. The Director said you are looking for access to local channels, correct? The Director said Sandi Kelly is standing over there and she is our Director of Marketing so she is out to all the municipalities. She would be the person for you to speak to - good luck !! Ms. Bengel said that is great and thank you for your time!!

Brian Everett, identified himself as a student of Rutgers University in Camden and addressed the Freeholder Board. Mr. Everett said as of March of this past year, I received an Open Public Records from the City of Camden highlighting the danger that RCA Building poses to the public; how, as of 2004, the City ordered the curb lanes of Cooper Street and Front Street to be closed because of the debris falling off of it. He said back in August of the past year, the City of Camden did re-inspect the building only to close the sidewalk portion of the surrounding area. That still took over three weeks to happen but the continuing danger right now is that a Riverline station sits directly beneath the Radio Lofts Building and if you go and visit this particular station, you can see where debris has completely ripped off a gutter from the station. I am here to ask if there is anything the County can do as the City of Camden is going forward with trying to help the City with its demolition efforts because, of course, in September the students and professors who visit Rutgers University will be very present in that area and I just want to make sure that nobody does get struck by the debris that falls off of this building. The Director called upon Director of Public Works, Sam Martello and asked if there is something we can talk to the City and take a look at this situation. Mr. Everett was going to speak with Mr. Martello. Mr. Everett thanked the Freeholders.

Seeing no one else wishing to comment, the Director asked for a motion to close the public portion. Deputy Freeholder Director made a motion to close, with a second by Freeholder Leonard and all Freeholders voted aye to close the public portion.

The Director said at this time I will open the floor to the Freeholder Board for their comment.

**Freeholder Nash** said I just want to recognize the great event that was put on at Wiggins Park for July 4<sup>th</sup>. The music was outstanding and he thanked Special Events and the Parks Department who are doing such a great job. He said I want to pay special recognition to the governing body in Bellmawr that always does a great job. Thank you.

**Freeholder Leonard** said I too want to thank Council for being here tonight. It is always a pleasure to be here in Bellmawr. Unfortunately, the Mayor couldn't be here but it is for good reason - he got hurt on July 4<sup>th</sup> at the Parade. Freeholder Leonard thanked the Public Works Department and Parks Department for all their hard work with these recent storms that we had. They have been out day and night two weeks ago when we had that severe storm working in the Parks and our Roadways to ensure that the public was safe. He thanked all the employees in Camden County for all their hard work. Thank you.

**Freeholder Rodriguez** thanked the Council and hopes that the Mayor feels better very soon. She thanked the residents of Bellmawr - it is a lovely community to come to and it is a beautiful venue that we have here. I do want to give a special thanks to our employees of Camden County because as you have seen today, they really do exceptional work and that is all of them from top to bottom - all the departments. She said our July 4<sup>th</sup> event was absolutely amazing as usual but it was absolutely amazing. Our office of constituent services - especially from my office with all the issues that I have - social issues, they have been absolutely instrumental in fielding so many of the concerns of the residents and just make sure that the constituents receive the services that they need and that they are able to communicate well - they are very wonderful at mediating on behalf of many of our constituents. She said all of our departments, including the Board of Social Services who also works hard for our constituents. I want to thank everybody and wished everyone a good summer.

**Freeholder Gentek-Mayer** said I would also like to thank the Mayor and Council for hosting us tonight. She thanked the departments that she oversees. She asked if anyone was there for the 9-1-1 Center – and asked them to stand. She said I would like you to be noticed because with the storms we have had a lot of people to call into our 9-1-1 Center. She said sometimes we don't really think about what they do – they are saving the lives of the residents of Camden County to make sure that they are dispatching the correct people out and getting a timely response. We thank you so much for everything that you do and know that we are very thankful for you and just be proud of what you do. Also, to our men and women who work in our jail – thank you to all of you – I know it is a hard job and just want to give special thanks. To my Department of Sustainability, everybody that works there – you are working so hard this summer. You placed 15,000 plants in the County – congratulations to all of you. Have a good night.

Deputy Freeholder Director McDonnell thanked Bellmawr Council and for welcoming us and having us here tonight. He said I wanted to congratulate Ross Angilella, our County Administrator and David McPeak, our CFO, we received our final 2014 Audit this week and it was once again as it is year after year an absolutely clean audit with no exceptions. Congratulations to them. He thanked all the County employees who do such a great job every day. **Freeholder Young,** thanked Mayor and Council for having us here in Bellmawr. He thanked our Department Buildings and Operations – you do a fantastic job. Thank you for all that you do. He said I did a little walk in Bellmawr at the Parade. There are really great folks here. Thank you very much.

The Director asked for a motion to adjourn. Freeholder Rodriguez made a motion with a second by Freeholder Deputy Director McDonnell and all freeholders present voted aye. The meeting was adjourned at 7:50 p.m.
