The meeting was called to order by Deputy Director Edward T. McDonnell at 7:05 p.m.

The Clerk called the roll and the following Freeholders answered:

The Deputy Director stated adequate notice of this meeting has been provided in accordance with the Open Public Meetings Act.

The Deputy Director called upon the Five Star Service Unit Girl Scout Troop of Winslow Township to lead everyone in the Pledge of Allegiance followed by the National Anthem, sung by Merle O'Brien, Lois Pressey, Nellie Jordon and Eleanor Young.

Deputy Director McDonnell thanked the Five Star Service Unit Girl Scout Troop and the ladies for their participation.

The Deputy Director said there are large print agendas available for those who are visually impaired. If you require the large print agenda, please see the Clerk seated to my far right.

The Deputy Director welcomed everyone to the meeting of the Camden County Board of Freeholders. He said we are very pleased to be in Winslow Township. He said it is the practice of the Freeholders to hold our meeting each month in one of our municipalities outside of the County Seat of Camden so that all members of the public will have full access to the meetings of the Board.

The Deputy Director said as is our custom, we ask Mayor Barry Wright and members of the Winslow Township Council to come forward for a presentation to thank them for hosting this meeting. He called upon Freeholder Rodriguez to come forward also.

The Deputy Director thanked the Mayor and Council for hosting the meeting. He asked Mayor Wright to introduce the Council members - Anthony Tomasello and Evelyn Leverett.

The Deputy Director said we want to thank you so much for having us here tonight. I always enjoy coming to Winslow, he said.

The Deputy Director said one of the reasons is because of Barry Wright who is just a terrific person and the "Best" Mayor in the Room tonight. He said we have a tremendous working relationship with him. He said we work through our public works department and Barry is always nice enough to compliment all the work that Sam Martello and Dominic Vesper and staff do on the roads to try to keep our County roads in great shape and so many other things that we cooperate on, particularly in the area of economic development.

The Deputy Director said this is probably "THE" Mayor and certainly all kidding aside in Camden County when it comes to economic development what he has done in Winslow Township and what you are going to do now with the Atlantic Basin connection is going to be fabulous. The Deputy Director said, "Mayor, thank you so much for having us and I also have something else I want to do. He said Freeholder Rodriguez has joined us and each year we are fortunate to give out a check from the CDBG Block Grant Fund and tonight we are presenting to you, Mayor and Council members, a

check from a Program that Freeholder Rodriguez oversees and tonight's check is for \$69,100.00 for Winslow Township.

### **PRESENTATION**

The Deputy Director said the other thing we do when we come to a town is we ask the Mayor to tell us of a group in town that really does great work. We don't have much to give them but we do like to congratulate great groups that do great works in town. He said we have a Certificate and small donation. He said the Mayor of Winslow Township decided that the non-profit that is going to accept the award Rubies & Pearls. Melissa Laster who is the Vice-President came forward. The Deputy Director said this is an organization for young women who are mentored and work together to help them be and grow to have great futures and careers and also to mentor younger women to do the same. He said not only do they do that but part of their becoming mature contributing citizens, they go into the community to do work and do volunteer work. They even do some fundraising. The Deputy Director called upon Melissa to say a few words and thanked her for all her work.

Melissa Laster, Vice President of Rubies & Pearls, said I am standing here on behalf of Ms. Diane McKenzie, who wasn't able to make it this evening. She is our CEO and Director. Melissa said Rubies & Pearls has been established for the past four years. She said we meet at the STAR building on Erial Road on Saturdays from 10:00 a.m. to 12:00 p.m. She said we work with ladies from the ages of five years old to 18 years old. She said our focus is to make them productive women in society by building their self-esteem, their leadership skills, the importance of higher education, their faith in God and also build the gaps in their families. She said a lot of children are brought up in broken homes now so we do a lot with their mothers to build their relationship if needed. She said I love the girls, they are all my little sisters because I don't have any sisters, I have all brothers. They are beautiful young ladies that go to school in Winslow - we have students who have 4.0 GPA's. The children of Winslow are doing good things. We do a lot of community service. They are going to ask to do more community service this year working with children who have special needs. One of our young ladies who will be a senior at Winslow High this year, was the one who coordinated a whole Breast Cancer walk for our girls, they did all the fundraising, and earned about \$600.00 doing it on their own. They saw how important it is to raise money for a good cause. She thanked everyone again. She said we will be going to Back to School Night and have brochures out - if you know ladies from the ages of 5 to 18 and would like to join the group, feel free to come out on a Saturday at the STAR building. Thank you.

Mayor Wright said this whole idea of mentoring our young children and I give Diane and Melissa so much credit for giving themselves so selflessly to guide these girls in the right direction. He said I was at an event they had in the Park at the STAR building a few weeks ago where a National Organization from New York actually came down and gave the Rubies & Pearls some school bags and school supplies because of their accomplishment. He said out of 23 girls 17 made the honor roll this year!! He said in Winslow Township, we are extremely proud of the job you are doing and you are going to provide us with some great female leaders in the future. Thank you.

### **COMMUNITY AWARD**

The Deputy Director said as we go from town to town we like to find people who have made extraordinary contributions or organizations and in this case, the organization is the Winslow Township Lions Club. Representing the Lion's Club is Howard Weimer and Tom Eckardt. They came forward.

Deputy Director McDonnell said we have a Proclamation for you to thank you for the great work that you do. He said it is all good words about how great they are but rather than read the whole thing, I do want to mention a couple of things that are said in here. The Deputy Director said Winslow Township Lions Club was chartered in 1952. Also, Lion's Club International, itself, the entire organization was started in Chicago by a man named Melvin Jones in 1917. He said the organization, Lions International has 46,000 clubs and 1.35 million members in 200 countries. He said as you know and a lot of us know through the Lion's Club what they do about the vision issue for folks. He said this Lions Club is a little different - they go way beyond that mission of providing eyeglasses and eye exams for kids and adults but they also make such major contributions to the community. He said Mayor Wright asked if he could stay up here because he wanted to talk a little bit about what they folks do beyond what you normally think of the Lions Club. They do so much more to help Winslow Township.

Mayor Wright said when you are the Mayor of a town and different things come up - you look around either the tax money is not there - the one organization we can always count on and depend on is the Lions Club. For instance, he said, our Veterans Day celebration which is so important to us, the Lions Club provides the refreshments for that event. When it comes to Memorial Day, it is so important to remember the people who gave so much for this country and for this Township, the Lions Club once again is the organization that is there. Our celebration committee as far as we go whether it is for Halloween, or Easter Egg Hunt, once again the Lions Club are there - these people give so selflessly. On behalf of the governing body of Winslow Township and the residents, we thank you for all the work you do. Thank you.

Deputy Director presented Mr. Wiemer and Mr. Eckhardt with the Proclamation and congratulated them.

Mr. Wiemer thanked the Board of Freeholders on behalf of the members of the Winslow Township Lions Club for this award. He said it is very much appreciated by us. Some of the things that we recently got into which we feel is very important today is the food banks. We have donated to three different food banks and we are going to continue this because we know there are a lot of people out there that don't get what they need on a daily basis. That is one of the things and we are also into helping the hearing impaired - we supply hearing tests for people and hearing aids. He said like the Mayor said, we have the eyeglass examinations and we support buying eyeglasses for people and also work with the blind.

He said believe it or not the blind use the computer better than I will ever be able to use it! They really have great programs out there for them. These are some of the things we do for support. Thank you.

Mayor Wright said there is a little bit of irony - the Lions Club of Winslow was started in 1952 and believe it or not I look young but I was born in 1952 - that is a pretty good year!

He said I want to take this opportunity to tell you what this Freeholder Board has done for us in Winslow Township. He said we have Freeholder Leonard with Sam Martello and a wonderful County Engineer, Kevin Becica. When you look at the roads they repaired in Winslow Township, Fleming Pike, Cedarbrook Road all the way out to Route 73 and the Biway at New Brooklyn Lake. They just finished Williamstown Road all the way day to the light in dire need of repair. He said we see Berlin New Freedom Road all the way out to Berlin. He said we waited so long for these things. It is happening in Winslow Township. He said I have to say the response this year, after the terrible winter we had in fixing these potholes, I actually called Ian Leonard and asked him if he was renting space in my storage unit for this pothole machine because I see it in Winslow so much. He said Jeff Nash and Frank Moran with the County Parks, what they have been able to do with the County Park over there, they actually established their first 18 hole disk

golf course in the area. He said disk golf is a new game and because of Jeff Nash and Frank Moran we have a golf game that I don't embarrass myself with. He said we have Michelle Gentek and Chris Waldron with their efforts with our Sustainable New Jersey action here which resulted in a \$10,000.00 grant we received this year with all these environmentally sound issues that they are coming forward with. Carmen Rodriguez, I can't say enough about her and the Board of Health - providing our Seniors with eye screening, flu shots and bringing the Health Van down to Winslow Township - thank you so much, Carmen and your staff. Scot McCray and the Communications people, we have Director Blaker and the Chief in the back. He said I don't know if you are aware of it but we have transferred all of our Police and Emergency Communications to the County Communications Center. What does that mean to Winslow, we have an up to date \$39 million complex handling our emergency calls now, which means a savings to Winslow Township of \$600,000.00 a year. That is how we control taxes - that is the County and the Township working together. He said this whole transition which started on June 1<sup>st</sup> has actually and I give the Director and his staff credit, so smoothly it is unbelievable. The Mayor said one of my favorite Freeholders, Ed McDonnell, when you talk about economic development and I have to put Director Cappelli in there as well - what they have been able to do because of their push and the sewer intercept line and sewer moratorium being lifted that was a \$59 million project because of this gentleman behind me and Lou Cappelli and that Board that it is done! What does that mean, the sewer moratorium has been lifted and it means Winslow is on the move. I will tell you right now, with just the building permits that have been issued for what you see on Cross Keys Road, Gloucester Township, eat your hearts out, it is in Winslow now between that and Taylor Woods that is a \$16 million increase in tax rates for Winslow Township. Even more important than that, when that construction is done, we have created because of their help 600 new jobs in Winslow Township that is very significant to our residents in Winslow Township and because of that and because of us being on good fiscal ground with the help of this Freeholder Board, we actually this week just had our Bond rating increased two points. That means that we are looking at a significant decrease in the interest we pay on our Bonds. On behalf of all of us, I thank this Freeholder Board and I thank you all for listening tonight.

The Deputy Director thanked Mayor Wright for those very kind words.

The Deputy Director said I would like to take a moment to introduce another Mayor in the room tonight - Stratford Mayor John Gentliss. Thank you for being here.

The Deputy Director proceeded with the Agenda.

**PUBLIC HEARING - RESOLUTION OF THE COUNTY OF CAMDEN IN THE STATE OF NEW JERSEY AUTHORIZING A GUARANTEE BY THE COUNTY OF THE PAYMENT OF THE PRINCIPAL OF AND INTEREST ON NOT MORE THAN \$1,600,000.00 AGGREGATE PRINCIPAL AMOUNT OF THE "COUNTY GUARANTEED REVENUE BONDS (THE BATTLESHIP NEW JERSEY PROJECT), SERIES 2014 TO BE ISSUED BY THE CAMDEN COUNTY IMPROVEMENT AUTHORITY FOR THE PURPOSE OF FINANCING CERTAIN CAPITAL IMPROVEMENTS ON BEHALF OF THE HOME PORT ALLIANCE FOR THE USS NEW JERSEY, INC.**

The Deputy Director declared the Public Hearing open. Seeing no one wishing to comment, the Deputy Director asked for a Motion to close the Public Hearing. Freeholder McCray made a motion to close the Public Hearing with a second by

Freeholder Rodriguez and on roll call, all Freeholders present voted aye.

The Deputy Director said it is noted for the record that we will be adopting this Bond Resolution at the September meeting.

#### CORRESPONDENCE

The Deputy Director asked if there was any correspondence. The Clerk advised that there is a note addressed to Thomas Castellano of Senior Services from The Pennsauken Senior Tower residents, as follows:

"Dear Tom,

Thanks a million for organizing the Prize Bingo and other activities for Camden County Senior Citizens and for being so kind and gracious in reserving tables for Pennsauken Senior Tower residents at the various events. We really appreciate it.

The Deputy Director said very nice and for those of you who don't know it Tom Castellano runs our Senior Citizens Programs in Camden County and he really does do a great job. It is nice when someone takes the time to say so.

#### COMPTROLLER'S REPORT

The Deputy Director asked for a motion to adopt the Comptroller's Report. Freeholder McCray made a motion to adopt the Comptroller's Report with a second by Freeholder Rodriguez and on roll call, all Freeholders present voted aye.

The Deputy Director said the next portion of the meeting is open to the public for discussion of the resolutions to be acted upon tonight. There will be another public hearing later in the meeting in which you can discuss any topics at all but this portion is limited to the discussions of the resolutions upon which we will vote.

The Deputy Director declared the Public Hearing open.

**Mayor John Gentliss** of Stratford, addressed the Freeholders. He said I am the proud 2<sup>nd</sup> Mayor in the room!! He said what brought me here tonight is that I just wanted to thank the Freeholders for considering Resolution 17 for the milling and resurfacing of Warwick Road in Stratford. Thank you for your consideration and thank you for your expeditious work on trying to get the Bridge open at the High Speed Line. You guys do a great job. It doesn't go unnoticed at the Municipal level. Keep up the good work and, folks, they really do a good job appreciate what you have here because they are really here for the people. Have a nice evening.

Deputy Director McDonnell thanked the Mayor for his kind words.

**Shirley Corsey** of Winslow Township identified herself as a small business owner. She said I just had a question about Resolution No. 78 - it is a Chapter 159 for Workforce Learning Link Program. She said I would like to know more about that. The Deputy Director said Chapter 159 means that it is money we are getting from another source and in this case it is from the State for the running of this program. The Freeholder Board does not actually pay for the program. He said the Learning Link I do know. He said it is one of the training programs that we do for displaced workers, people who have lost their jobs. It is One Stop training programs.

Ms. Corsey said I am an eligible training provider and I wanted to know how I can be a part of that - maybe I already am because I am allowed to get people enrolled in my program. She said her business is Healthcare IT School of New Jersey. The Deputy Director said Kathy Mayfield runs One Stop. Ms. Corsey said I know Ms. Mayfield and I receive individual students but if this is some type of grant I want to know more about it. She said I own a school and am on the eligible training list so people on unemployment can enroll in my program. I hadn't heard of this Workforce Learning Link. The Deputy Director said I don't think it is new, I have heard of it. I am just not sure what it is specifically. The Deputy Director said we will get someone to call you.

Freeholder Rodriguez said in June we established an Addiction Awareness Task Force and this month we are actually appointing members to this Addiction Task Force. She said I want to take a moment to recognize some of these individuals who are here today who came all the way out here to be recognized and acknowledged. Freeholder Rodriguez called forward, Michelle Azan, Patti DiRenzo, Anthony Leone, William Lynch, Bob Wahlquist, Chief Christopher Winters of Pine Hill Police Department, and John Pelicane of Camden County. The Freeholder said I don't have an award or certificates for you but what I actually have for you is work. I hope you are ready. She said when Camden County took over the City Police Force - the Camden County Metro was created - there was something that really became very evident and that was the issue with addiction and the problem that it creates throughout the entire County not just the City. She said that became a real issue so the Freeholder Director and I went back and forth on how we are going to deal with this issue. One of the things that became very evident was that we needed an Awareness Task Force - individuals who could come together and really guide and drive how we deal with this very significant issue. These individuals are here because they have accepted a challenge to be able to create programming and guide us and direct us in addressing this real issue that we have in the community. The Freeholder said I don't want to call it a crisis because that is over used but it definitely is a very serious issue. They are here not to be rewarded but at least for a moment to be acknowledged for all the hard work they are going to encounter driving this force because they are going to be working hard on your behalf.

Freeholder Rodriguez called upon John Pelicane, who was instrumental from the very beginning in creating this.

Mr. Pelicane said I am the Drug and Alcohol Director for the County. He said basically we recognized that this is a significant problem - it affects every area of the County. He said Dominic Vesper, Jr., Freeholder Rodriguez and Director Cappelli and the rest of the team, Sandi Kelly, had put together a strong team. There are a lot of ideas and a lot of things we can do to turn the tide of addiction around and make a lot of headway. I am sure the team is ready to work hard and I am ready to work with everybody. Thank you.

Freeholder Rodriguez said thank you, all of you, and again we have your work cut out for you. We really appreciate the work you are going to be doing. She said we tried to get individuals from every aspect of the community. She said we have Chiefs and people from all aspects.

Freeholder Rodriguez said the Addiction Awareness Task Force, what we did was to pick people from different areas, including people who are addicted who offer some advice to the program - they are a part of it. She said we are taking little bits and pieces throughout the community. She said we have mothers of children who suffered through addiction. What they do - they are not fixing the problem, they are asking the same exact questions you are asking so that we can put things into place to help people in that situation.

Mr. Angilella interjected in response to a member of the audience. Mr. Angilella said in addition to what the Task Force is going to do, we in County Government are working with the Prosecutor, with the Judiciary and with our Jail. We do not believe that people who have a drug addiction problem belong in our jail. The jail is a precious limited community resource. We should not be filling it up with people who have an addiction problem. To that end, we have started the drug court that reviews people's drug problem and in the next year we will hire a contractor who is working with us from a nationally known firm to help us make sure that the right type of people end up in jail. Not people with medical problems and that is what addiction is. That is what we are working on. Also, Mr. Angilella said the new Prosecutor, I have spoken at length with her about this and she gets it. I think you are going to see some changes. Freeholder Rodriguez said that is what the Addiction Task Force is for - they are not going out and making decisions but they are advising us of all of these challenges that exist in our community so we can take action such as creation of the drug courts, etc. They are here to advise us on what we need to do to work things out and make things better for the entire County and for everyone.

Freeholder Rodriguez thanked all the new members of the Camden County Board of Freeholders Addiction and Awareness Task Force.

Deputy Director thanked Freeholder Rodriguez and said we are glad that you brought these folks up so we can know who they are and the hard work they will be doing.

**Suzanne Bradley** addressed the Freeholders regarding Resolution 28 Chapter 159 Funds into the Budget for the Camden County Office of the Prosecutor's Violence Against Women Act (VAWA) Grant Program. The Deputy Director responded and said that money is going to the Prosecutor's Office.

Freeholder McCray responded and said that money is going specifically to Women who have been a victim of domestic violence.

The question from Ms. Bradley is what happens to men who are victims of domestic violence. The Freeholder said I am sure there are agencies out there and he asked her for her contact information so he could meet with her to discuss further.

**Shanell Preacher** addressed the Freeholders and asked about the Stop the Violence Program and how people abuse it by getting around the system. She said they are using the system and file claims in Court but don't show up for Court. She said it is not right to be using the taxpayers' money. The Deputy Director responded and said you are talking about the Judicial System and that is run by the State. He said we really don't have any input into that at all. She asked if the Freeholders would look into it further.

Seeing no one wishing to speak, Freeholder McCray made a motion to close the public hearing with a second by Freeholder Rodriguez and all Freeholders present voted aye.

The Deputy Director said at our Caucus Meeting on Tuesday evening, the Board of Freeholders reviewed the Resolutions to be acted upon tonight. It was at that time that the Board discussed the items to be voted upon. He said we will be voting on Resolutions in blocks based on the unanimous consent of the Freeholders.

The Deputy Director said at this time the meeting is open to any member of the public who wishes to address the Board of Freeholders on any topic. He declared the public hearing open.

**Thomas McCann** of Berlin addressed the Freeholders on behalf of Greg DePaul who had to leave. Mr. McCann said I think Greg's question had to do with the status of the proposed use of the property on Pump Branch Road. He said I think it was more of a concern about a County fairground. The Deputy Director said Jack Sworaski who is the head of our Open Space Program is here. Mr. McCann said I spoke with Jack. Mr. McCann said I am the former Director of Hudson County and I served there for years and I retired here. He said I spoke with Green Acres people and they said there would have to be several public hearings. He said Jack was very helpful and we appreciate that they recognized this was not the best site for a County Fairground. He said basically it abuts everybody's house - the rodeo area with a speaker system would have been right behind Greg's house. He said the access road would have hugged everybody's property. Mr. McCann said I have attended these meetings for 31 years as a representative just as Jack does. Thank you very much for relocating this event.

**Danielle Gioffre** of Hammonton addressed the Freeholders and said I am a Girl Scout, Troop 30910, and I am trying to earn my Girl Scout Silver Award which is the highest award a girl scout at my level can earn. She said she is running a soccer camp for Children of Special Needs and it is starting this week from Monday to Saturday and we have been trying to have people come as players for a month or two but we only have three people as of now. She said I am just trying to get the word out. The Deputy Director asked for the ages of children who can play. She said from Kindergarten to 7<sup>th</sup> Grade. The Deputy Director said in Camden County we have a lot of programs for special needs kids and adults and Sandi Kelly who oversees the whole project is here. We have a lot of contacts with families of disabled children. The Deputy Director asked for her contact information and we will make sure Karen Widener gives you a call and see if she can do an email blast for you. Danielle said we have been trying to get in touch with different organizations. She said the project has to be done before she is a 9<sup>th</sup> Grader. Danielle said we don't need a specific amount of kids we just need enough to have a game. She said usually you need 11 players. Sandi Kelly will try to help Danielle and get her in touch with Karen. Sandi is going to meet with Danielle.

**Bernice Hile** of Elm Town addressed the Freeholders. Ms. Hile said she was born and raised in Atlantic County. She was an Atlantic County Committeewoman for 17 years. She said her

grandparents built Sweetwater Casino. She said they gave me 10 acres of land and I lived there for 45 years. She said my house burned down in 2008. She said I was involved with the Senior freeze because I was of that age and I got it. She said I moved to Elm Town - the zip code was 08037 which is confusing because Hammonton has the same zip code. She said I thought I was moving into Atlantic County but I really moved into Camden County. She said so I applied for the freeze over 3 years ago and it is five years now and I am afraid I am going to lose my house. She said I am on a very fixed income and this is a beautiful place to live the houses are very nice and I like it there. She said I am wondering when did that freeze change because I did have it when I was in Sweetwater - does anyone know? The Deputy Director said that is a State question. The Deputy Director said Marge DellaVecchia is our Deputy County Administrator who spent a lot of time working in the State - she knows a lot of folks maybe she can help you.

Ms. Hile said Elm Town is run by trustees. Since we are Winslow Township, the trustees are elected by the residents and rules are made by those trustees. She said it is a private organization and she was told when she was involved in politics in Atlantic County that senior citizen complexes - if you have a certain amount of homes that are vacant (13%) - where people die or move in Elm Town, I think we have over 13% homes vacant. She said I have a daughter that is 53 years old. She said I was told that she can't move in there but a lawyer and some Atlantic County people told me that if there is a certain percentage of vacant homes in a senior citizen community that if people are close to retirement age, they may be accepted. She said isn't there a way that we can go over the trustees - from the County. Is there any kind of law on the books? The Deputy Director said the County government can't do that - again it is a private entity but since they are receiving some federal money, I think there are rules. Ms. DellaVecchia interjected and said the Department of Community Affairs handles that. The Deputy Director said Marge will steer you in the right direction.

**Shirley Corsey** of Sicklerville addressed the Board. Ms. Corsey said I am a small business owner. My School is Healthcare IT School of New Jersey. She said we are approved by Workforce New Jersey and that allows people to go to all of the County One Stop or unemployment centers - they are eligible for training grants. She said my question is with all the Casinos closing in Atlantic City, even though we are Camden County, it does affect a lot of people from our County who are working there and they are estimating over 5,000 people. The first question is do we know how many Camden County people are affected by these layoffs? The Deputy Director responded and said about 400 live in Camden County and Kathy Mayfield from the One Stop and Frank Filipek and I had a meeting and I asked do you have those \$4,000.00 Grants and they do and would these Casino workers be eligible and they will. He said they go down before the people are actually laid off (Rapid Response Team) and they discuss what programs are available. He said the answer is there is going to be an aggressive push by those folks and Kathy and Frank are all over it. Ms. Corsey said my question is since I am a Camden County resident and a County small business owner - I am connected with One Stop but are we in the community going to do outreach. She said a lot of the things you mentioned come from the state down and what I am proposing are ways that we can really reach people and what I want to know as a small business owner, how can I be even more effective in letting people from our community here in Winslow Township - I have a school it is on line - it is not far away - it is convenient - I just want to have an opportunity to be a part of all the eligible providers specifically with our Camden County residents. So they know there is an eligible school, that they know what they need to do - how can we outreach. She said they give healthcare and IT training - it is a specific area that a lot of people are not aware of. The

reason why I want to bring this here is like the Casino industry is regulated so is the healthcare IT. She said this is not Allied Health - what I do is support. It is not just medical billing coding - our IT is electronic medical records, the front desk clerk. She said your response is exactly why I want an opportunity to have some community outreach to show people in the community - all people in our community about what this is - demand jobs with hospitals and clinics - just like the Casino industry is regulated so is the healthcare industry. A lot of the people being laid off have transferable skills and the background will fit in nicely with jobs they can be hired by Cooper, Urgent Care Centers. The Deputy Director said there is going to be a meeting in the second week of September that they are putting together which will feature - not a public meeting but will start as a small meeting which will be the CEO's of Cooper and Virtua, Inspira, Kennedy. He said they are going to sit around and talk about these workers and talk to these CEO's and say what is in demand jobs that you really need. After that is done, then there will be a whole outreach with One Stop with Kathy and Frank. The Deputy Director said the only thing I can suggest you do is keep staying with and talking with them. They are going to have information sessions for these laid off workers. She interrupted and said they are in Camden City. The Deputy Director said, no, this is Camden County - the whole County. Ms. Corsey said so they are going to locate all Camden County. The Deputy Director said the plan is they will have information sessions throughout the County. Displaced workers will be invited to the meetings and at that time Kathy and Frank will tell them what they have to do. He told her to keep in touch with Kathy and the One Stop.

Freeholder McCray interjected and said I work in the healthcare field. He said you have a contract with Camden County.

She said yes but just because we are listed, doesn't mean we are marketed. She had brochures.

**John Howell** of Sicklerville addressed the Board. He said I go to the One Stop in Camden and they have a great training facility. They have the people already there. He said we need facilities here in Winslow. He said there is a school for the special needs children down the street. We turned into the Superintendent's office to use as office space. He said these classrooms still exist - the whole building is not being used. We can work together. Ms. Corsey interjected and said we need training right here. Mr. Howell said a lot of the African American children who graduated and are between the ages of 18 to 30 never had a job since they left high school. They need to update and write resumes and be trained for a job. He said my nephew and son until recently didn't have a job for three years after they left high school. Mr. Howell said what I am saying is we have facilities right here in Winslow - if we can bring the training people here, we can work together. He said we have a facility that has the classrooms already. He said everyone here who went to school knows where the High School is - it is something where we can work together as a township and a county and help each other at the same time. The Deputy Director said the bottom line is the money for the training is from the One Stop. He said the training happens in different areas. Ms. Corsey knows it is held at the College but not everyone can get to the College. She said this is practical education. Mr. Howell said we do have facilities. Ms. Corsey said I am the contact provider but how do we reach people here in Winslow. The Deputy Director said the Freeholder Board would help to provide training information to residents. Mr. Howell said the County already has people who do this - we have a facility if they are willing to come and use our facilities. He said we have it right here - everything is here. Mr. Angilella asked Mr. Howell to give his contact information and someone will contact him about training. Ms. Corsey said I am talking about community outreach bringing it to our people.

**Mr. Givoni** identified himself as a School Board Member. He said I have nothing to do with this training program but regarding the building which this gentleman is talking about - that building was vacant so Winslow Township as well as the school system asked for the building and got it - one of our State Senator's helped us get that building. Previously, administration was in that building which was the Middle School so they started using that building. At the present time, there are no classrooms there, it is an administration building. I wanted to clear that up.

Mr. Givoni said I have a question with regard to the intersection of Cross Keys Road and Sicklerville Road. When you are going from Sicklerville Road to Cross Keys Road you can make a left turn on left arrow but coming from Gloucester Township of Sicklerville Road, if someone wants to make a right turn, - no turn on red, but the sign is so far back that no one remembers that there is not a right turn on red. People are making a right turn and I don't blame them because the board is too far back. Is it possible to put a board in the center where someone is going to make a turn and saying no turn on red so people understand what they are supposed to do.

The Deputy Director called upon Sam Martello, Director of Public Works to answer. Mr. Martello said that is actually the Department of Transportation but we will contact them to see if this can be done.

The next question is regarding the Pennsauken Mart. He said they used to pay taxes and it has been many years when the County took over that land and they said a friend of ours wants to bring in an Ice Hockey team. He said I have not seen an Ice Hockey Team there - all I see are weeds growing on the property. I don't know if anyone is collecting any taxes on that property anymore and I don't know how much taxes have been lost in the process. The Deputy Director said that is a Pennsauken Township issue - the Freeholder Board does not own that - Pennsauken does and they are trying very hard, along with the County to try to redevelop it. That is in the process. Mr. Givoni said why did they destroy it and not pay taxes? The Deputy Director said he was not aware of that.

**Allen Osborne** of Winslow Township addressed the Freeholders and said my question concerns the DOT and the intersection of Berlin Cross Keys Road. He said the left turn signal when you are turning on to Rt. 30 - I would like to recommend that the turn signal be extended. He said only 3 or 4 cars can get through. He said that turn is long and sharp. The Public Works Director Sam Martello responded and said again it is a DOT issue but we will contact them about the timing.

Seeing no one, the Deputy Director asked for a motion to close the public hearing. Freeholder Gentek made a motion to close the public hearing with a second by Freeholder Rodriguez and all Freeholders present voted aye.

The Deputy Director said I will now open the floor to the Freeholders for their comments.

**Freeholder Rodriguez** said it is nice to be in Winslow. She said it is very peaceful and a friendly environment - nice people here. She thanked the Mayor and Council and acknowledged Mayor Barry Wright who is a strong advocate for the community! She thanked the residents for all their comments and suggestions. She said great ideas came forth tonight and that is what this is all about. Thank you for participating. The Freeholder thanked Freeholder Gentek for a dare. She said for those of you who want to hang out after the meeting, there are a couple of Freeholders who are going to be taking a shower! Freeholder Gentek is orchestrating this. She said I am extremely honored to do this

because for those of you who know about Lou Gehrig's disease, it is an unbelievable devastating disease and what is most tragic with the history ALS has been known for such a long time - a cure has not increased much. It is very honoring for me to be able to take this challenge and to help contribute to the cause - perhaps improving the medical efforts and research that goes into finding a cure or at least better treatment. She said I am excited in doing this and asked everyone to stay and watch us get drenched!

**Freeholder Gentek** thanked the Freeholders for being a good sport. She said I did mine the other night and it is "cold". It is for such a great cause and I thank all of you for participating.

She referred to a gentleman whose mother has it and she has no mobility at all and he was just diagnosed with it. It is really sad. On a brighter note, we are having a County fair on September 27 and 28 at the Lakeland Complex in Gloucester Township. She said the details are on the County Website. It will be a lot of fun. She said we are bringing about the old time country fair, an apple pie contest and also will have a parade. Thank you all for coming out this evening.

**Freeholder McCray** thanked everyone for coming this evening. He thanked Mayor Wright and said he is a great guy. He said we actually got started together - we had a lot of good times on the campaign trail with him. Winslow is a great town and a lot of good things are happening. He wished everyone a safe summer and a great Labor Day weekend.

**Deputy Director McDonnell** thanked everyone in Winslow Township for hosting the meeting. He thanked everyone for staying for the whole meeting - we are glad you were here and appreciate your comments. The Deputy Director thanked all the employees of Camden County who do a great job every day for the residents of Camden County.

The Deputy Director asked for a motion to adjourn. Freeholder Gentek made a motion to adjourn with a second by Freeholder Rodriguez and all Freeholders present voted aye. The meeting was adjourned at 8:30 p.m.
