The meeting was called to order by Director Cappelli at 7:00 p.m.

The Clerk called the roll and the following Freeholders answered:

The Director stated that adequate notice of this meeting has been provided in accordance with the Open Public Meetings Act.

The Director asked everyone to rise for the Pledge of Allegiance which was led by Ms. Concetta Sherlock and the National Anthem which was sung by Michael Parisi.

The Director thanked everyone and asked for a round of applause.

Director Cappelli said the County has large print agendas available from the Clerk for the visually impaired.

The Director welcomed everyone to the meeting of the Camden County Board of Freeholders and said we are very pleased to be in Berlin Township. It is the practice of the Board of Freeholders to hold the meetings each month in one of the municipalities outside of the County Seat of Camden so that all members of the public will have full access to the meetings of the Board.

PRESENTATION

The Director asked Letti-Jane White from the Wesley United Methodist Church to come forward. The Director said each month the Board asks the governing body of the town for the name of a non-profit in the town worthy of recognition and a small donation from the Board of Freeholders. The governing body of Berlin Township chose Wesley United Methodist Church. Wesley United Methodist Church (UMC) has proudly called Berlin Township home for over 118 years. Wesley UMC is a pillar in the community and assists the Township of Berlin in various ways. For the past 20 years, Wesley UMC, under the leadership of Pastor June K. Stitzinger-Clark, has hosted the National Night of Prayer for Berlin Township and surrounding communities. Wesley UMC has been called upon in the wake of national and local tragedies to conduct prayer vigils that have helped heal and unify the community. Long before the incorporation of the Township of Berlin, the church has participated in local civic events and historical functions. Pastor June has been serving Wesley UMC in Berlin Township and Centenary UMC in Berlin Borough for the past 20 years. Pastor June is a veteran of the United States Army and the National

Guard. She uses her degree in Social Work for good of the community. Pastor June will retire at the end of June. Ms. Letti-Jane White accepted the donation in Pastor June's absence.

COMMUNITY AWARD

Freeholder Moen said this month's Community Award goes to Reverend Samuel D. Sykes. Reverend Samuel Sykes has deep roots in the East Berlin area. He and his wife came to Berlin, several decades ago, and are still there today. Sam fulfilled a 30-year career in Law Enforcement before he became a Pastor. He retired from the Camden County Prosecutor's Office as Sergeant of Investigations. After retirement, Reverend Sykes began to minister and is now the Associate Minister of Green Grove Baptist Church in Berlin Township. Reverend Sykes is dedicated to serving his community. He is on the Berlin Township Planning & Zoning Board, Berlin Township Police Chief Review Committee, Berlin Township County Committee and Berlin Township Recreation Committee. He is also committed to the youth. Reverend Sykes strives every day to show them the importance of education, avoiding negative peer pressure and taking responsibility for their actions.

Reverend Sykes said he was honored for receive this award. He has been the pastor of Green Grove Baptist Church for 23 years. During the time the church has experienced exceptional growth, both spiritually and numerically. When he first arrived at the Church, the active membership was about 40 people with basically no ministries functioning and a very low income. They now have an active and thriving membership with numerous functioning ministries. The Pastor said he is an ardent supporter of families working together in building and promoting family prayer, family dinners and quality family time together.

YOUNG COMMUNITY LEADER

Freeholder Young asked Shane D. Jackson to come forward. Shane Jackson is a 20 years old resident of Camden County. He is currently attending William Paterson University where he is in his junior year studying Sports Management. Shane is also very active in the Psychology Club and the Young Men's Social Awareness Group. Shane is deeply driven by his faith and is a longtime member of Green Grove Baptist Church located in West Berlin. He was an active member in ministries such as the Youth Ministry, Youth Choir and Ushers Ministry. He also participated in several of the church's Dr. Martin Luther King Day of Service events. Shane was honored by the Mayor of Berlin Twp. for his participation in cleaning and restoring one of the Town's parks. Shane was also active in the Winslow Township Maullers Football Association and the Winslow Basketball Association. As team captain, he led the basketball team to the Championship. Freeholder Young said the Camden County Board of Chosen Freeholders is proud the present Shane Jackson with this month's Young Community Leader award.

SUSTAINABILITY AWARD

Freeholder Young asked Ilya Giryla and Yan Girlya, Co-Presidents of Diggerland, to come forward. This month's Sustainability Champion is a local family owned and operated business focused on family fun and adventure in an outdoor environment that promotes sustainability and

good clean fun, with dirt. Diggerland USA is the only construction themed adventure park in North America where children and families can drive, ride and operate actual machinery. The park covers about 14 acres in West Berlin, NJ and has over 25 attractions - the majority of which are real, diesel- powered, full-size, pieces of construction equipment. Each machine is safe for the public and the environment -the engines use the highest grade eco-friendly diesel fuel. Diggerland USA operates all machinery with Tier 4 technology which meets the highest level of EPA emission rules enacted in 2004. The Tier 4 standards require that emissions of Particulate Matter and Nitrogen Oxides be further reduced by about 90%. Such emission reductions can be achieved through the use of control technologies including advanced exhaust gas after treatment. Freeholder Young said we are proud to recognize Diggerland USA and the Girlya Family as our Camden County Sustainability Champion for the month of May.

PROCLAMATION

Freeholder Young asked Mayor Phyllis Jeffries-Magazzu to come forward. Phyllis Jeffries-Magazzu has lived in Berlin Township all of her life and currently serves as the town's Mayor. She has dedicated over 30 years to the community, serving as the Mayor and Council President of Berlin Township. She has also been a member of the Township Planning Board, Zoning Board, Recreation Committee, PEACE (PTA), Overbrook High School Music and Band Association, Berlin Township Emergency Management Committee and Municipal Chairwoman of the Berlin Township Committee.

Mayor Magazzu is the immediate Past President, as well as Executive Board Member, of the Camden County Mayor's Association. She has been of service to the Legislative and Resolution Committees as part of the League of Municipality. Most recently Mayor Magazzu has been active with the New Jersey Conference of Mayors and just completed a year of exemplary service as their President. Upon turning over the gavel as President of the Mayor's Association, Mayor Magazzu received two awards from her colleagues – The Mayor of the Year Award for 2016-2017 and the Law Enforcement Against Drugs (L.E.A.D.) Award.

Mayor Magazzu's other titles, wife and mother, provide her life with the strongest sense of fulfillment and unconditional love. Mayor Magazzu and her husband, Frank, have raised 8 children and served as foster parents to over 90 children.

Mayor Magazzu thanked the Freeholder Board for their acknowledgment. She said she is both proud and grateful for the wonderful working relationship Berlin Township has with the County of Camden.

PROCLAMATION

Director Cappelli introduced Andrew Pierson, Director of Instruction at the Camden County Golf Academy. Andrew has played an integral role in the implementation of the Camden County Addiction Awareness Task Force's (AATF) Recovery Encouragement Athletic League (R.E.A.L.) golf lessons. In 2017 the Board of Freeholders and the AATF launched a pilot program to provide golf lessons to individuals in recovery. Andrew worked countless hours providing leadership, instruction and support to the program. The following year, the program became so successful that the AATF announced an official golf program under the R.E.A.L. initiative.

Andrew is a graduate of Rutgers University – Camden, a PGA Apprentice and currently served as the Assistant Golf Coach for Rutgers golf team. Andrew helped lead the Rutgers golf team to three consecutive NCAA Finals Appearances.

Andrew thanked the Freeholders for the honor. He commented that working with R.E.A.L. has been truly inspirational.

PROCLAMATION

Freeholder Nash introduced Fitzroy Campbell. Fitzroy is a resident of Sicklerville and son of Jamaican immigrants. He recently graduated with honors from Rutgers University. Fitzroy obtained a bachelor's degree in Philosophy and French with a minor in marketing. By achieving a college degree, he has fulfilled the dream of many who have come before him.

Fitzroy plans to continue his education with the next step being law school. He looks forward to representing other immigrants and intends to give back to the community. He aspires to be a prosecutor, specializing in hate crimes or an immigration lawyer, similar to those who have worked pro bono to represent clients in the wake of the Trump administration's travel ban on immigrants from predominantly Muslin counties. Fitzroy has become focused on serving others and has volunteered with several organizations in the Camden community. He recently served as a tax preparer for the nonprofit organization PathWays VITA.

Fitzroy thanked the Freeholders and his family, many of whom were in the audience. He credits his Rutgers-Camden educations for giving him the opportunity to learn and grow as a student and as a person.

PROCLAMATION

Director Cappelli asked Shirley Conroy, S.J. Volunteer Coordinator for Moms demand Action for Gun Sense in America. June 2nd of each year is designated as "National Gun Violence Awareness Day" in the United States. The day is one of honor and remembrance of all victims and survivors of gun violence as well as a day of declaration as it brings attention to the issue and realization that we as a Country must do more to reduce gun violence.

Every day, 93 Americans are killed by gun violence. Over the last 5 years, more than 200 have sustained non-fatal firearm injuries. Americans are 25 times more likely to be killed with guns than people in other developed countries. Protecting the safety of residents is the highest responsibility of the Camden County Board of Freeholders. On June 2nd, many will join the Wear Orange Campaign to help raise awareness about gun violence by wearing orange and honoring the lives lost and human potential of Americans stolen by gun violence. The Board of Freeholders of the County of Camden declare June 2, 2017, National Gun Violence Awareness Day.

Ms. Conroy stated that much like Mothers Against Drunk Driving was created to reduce drunk driving, Moms Demand Action for Gun Sense in America was created to advocate for stronger laws and policies that will reduce gun violence and save lives. They are a non-partisan grassroots movement of American mothers demanding common-sense solutions to address our country's dangerous culture of gun violence, which jeopardizes the safety of our children and families. She further commented that America is in a state of crisis and that this violence affects

everyone, everywhere – from big cities to small towns to rural communities – and as mothers, they can no longer wait for politics to catch up to the policies we need. They support the Second Amendment while doing so much more to keep guns out of the hands of dangerous people and make our communities safer. Ms. Conroy said Mothers Demand Action for Gun Sense advocate for the following goals: (1) closing deadly loopholes in our background check system that allow minors and dangerous people like felons and domestic abusers easy access to guns; (2) promoting gun safety so that America's children will no longer be exposed to unacceptable levels of risk; (3) supporting reasonable limits on where, when and how loaded guns are carried and used in public; and (4) creating enforceable laws that address gun trafficking and fraudulent purchasing to keep illegal guns off our streets.

PROCLAMATION

Director Cappelli asked the members of the Camden County Technical School – Gloucester Township Culinary Arts Program to step forward. On May 12, 2017, students and teachers from Camden County Technical School – Gloucester Township Campus' Culinary Arts Program participated in the 6th Annual County Vocational – Technical School Cook-Off Challenge in Atlantic City. The Competition, sponsored by the New Jersey Association of Counties (NJAC), invited culinary arts students from county vocational-technical schools across the State to show off their culinary skills. The schools were selected to compete for titles in taste, creativity, and food presentation. Each team, which consisted of 5-6 students and 2 staff members, created 400 samples of appetizers at a total cost of less than \$500.00. Atlantic City chefs, County officials and guests judged the highly competitive competition. Camden County Technical School's submission of braised short rib taco with Mexican street corn salsa, pickled onions, fresh cilantro, topped with an avocado cream won gold medals in both the Taste and People's Choice categories. Even greater yet, the Camden County Technical Schools – Gloucester Township campus was named Grand Champions of the competition.

Director Cappelli stated the meeting was now open to any member of the public who wishes to address the Board of Freeholders. The Director now declared the hearing open

Amy Lackpour of Haddonfield said she is here once again regarding the natural gas pipeline that is going to run through the Pine Barrens. Our elected official to the Pinelands Commission, Mr. Ed McGlinchey, in February 2017, voted yes to approve a 22-mile-long natural gas pipeline that is going to go through the Pine Barrens, a federally protected reserve. Mr. Edward McGlinchey does not represent the views of herself as a County resident and does not represent the views of Camden County. She feels he is unfit to serve on the Pinelands Commission. By voting yes on this issue he put private interest ahead of a public resource. She is disappointed in his vote. Ms. Lackpour asked the Freeholders what the process is by which a Pinelands Commissioner is elected and how nominations are made. The Director said Mr. McGlinchey is the Camden County representative of the Pinelands Commission. He was selected by the Board. Ms. Lackpour wanted to know how nominations are made to the Board for Pinelands Commissioners. The Director said they would accept the resume of anyone who expresses an interest and give them consideration. The Board then votes. The Board will vote again in November or December of 2017. The Director said anyone who is interested in the position can begin submitting resumes between now and November 2017.

Kevin McFadden of Brooklawn, New Jersey is a caterer and asked the Freeholders for a list of recently approved Camden County caterers. Kristen Cass, manager of the Camden County Boathouse stated that she would gladly provide the list to him.

Gilbert Shaw of Blue Anchor said he is here tonight to request that the Freeholders consider naming the new One Stop facility after long-time director Frank Shaw. The Director said he would pass Mr. Shaw's recommendation along to the committee.

Glenn Fontane of Berlin asked the Board for a new traffic light at Hearthstone Drive and Route 73 North in Berlin. He said this is a very dangerous intersection. Kevin Becica, County Engineer agreed to speak with Mr. Fontane after the meeting.

Director Cappelli made a motion to close the public hearing. Freeholder Shin Angulo made a motion with a second by Freeholder Moen and all Freeholders voted aye.

The Director said he will now open the floor to the members of the Board of Freeholders for their comments.

Freeholder Nash said he would like to congratulate County Administration and the Freeholders who were involved in preparing the 2017 budget. He said once again it is very difficult to balance the enormous needs of the residents with the further need to keep a lid on our tax rate. He thanked the Mayor and Council for hosting the meeting as well as the residents for coming out to express their concerns.

Freeholder Young said he would like to thank Mayor and council for hosting them and said it's always good to be back home. He said he would also like to congratulate the Board and County personnel on doing a great job on the budget.

Freeholder Shin-Angulo said she would like to thank the Mayor and Council members for being here tonight and hosting them, she said she knows it is a lot of work and the Constituent Services staff work very hard to set everything up. She said just to let everyone know there are a lot of road improvements going on throughout this county, so give yourself a little bit of extra time. She thanked everyone again.

Freeholder Moen thanked the Mayor and Council and congratulated the Mayor on her recent recognition as Mayor of the Year. He would like to echo Freeholder Nash's sentiments on the County Administrations work on this year's budget. He would also like to thank the families in the audience and in the County who are celebrating college graduates that are walking across the stage this month. He said lastly June 6th is the primary election, please go out and vote.

Director Cappelli would like to thank Mayor Magazzu for having us along with the council members. He would also like to thank Ross Angilella and David McPeak for the great work on the budget. He said he would like to thank all of the employees of Camden County that work so hard every day for the citizens of Camden County. He thanked everyone for attending.

The Director asked for a motion to adjourn. Freeholder Young made a motion with a second by Freeholder Shin Angulo and all Freeholders voted aye.
