> Archives – An update was given on the progress of the relocation of 5,000 tax list books. Phase 2 is underway and should be completed in a few weeks. The final phase (Phase 3) is projected for completion in early 2022.

> **OPRA** – Staff is working with the Archive Management Department learning the RIM system which is used to catalog archive records.

Audits – Exemption audit is on-going. The abatement audit will begin in early 2022. Bi-annual Report – The reports were distributed to county and local officials
