# CAMDEN COUNTY BOARD OF FREEHOLDERS FREEHOLDER MEETING FEBRUARY 15, 2018

Harry Williams Building Broadway & Black Horse Pike Runnemede, New Jersey 08078

The meeting was called to order by Director Cappelli at 7:00 p.m.

The Clerk called the roll and the following Freeholders answered:

PRESENT: SHIN ANGULO, MOEN, NASH, RODRIGUEZ, YOUNG, McDONNELL, CAPPELLI

The Director stated that adequate notice of this meeting has been provided in accordance with the Open Public Meetings Act.

The Director asked everyone to rise for the Pledge of Allegiance which was led by Runnemede VFW and Boy Scout Troop #117. The National Anthem was sung by Serena Garcia from Triton Regional High School.

The Director thanked everyone and asked for a round of applause.

Director Cappelli said the County has large print agendas available from the Clerk for the visually impaired.

The Director welcomed everyone to the meeting of the Camden County Board of Freeholders and said we are very pleased to be in Runnemede. It is the practice of the Board of Freeholders to hold their meeting each month in one of the municipalities outside the County seat of Camden so all members of the public have full access to the meetings of the Board. He said as is our custom, we will begin tonight's meeting with a presentation to the governing body. The Director asked Mayor Kappatos and members of the governing body to come forward, along with Freeholder Rodriguez.

The Director said the Freeholders are very proud to call the governing body of Runnemede our partners in government. There has been a long tradition in this town of great government and outstanding leadership and very dedicated public servants. This Mayor and Council have continued that tradition. Director Cappelli said we work closely with Runnemede on economic development, public safety and infrastructure. Mayor Kappatos introduced his governing body.

Freeholder Rodriguez presented the Mayor with a check for CDGB funds in the amount of \$33,500 which has been designated for infrastructure improvements. Mayor Kappatos thanked the Freeholders for their generous gift.

# **PRESENTATION**

Director Cappelli asked Ms. Lee Mikulski to come forward. He said, as we go from town to town and have our meetings, we ask the governing body for the name of a non-profit worthy of a small donation in recognition from the Board of Freeholders. The governing body of Runnemede, has chosen the Runnemede Seniors Club. The Runnemede Seniors Club was formed in 1970 and was intended to bring men and women age 65 and up together for sociability, entertainment and general welfare. The Club was exclusively for residents and former residents of the Runnemede area. The Club has since moved and is now adjacent to the Harry Williams Community Center. In addition, the age limit has been lowered to include individuals 55 and up and the residency requirements have expanded. This group provides many activities for seniors in Runnemede and serves the community very well. Ms. Mikulski thanked the Freeholder Board for its gift.

# **COMMUNITY AWARD**

Freeholder Moen said he has the honor of presenting the Community Award which is an award which is recommended by our local Mayor and Council for an organization or individual that they believe is deserving of County recognition. He said this month's award goes to New Beginnings, and asked President Lisa Segrest and members of the Club to come forward. New Beginnings is a non-profit organization formed by volunteers who saw the need for a 12-step recovery club house, which began operating in Runnemede on December 15, 2010. New Beginnings began with only a few nightly meetings and now has over 20 weekly meetings to help with all forms of recovery. New Beginnings' mission and values go far beyond helping individuals. The organization also supports the community in any way it can. The facility maintains a safe and non-discriminatory environment to all with its primary goal being to help those suffering from addiction to achieve long-term sobriety. New Beginnings serves Runnemede and the surrounding communities. This organization has an essential role in a time when the epidemic of addiction directly impacts the community.

Lisa Segrest thanked the Freeholder Board and the Borough of Runnemede for its support in helping keep their doors open.

# YOUNG COMMUNITY LEADER

Freeholder Young said that as we travel throughout the County from month to month, we like to acknowledge our youth and say thank you for doing a good job. He asked Alex McCafferty to step forward. Alex is an 8th grade student at St. Teresa Regional Catholic School. He is very involved in the community and is a Son of a Legion for American Legion Post 281. Alex participates in the flag burning ceremony and has participated in the Legion's parade. Alex has donated and delivered books to the Runsen Senior House and has spent time talking with Runsen residents about their "College Dorm". Alex participates in the Cozies for Chemo event every year on the Martin Luther King Day of service. He participated in a service project making peanut butter and jelly sandwiches for the homeless. Although he is too young to volunteer at Cathedral Kitchen, he helps make the utensil packets. His family is very proud of the many service projects Alex is involved in throughout the community

## **SUSTAINABILITY AWARD**

Freeholder Young said it's important for us to change the carbon footprint of our County. Each month we celebrate a "sustainable champ". This month we celebrate Mary Jo Ranieri. Mary Jo is a graduate of Triton Regional High School and a member of the Runnemede Green Team who has always been committed to sustainability. She had a bicycle accident about two years ago and sustained serious brain injury, but wearing a helmet saved her life! Because of her love for animals, she and her family are vegetarians and animal activists. She also advocates for monarch butterflies by planting milkweed, which monarchs need to survive. Along with her husband John, she developed a natural weed killer. Compared to Roundup, their weed killer is safer for the environment, pets, and children. A solar energy user herself, Mary Jo promotes the benefits of solar energy with her husband who has reached out solar energy companies to save money for the residents of Runnemede. She and her family continue to educate others on green living and sustainability and look forward to a brighter, healthier future. Freeholder Young said we are proud to recognize Mary Jo Ranieri as our Camden County Sustainability Champion for the month of February.

# **PROCLAMATION**

Freeholder Young asked Vicki Rowland, Executive Director of the Camden County Animal Shelter to come forward. The Board of Freeholders is proud to recognize the Camden County Animal Shelter for their incredible commitment and dedication to saving animal lives. The Shelter reached a 91% save rate in 2017, the highest in the shelter's 20-year history. The Camden County Animal Shelter is the only open admission animal shelter in the region to achieve the rating. In 2009, the Shelter's save rate was only 46 percent for cats and 73 percent for dogs. Camden County Animal Shelter partners with national animal welfare agencies to learn best practices and lifesaving programs. 1,540 animals were transferred out to other rescue agencies last year. In 2017, there was an increase of 37% or 417 more lives saved. In addition, their foster care program and dedicated volunteers increase care capacity to save more lives. The Shelter has built relationships with organizations and rescues focused on Trap-Neuter-Return (TNR) programs. These relationships have resulted in fewer kittens being born and a reduction in the cat population. Freeholder Young said the Camden County Board of Chosen Freeholders is proud to recognize Vicki Rowland, Executive Director, and the staff and volunteers of the Camden County Animal Shelter for their tireless commitment to saving animal lives.

# **PROCLAMATION**

Director Cappelli asked Freeholder Young, Lt. Jannell Simpson, Sgt. Tracy Seigel, Officer David Hinton, Dispatcher Tondaleya Bagby, and Retired Lt. Scott Bagby to come forward. On Monday, January 22nd Dispatcher Tondaleya Bagby of the Camden County Communications Center received a call from a distraught mother of four (4). The mother called 911 because she had no telephone and was unable to call any number other than 911 on her cell phone. She was distraught because her children were in extreme need of food. Dispatcher Bagby requested that an officer go check on the family. Officer David Hinton went to the apartment and found there was no food for the children. He went to a local take-out restaurant and purchased a variety of items for the family. Dispatcher Bagby shared the troubling situation with her mother, Sergeant Seigel. The two, along with retired Lieutenant Scott Bagby and Lieutenant Janell Simpson, purchased ten (10) bags of groceries for the family. Dispatcher Bagby and her mother delivered the groceries to the family that same night. The family was surprised and full of gratitude for the

act of kindness. Director Cappelli said this is a great example of the Metro Police in Camden being an ambassador of peace and hope in the City – this is how they forge great relationships with the residents of the City. The residents see them as partners, as those who will help the residents in times of need. The actions of Dispatcher Bagby and all of the member of the Police Department here tonight went a long way with building trust in the community not to mention the help for that mother and her four (4) children. Director Cappelli thanked each member of the team for their great service and generosity and, speaking on behalf of the entire Freeholder Board, said we cannot be prouder of the work you do each and every day.

Captain Verticelli said Lt. Simpson reports to him on a daily basis. He is in charge of investigations in Camden City and she is one of the Lieutenants. He said they were having a casual conversation and she told him this story and what they did. Being humble, it wasn't anything out of the ordinary for her. Captain Verticelli said our creed at the police department is Service Before Self. The dispatcher and those officers were upholding this creed.

Dispatcher Bagby thanked everyone for their acknowledgement and appreciation.

# **PROCLAMATION**

The Director asked Mayor Redd to join him. Director Cappelli said a little over eight (8) years over, Dana Redd was elected the Mayor of the City of Camden, our County seat. At that time, Camden had some of the highest crime rates in the nation, the highest poverty rate in the nation, and one of the most distressed and failing school districts in the nation. Dana was so dedicated to her city that she ran for Mayor, she was elected, and the story over the past eight (8) years is a story that will actually make history and be a case study on how to revive a failing city in the United States. Today the crime rate in Camden is the lowest it has been in over thirty (30) years. There is \$2 billion of private investment taking place in Camden City. That investment will result in somewhere between 7,000 to 10,000 new jobs in Camden City over the next ten (10) years. As the crime rate has decreased in Camden City, the crime rate has decreased in Camden County. Of the jobs that will be created, many will be filled by Camden City residents and many will be filled by residents who live in the suburbs. Over the past year, the school system has had the highest graduation rate and test scores in a decade. Over the past years, Dana has not been one to take a lot of credit for all of this. She does not like the limelight. She is a very humble person. She decided not to run for re-election this year. She served eight (8) tremendous years and the Board of Freeholders felt that her accomplishments were so extraordinary, not just for the residents of Camden City, but also for our County and the region, that today we declare this day The Honorable Mayor Dana Redd Day here in Camden County.

Mayor Redd thanked Freeholder Director Cappelli and the entire Board of Chosen Freeholders for this distinct honor. She said tonight she accepts this award in the memory of a mentor and a special mother and friend to all of us who passed in December of last year, The Honorable Freeholder Riletta L. Cream. Mayor Redd said tonight is very special to her because as she thinks about her journey in life, she is grateful because we have had so many wonderful partners who have helped us to lift and propel Camden forward and the Freeholder Board has been a strong partner in the progression of Camden's new narrative around public safety, education and economic development. She said she wanted to publicly thank her friend, a gentleman who has had her back during the difficult times and the good times. He has been a good counselor, someone who listens to her when she has had various challenges. Lou Cappelli, she said, you will never know how much your friendship has meant to me during these past eight (8) years.

The Mayor said from 1994 to 2008 she served as a Freeholder Aide with a cohort that really was remarkable. The Board of Chosen Freeholders propel leaders forward. Her cohort consisted of Holly Cass, Frank Filipek, Jr. and Dominic Vesper. Camden County grooms leaders to lead and to change the environment in which we live because we believe that we need to give back because we have been so blessed. She thanked Ross Angilella, who also mentored her during those years of working for Camden County. She said she took those skill sets to her position as State Senator, as City Councilwoman, and then as Mayor and she is truly honored for this declaration.

# PROCLAMATION / EMPLOYEES OF THE MONTH

Freeholder Shin Angulo asked Albert Busan and Kevin Lish to step forward. Albert and Kevin are truck drivers for the Department of Public Works. On January 31st, Al and Kevin did something quite remarkable. It was around 6:20 p.m. when they were out on an emergency pothole call. The Gibbsboro Police reported a large pothole on County Route 561 (Haddonfield-Berlin Road). Al and Kevin headed down Egg Harbor Road to the site of the pothole and soon smelled gas in the air. They realized that the odor was coming from a compressed natural gas company on the road. They went to the site and hearing the gas being released began to investigate the matter. The gas was escaping from one of the company's trucks. They called Lindenwold Fire Company for assistance. When the fire company arrived, they were also alarmed. They had no way of contacting anyone in charge of the plant to determine the proper course of action. Al noticed an emergency stop button on the wall of the building and brought it to the attention of the firemen. **Freeholder Rodriguez** thanked the Mayor and Council for the wonderful reception. She went on to say that February is Career and Technical Education Month. Camden County has one of the best programs in the entire State. She acknowledged Superintendent Pat Fitzgerald and said that under her leadership they have done some pretty amazing work. Their recent accomplishments include: Video Production students winning 3<sup>rd</sup> place in a national contest; Culinary Arts students winning 1<sup>st</sup> place in the South Jersey Culinary Arts Competitions; students participating in the South Jersey flower show and receiving twelve (12) 1<sup>st</sup> place medals; and students winning the State Bowling championship.

Freeholder Rodriguez said part of the reason she likes to talk about our Technical Schools is that she recently read an article that when someone takes the CTE route as far as education, they end up with a certificate that allows them to be employable immediately upon graduation. We have plumbers, electricians and others ready to go out and do work. College isn't for everyone; however, our Technical Schools do prepare our students for college at the same time as they are graduating with an employable skill.

**Freeholder Young** said our hearts go out to the people in Florida. He said he is proud of Director Cappelli and how he stands up against useless and senseless gun violence.

He wished Warden Taylor a Happy Birthday and thanked all of his departments for the fabulous job they do. He congratulated the Animal Shelter which also does a wonderful job.

Freeholder Young said three (3) years ago he came on the Board and had Joanne Gurick as his aide. His second term, Nancy Jeanette became his aide and did a fantastic job. Nancy is now moving on to Purchasing. He thanked Nancy for all that she has done. He then introduced his new Aide, Imani Fussell.

**Freeholder Shin Angulo** thanked the Mayor and Council members and said we love coming to Runnemede. For those who are driving around, tis the season for potholes. Because of the rain and the cold, we are experiencing a lot of potholes. She said you are our eyes and ears throughout the County. He said last night he received a tweet from a constituent asking him to thank the Director on his behalf.
