CAMDEN COUNTY BOARD OF FREEHOLDERS FREEHOLDER MEETING MAY 17, 2018

The meeting was called to order by Director Cappelli at 7:00 p.m.

The Clerk called the roll and the following Freeholders answered:

PRESENT: SHIN ANGULO, MOEN, NASH, RODRIGUEZ, YOUNG, McDONNELL, CAPPELLI

The Director stated that adequate notice of this meeting has been provided in accordance with the Open Public Meetings Act.

The Director asked everyone to rise for the Pledge of Allegiance which was led by Faith Simmons and the National Anthem which was sung by Melissa Philips.

The Director thanked everyone and asked for a round of applause.

Director Cappelli said the County has large print agendas available from the Clerk for the visually impaired.

The Director welcomed everyone to the meeting of the Camden County Board of Freeholders and said we are very pleased to be in Berlin Township. It is the practice of the Board of Freeholders to hold the meetings each month in one of the municipalities outside of the County Seat of Camden so that all members of the public will have full access to the meetings of the Board.

The Director said the Freeholders are very proud to call the governing body of Berlin Township our partners in government. Many, many years of great service by the governing body in Berlin has led to some great neighborhoods and some great economic development. These leaders work day in and day out to help bring new businesses and development to Berlin which helps increase tax revenues and keep some of the tax pressure off the residents of Berlin. Director Cappelli thanked the Mayor and Council President for hosting tonight's meeting and said Freeholder Shin Angulo has a presentation to make.

Freeholder Shin Angulo presented a check to the Mayor in the amount of \$21,000 for the improvement of the senior citizens' facility in Berlin. Freeholder Magazzu introduced Council President Chris Morris and Council members Frank Epifanio, Marion Bodanza and Jerome McIntosh and thanked the Freeholders.

PRESENTATION

Director Cappelli asked Eartha Holland to come forward and said, as we go from town to town and have our meetings, we ask the governing body for the name of a non-profit worthy of a small donation in recognition from the Board of Freeholders. The governing body of Berlin Township has chosen the Emerald Vision Community Development. The Emerald Vision

Community Development is a non-profit organization affiliated with Green Grove Baptist Church. The organization partners with state and local agencies to meet the needs of the community. Emerald Vision's mission is to strengthen the physical, social and economic fabric of the community by being a catalyst for education, training and opportunity. The organization uses a variety of resources to fulfill their mission. Emerald Vision donates funds to a school they adopted as well as churches in Kenya, Africa, provided contributions to help build a school building in Kenya, and provided food parcels to villages in Kenya. In addition, Emerald Vision supports programs for underprivileged families in Philadelphia, contributes \$10k annually to the Green Grove Gunther Scholarship where recipients are awarded scholarships based on academic excellence and financial need. To date over \$100k in scholarships have been given to students.

Ms. Holland thanked the Freeholder Board for recognizing the work that they do. Ms. Holland said she is the Executive Director of Emerald Vison Community Development and thinks Berlin has the best mayor and council this side of heaven. She thanked everyone for recognizing the work that they do. So much of what we do we try to keep secret because the work that we do is so much connected to our faith. The Bible tells us to be humble in how we walk and how we serve our fellow man. But being recognized for the work that we do humbly is a great surprise. Ms. Holland went on to say that when you elevate a community, you have the potential to elevate the county and when you elevate a county, you have the potential to elevate the whole state and when you can elevate the whole state then you can elevate the whole country.

COMMUNITY AWARD

Freeholder Shin Angulo said she has the honor of presenting the Community Award which is an award which is recommended by the local Mayor and Council for an organization or individual that they believe is deserving of County recognition. This month's award goes to the Reverend George E. Holland, Sr. who has been the Pastor of Green Grove Baptist Church in West Berlin, New Jersey for 25 years, has been preaching for 31 years and ministering for 41 years. The Green Grove Baptist Church has grown to 400 plus active members. He conducts numerous workshops and seminars throughout the region, as well as speaks on topics such as: Worship and Praise, Youth Ministry, Men's Ministry, Leadership, Church Growth & Development and Marriage. He is a gifted musician and has performed, written and composed music with renowned Gospel Music artists. The Church practices missional connectedness in serving the community. Reverend Holland has several degrees and certifications including a Master of Divinity degree from Biblical Theological Seminary (Hatfield, P.A.). He is involved in numerous organizations and strives daily to fulfill his spiritual mission of preaching the Gospel to the masses. Rev. Holland is married to Lady Eartha Holland and has seven children ages 19-40 and five grandchildren.

Rev. Holland thanked the Freeholders, Mayor and Council and said we appreciate being honored. Rev. Holland said he is one of those people who feel the less you say about him the better. He said he loves Berlin Township and the working relationship that they have with the Mayor and Council.

YOUNG COMMUNITY LEADER

Freeholder Young said that as we travel throughout the County from month to month, we like to acknowledge our youth and say thank you for doing a good job. He asked Tamara Janae Butler to step forward. Tamara Butler is a 14-year-old student at Winslow Township Middle School. She is a member of the Student Government Club, has a great attendance record and strives for excellence academically. Tamara recently received all A's, B's and one C which earned her an Honorable Mention. This young leader is an active member of Green Grove Baptist Church in Berlin, New Jersey. She has participated in the Jewel's Choir and the Ushers Ministry and is currently involved with the children's nursery, the Youth Ministry and Youth Bible Study. Tamara enjoys working with children and has been a Counselor in Training at St. John's United Methodist Church's summer camp. She is also involved in the Girl Scouts and is now a Cadet. In her spare time, Tamara loves spending time with her family and friends, listening to music, swimming and riding roller coasters.

PROCLAMATION

Freeholder Moen said May is Older Americans Month and the Freeholder Board would like to take the opportunity to recognize one of our stellar senior citizens. He asked Angeline "Jean" Tamburrino, to come forward. Jean was born on the family's 100-acre farm in Waterford Township on September 28, 1916. She was raised on that farm with her four brothers and eight sisters. Angeline married the late Frederick Tamburrino and they started their lives together in West Berlin where they had two children: Teresann and Frederick, Jr. The family settled in Berlin Borough in 1962. Frederick, Sr. worked with Joe Ripa at New Jersey Transit for 40 years while Jean worked at Fisher's Clothing Factory in Berlin and Atco Knitting Mill. Angeline and Frederick, Sr. owned and operated Tamburrino's Italian Restaurant in Voorhees in the 1950's. Angeline later worked at Mount Carmel Parish Rectory for 31 years. Angeline is 101 years old and has six grandchildren, eleven great grandchildren and one great great grandchild. She has lived in Berlin Borough for 55 years and enjoys cooking, politics, history, reading and gardening.

Mrs. Tamburrino thanked everyone and said she is so happy to be a resident of Berlin Borough and West Berlin.

PROCLAMATION

Director Cappelli asked Shirley Conroy, S.J. Volunteer Coordinator for Moms Demand Action/Students Demand Action for Gun Sense in America. The Director said June 2nd is designated as "National Gun Violence Awareness Day" in the United States. As we all know, mass shootings and shootings have become commonplace in this nation. Every week there seems to be some type of shooting. Each time it should really shock us all and bring us all to action. Maybe the last shooting in Florida really awakened the nation. Those students have inspired many people to come forward. The members of Moms Demand Action have been active for quite a while. On June 2nd, we are encouraging everyone to wear orange. The Freeholders will be hosting an event in Wiggins Park in Camden City on June 2nd from 10:00 a.m. to 2:00 p.m. to raise awareness to the fact that we need better laws throughout our nation to promote gun safety. The Director said no one here is saying take away guns. We are all saying let's get some reasonable

national laws in place. Laws similar to the ones that we have in New Jersey which are some of the strictest laws in the nation. 80% of the guns confiscated in Camden City and Camden County are guns that come in from other states. States that have loose gun laws. Those guns wind up here and our residents end up being hurt or killed by them. Our public safety folks and police officers' jobs are made a lot more difficult because of a lack of national control on guns. Director Cappelli said on behalf of the Board of Freeholders, we want to recognize Moms Demand Action. They do a terrific job, they co-sponsor events with the Freeholders and are working very hard to continue to raise awareness.

Shirley Conroy thanked Freeholder Director Cappelli, the Freeholders and Frank Filipek, Jr., who is planning the June 2nd event. Shirley said National Gun Violence Awareness Day was started 4 years ago by students in Chicago. Hadiya Pendleton was a 15-year-old who was shot and killed - just one week after performing at President Obama's 2nd Inaugural Parade. Her friends decided, on what would have been her 18th birthday, that they would start something by wearing orange in her honor. They started researching what could be done in Chicago to help prevent the gun violence and it spread across the country. All kinds of monuments, bridges, buildings across the country will be lit orange on Friday the 1st and Saturday the 2nd. There will be a lot of events around and we are asking everyone to wear orange. The event on June 2nd will be to recognize and honor those who have been victims of gun violence and those who are survivors. There will be mothers speaking who have lost children. It is also about suicides and the incidental shootings that happen when guns are left and they are not safely stored. Ms. Conroy said she has been very touched by everyone she has met.

PROCLAMATION

Freeholder Carmen Rodriguez said it is the desire of the Board of Chosen Freeholders of the County of Camden to recognize organizations dedicated to improving the mental health of our community. She asked Amy White, Director of Crisis and Coordinated Specialty Care for Oaks Integrated Care to come forward. Oaks Integrated Care is a private, nonprofit organization committed to serving children, adults and families living with a mental illness, addiction or developmental disability; the organization offers over 230 health and social service programs throughout New Jersey. Oaks Integrated Care has about 2,700 employees who are dedicated to helping fulfill the organization's vision of building healthy, strong communities. Nearly 34,000 lives are impacted each year by programs designed to compassionately meet the community's needs. Oaks Integrated Care also plays a tremendous role in all aspects of mental health in Camden County. The organization is highly involved with the crisis intervention training of local police departments, assists with housing and supports the Camden County Mental Health Board. Oaks' focus on integrated care strives to treat the whole person and achieve both mental and physical wellness for all. Oaks has been at the table with the Camden County Mental Health Board since its creation and has made a lot of the programming associated with it possible. They have a focus on integrated care that strives to treat the whole person and achieve both mental and physical wellness. Freeholder Rodriguez asked John Pellicane, Director of the Mental Health Board, to come forward. Mr. Pellicane thanked Oaks Integrated Care for the work that they do. He said working with people with mental illness can be very challenging. He said Amy White runs a 24hour crisis center. There is an alternative to the crisis center called the early intervention support services which is run by Kate Fisher. He introduced Kelly Walker who supports services for people with multiple hospitalizations and Jeanna who runs a program that provides financial

support to folks with mental illness who are unable to secure bedding or housing. Mr. Pellicane said he is very grateful for each one of their support and thanked them for doing Camden County proud.

Freeholder Nash said he wanted to recognize the work that his colleague Carmen Rodriguez and the Department of Health and Human Services, led by Ann Biondi, do because Oaks Integrated, which is the largest non-profit in southern New Jersey with 2,400 employees and servicing over 36,000 of our residents, is really our safety net in this community and, he said, the four (4) people you see behind me are really the champions of our community. Oaks Integrated Care is going to celebrate its 50th anniversary on June 6th. They are going to recognize some other community champions such as Senator Troy Singleton and Nilsa Cruz-Perez and we are just so grateful for the work that Oaks has done in our community.

Amy White said it is an honor to be here tonight. She thanked, on behalf of Oaks, the Freeholders and the Department of Health and Human Services for the recognition and for all of her colleagues who could not be here tonight that work tirelessly to make the community a better place. She said as Oaks continues to grow, she hopes that they can be in more places.

Freeholder Rodriguez presented Ms. White with a Proclamation thanking Oaks for its many years of service and all that they have done.

PROCLAMATION

Freeholder Nash said tonight we are going to recognize a person whom he considers to be a community superstar and asked David Snyder to come forward. Freeholder Nash said he has known David for many years but the past eight years David has served as the Executive Director of the Jewish Community Relations Council. David has done an extraordinary amount of work for the JCRC. The JCRC is involved in many organizations; they are fighting against anti-Semitism, they are promoting Israel, but Freeholder Nash said he thinks the thing that was most impressive to him about the work that David and his colleagues at the JCRC has done is at a time when the Muslim community was feeling under attack by this nation and communities and there was a feeling of being scared of their own neighbors, it was David and the JCRC and the interfaith community of Christians, Jews and Muslims who came together in Southern New Jersey to say we are a family. We are all together. It was led by David Snyder. Freeholder Nash said he was so proud of the work David did because we have a sizable Muslim community in Southern New Jersey and it is unacceptable that any segment of our community should feel under attack. Freeholder Nash went on to say how proud he is of the Jewish Community Relations Council and of David who led the effort with Christians, Jews and Muslims together. He did it by educating people who don't understand. They opened up the Jewish Community Center and had over 500 people learning about what the Muslim religion is about, and what the Koran actually says as opposed to the radicals who have made it something that it is not. For that reason, we are going to thank this man, David Snyder, for the work that he has done. He has moved on to a new position with McCabe USA and, Freeholder Nash said, I am sure that organization is going to be wellserved but we are so thankful for what David did for us that we wanted to recognize your effort over the past eight years.

Mr. Snyder said thank you to all of the Freeholders. He said we are in this together. We have been in a few Mosques together. Mr. Synder said it has been a pleasure to both live in

Camden County for his entire life and to work and to cover this territory for about 20 years. It's truly a pleasure and I cannot thank you enough for your friendship and partnership.

EMPLOYEE OF THE MONTH

Freeholder Nash said the next recognition goes to the Employee of the Month. We select one employee per month out of the 3,000 people that are employed by Camden County at different agencies. This employee is very apropos because we get to give it to an employee of the Parks Department in May. Freeholder Nash said it gives me great pleasure to introduce Stephen Klosinski. Freeholder Nash asked Maggie McCann, the Director of Parks to also join him. This is very important, especially at this time, because the Camden County Cooper River, which is the jewel of the County Parks System, is going to be hosting of the Stotesbury Regatta. That Regatta has been in Philadelphia for the past 92 years and the Philadelphia representative said, because of the weather, we are going to move it on a moment's notice, to the Cooper River. It is the Parks Department and the Boathouse who picked up, on a day's notice, and great community volunteers, like Ann Cutler, who has been a part of the rowing association in Camden County for many years, who picked it up to host 6,000 participants. It is the largest Regatta in the entire country and they are coming to Camden County. Freeholder Nash said this is a very big deal and it is great that we are able to recognize Stephen and all of the men and women who work at the Parks Department. This is a great story because Stephen started as a seasonal worker working the summers back in 2010. He did such a great job that the Parks Department decided to hire him full-time and he started working for the County in December of 2014. He started as a laborer, meaning he's the guy who is just picking up the stuff and making sure those parks are beautiful before we all get out and about in the morning. He progressed through that position because of his hard work and dedication, to the positon of truck driver and he is recognized by his colleagues as someone who cares a lot about the parks and gets the job done so that the rest of us can enjoy our 22 parks throughout Camden County. Stephen is a resident of Pine Hill and we are so appreciative of everything he has done. Freeholder Nash asked Maggie McCann to say a few words.

Maggie said that Stevie is a great worker and we are so lucky to have him on our crew. He is reliable. When I give him a job to be done Stevie is on it, I know that it is getting done and being taken care of. We rely on him in a lot of ways at the Parks Department.

Freeholder Deputy Director McDonnell thanked the Mayor and Council for hosting the meeting. He congratulated Freeholder Rodriguez on the Women's Health Conference and noted that Linda Develin, Director of the Camden County Library System was in attendance at tonight's meeting/

Director Cappelli recognized the Deputy Mayor of Waterford, Tom Giangiulio and congratulated Freeholder Jeffrey Nash for being named Freeholder of the Year. Director Cappelli said Cooper River, thanks to Freeholder Nash's leadership, has become a tremendous venue. These regattas generate over \$10 million a year for the local economy.
