### CAMDEN COUNTY BOARD OF CHOSEN FREEHOLDERS CAUCUS MEETING

### September 17, 2019 - 6:00 PM FREEHOLDER CONFERENCE ROOM - 16<sup>TH</sup> FLOOR 520 MARKET STREET, CAMDEN, NJ 08102

Freeholder Director Cappelli called the meeting to order at 6:00 p.m. and the following Freeholders answered to their name:

The Director said this meeting has been properly advertised in accordance with the Open Public Meetings Act.

The Director asked for everyone to stand for a moment of silence and then asked everyone to remain standing for the Pledge of Allegiance which was led by Warden Taylor.

The Director then proceeded with the Caucus Agenda.

The Director said we will have six (6) First Readings on Thursday evening as follows:

**FIRST READING** - Bond Ordinance further amending a Bond Ordinance finally adopted January 21, 2016, as amended by a Bond Ordinance finally adopted October 19, 2017 and as further amended by a Bond Ordinance finally adopted September 17, 2018 by the County of Camden, State of New Jersey, in order to provide for a further change in the improvement authorized by such Ordinance.

Resolutions 89 through 110 and 112 through 118 were approved to be placed on the Freeholder Meeting Agenda for adoption. Resolution 111 was pulled.

The Director opened the meeting to the public for discussion of the Resolutions.

Joseph Quigley of Haddon Heights asked the following questions:

Resolution No. 27 authorizing Change Order No. 3 (Bid A-38/2017), by and between the County of Camden (Department of Buildings and Operations) and Tutor Perini Building Corp., for demolition of the Camden City Hall Fifth and Sixth Floors, for an increase in the amount of \$24,470.00. Chris Orlando commented that this was a minor change order. They requested a about a million dollars in change orders at the end of the project. We negotiated down to the final change order being \$24,000.

Resolution No. 29 authorizing a Memorandum of Understanding, by and between the County of Camden (Department of Buildings and Operations) and the State of New Jersey, Department of Treasury, Division of Property Management and Construction, for the lease of office space at 101 Woodcrest Road (Suite 127) in the Township of Cherry Hill, for the period of September 16, 2019 through December 15, 2022, in the amount of \$2,272,710.36. Mr. Quigley commented that this is a lot of money to pay for rent. Chris Orlando commented that the State is paying us.

Resolution No. 41 authorizing Change Order No. 1 (Bid A-7/2019), by and between the County of Camden (Department of Parks) and Atlantic Subsea, Inc., for starting docks, for an increase in the amount of \$26,708.00. Mr. Quigley asked what the increase was for and where the docks are? Maggie McCann-Johns replied the Change Order is for structural work to the docks and that the docks are for the Regattas.

Resolution No. 44 authorizing the approval of recommendations of the Open Space Preservation Trust Fund Advisory Committee, relative to Round 19 Historic Preservation Projects, in the total amount of \$250,000.00. Mr. Quigley asked for a list of the projects. Freeholder Nash read the list to him.

Resolution No. 79 authorizing acceptance of the 2018 Report of Audit. Mr. Quigley asked for a copy of the Budget. David McPeak said it was available on-line or he could mail him a copy.

Resolution No. 89 authorizing an award of Contract, pursuant to solicitation of quotations, by and between the County of Camden (Office of the Prosecutor) and Sumuri, LLC, for the purchase of one (1) forensic workstation, in the amount of \$10,595.00. Funding available from the Prosecutor's Forfeiture Funds. Mr. Quigley asked how much money is in

the Prosecutor's Forfeiture Fund. David McPeak said he did not have the number handy but that he could get it for him. This is for people who put up bonds? No, David responded it is for confiscated money.

Resolution No. 113 authorizing an award of Contract (State Contract #A-82583), by and between the County of Camden (Department of Police Services) and Cellco Partnership, d/b/a Verizon Wireless, for cellphone and modem service, in the amount of \$460,000.00. Funding available in the amount of \$150,000.00 - CAF#9900213777. Balance of funding contingent upon appropriation of sufficient funds in the FY 2019 Budget. Is this our normal Verizon wireless bill? Why are we only authorizing part of it? Holly responded that the Police Department operates on a fiscal year and their year just began and part of their year goes into 2020 so they only authorize a portion of it. This is for their wireless cell phones and modems.

Jewish Community Center Donation If you walk into the Jewish Community Center in Cherry Hill they have a list of donors on the wall. The Freeholders are listed as a \$1,000 donor. Freeholder Nash said it was not a cash donation. When the facility was first being contemplated, the JCC needed financing and the County's IA provided the financing vehicle for them to afford that building. The County did not put cash up, but they used its mechanism at the CCIA to help finance the non-profit. It is not a religious organization, it is 501(c). We helped them secure financing at a lower interest rate and they paid it off quicker than they thought. Mr. Quigley asked if we do it annually. Freeholder Nash responded no, we do not.

Unnamed Constituent - Resolution No. 34 authorizing payment by the County of Camden (Library System) to Barton Carpets & Floor Covering, for removal and replacement of carpeting at the Bellmawr Branch, in the amount of \$112,550.00 - Various CAFs. I don't know if you have ever been to that library, it is one floor and not everything is carpeted. For \$12,550 you can pay me to go in their and rip it out on a weekend and still have \$100,000 left. How expensive is the carpeting going in there? Dominic Vesper said it is probably a 5200 sq. ft. building. They are ripping up the old carpeting, which is probably glued down, its labor intensive, they need to move all the shelving. Do you think its high? Yes. Mr. Vesper said he will find out for him.

Seeing no other members of the public wishing to comment, the Director asked for a motion to close the public portion. Freeholder Young made a motion with a second by Deputy Director McDonnell. All Freeholders present voted aye.
