The meeting was called to order by Director Cappelli at 7:00 p.m.

The Clerk called the roll and the following Freeholders answered:

The Director stated that adequate notice of this meeting has been provided in accordance with the Open Public Meetings Act.

The Director asked everyone to rise for the Pledge of Allegiance which was led by Boy Scout Troop #118 and the National Anthem, which was sung by Kylie Jones.

The Director thanked everyone and asked for a round of applause.

Director Cappelli said the County has large print agendas available from the Clerk for the visually impaired.

The Director welcomed everyone to the meeting of the Camden County Board of Freeholders. It is the practice of the Board of Freeholders to hold our meeting each month in one of our municipalities outside of the County seat of Camden so that all members of the public will have full access to the meetings of the Board. As is our custom, we are going to ask members of the governing body to come forward. Director Cappelli asked Mayor McBride to come forward with her committee members, as well as Freeholder Rodriguez. Mayor McBride introduced Committee members Marco DiBattista and Tim Killion. She asked everyone to keep Deputy Mayor Rick Taylor in their prayers as he is very ill. The Director thanked the Mayor for hosting us and said we are very proud to call the governing body here in Pennsauken our partners in government. They do such a wonderful job and there is a long tradition of great leadership in this municipality going back decades. As a result, one of the most robust economies in Camden County is right here in Pennsauken. Many jobs are created here year after year. There are great neighborhoods and we are very pleased to be here tonight. The Director turned the mic over to Freeholder Rodriguez for a presentation. Freeholder Rodriguez said I come with your CDBG check in the amount of \$150,000.00 for your Lend-A-Hand Program. The Lend-A-Hand Program assists low to moderate income constituents with home rehabilitations up to \$14,000. The Mayor said the Freeholder Director said it very well, we consider Camden County a very close partner of ours. Not only have you adopted this beautiful park and had your staff do this beautiful renovation but you have helped us with multiple road projects. You helped us with our Shop Local Program, our Lend A Hand Program and we could not be Pennsauken without Camden County's support. This Lend A Hand Program has been going on with CDBG dollars for a long time. Some of our residents do struggle and need a little helping hand. When we are watching a tight budget, we might not be able to come up with the funds to help those individual families. This check means a lot to us in Pennsauken.

PRESENTATION

Director Cappelli said, as we go from town to town and have our meetings, we ask the governing body for the name of a non-profit in town worthy of a small donation and recognition by the Board of Freeholders. This governing body has chosen the Pennsauken Lion's Club. The Director asked Ely Mateo to come forward. The Pennsauken Lions Club was founded in 1917 and is best known for fighting blindness, but this Club gets involved in many different activities here in Pennsauken, including the Peace Poster Contest, Youth Camps and Exchange and Lions Quest. All these volunteers from the Lions Club help make Pennsauken such a special place to be. On behalf of the Board of Freeholders, the Director thanked Ely and all his members for their hard work and presented him with a small token of their appreciation.

Ely said, on behalf of the Pennsauken Lions Club, I want to thank everyone for coming here and on behalf of the 1.4 million Lions worldwide that go out of their way each and every day to make life better for their communities. Ely invited his team members in the audience to join him. They all dedicate their time and effort to make sure that the less fortunate are helped. I am very proud. Eyesight is our number one opportunity here in Pennsauken. Each year we have the opportunity to screen the kids in pre-K and kindergarten in the Pennsauken School Districts as well as Merchantville. I am happy to say that so far this year we have screened over 700 kids. It is because of people like you who care about what we do that makes this possible. Again, on behalf of the Pennsauken Lions Club, our team here and the members, we really want to thank you.

COMMUNITY AWARD

Freeholder Kane said it is my privilege tonight, keeping with our Pennsauken theme, to present our Community Award. The recipient this evening is Captain Daniel J. Kerr, Jr. Captain Dan Kerr is the Administrative Captain of the Pennsauken Fire Department and he has served with the Department for 22 years. He is responsible for the Training & Safety Division, as well as the Fire Prevention Division. Captain Kerr created the School Public Education Program and the Fire Investigation Unit. He served as the first unit leader of the Fire Department's Honor Guard. Dan received an Associate of Applied Science Degree and was certified in Criminal Justice at Camden County College in 2006. He is currently in the Public Safety Administration Program at Neumann University. Dan has the following certifications: Firefighter II, Fire Officer II, Fire Marshal, Level II Drill Ground Instructor, and Juvenile Firesetter Specialist. His devotion to public service is also shown at his job as a part-time Lieutenant with the Collingswood Police Department. In his spare

time, Captain Dan is a Basic Life Support Instructor as well as a Fire Instructor. Captain Dan was born in Camden and raised in Pennsauken where he now lives with his wife, Hannah, and son, Aidan. Congratulations.

Captain Dan said, remember that our nation, as a whole, was funded on communities. Individual communities. That is where most of the work gets done. We celebrated up here tonight, the Lions Club and various other organizations, including the Fire Department. Remember that in everything you do. When you want something accomplished it happens right here every day in your town. Thank you.

SPECIAL PRESENTATION

Freeholder Kane said I am going talk about a program that was not done alone but was done with the incredible work of many individuals. That program is the Camden County Welcome Home Program for our Vietnam veterans. We hosted the 50th Commemoration event on September 5th through 8th where we were blessed with beautiful weather and an incredible amount of gratitude and love and joy for everyone that was there who we could honor for their service and sacrifice. We came together as a county to honor our veterans from Vietnam and for all those who have served. The tribute included the Vietnam Traveling Tribute Wall, which is an 80% replica of the wall and was on Veterans Island. For those of you who did not have an opportunity to see it, it was beautiful. It was placed in front of the flags with the Cooper River behind. Many people asked if we could keep it and I did hear that it was for sale for \$8,000. In addition, we had a motorcycle escort, a powerful Welcome Home pinning ceremony, a moving remembrance vigil, a veterans' service fair, educational speeches, a free concert by The Tri County Symphonic Orchestra and Gary Puckett as well as the Union Gap, and the Travis Manion 9/11 Heroes Run. This historic event was a huge undertaking, and nothing is done individually. I would like to call up those who were involved with this tremendous event. As you can see, this was a collaborative effort and I am proud to have worked with all these individuals and we look forward to working together as colleagues and as friends.

Director Cappelli said thank you everyone. It was a great weekend. The Board of Freeholders could not be more proud of the weekend where we welcomed home the Vietnam veterans. I want to also thank, for her leadership and for putting her heart and soul into this project, Freeholder Kane. You did a great job!

Louis Cavaliere said I represent The Chapel of The Four Chaplains which is in Philadelphia, but I am a resident of Cherry Hill, so I feel like I belong here tonight. I have been here since 1995 and this is the first time I have ever been to a Freeholder's meeting and I have to say this is quite exciting. What I am here for tonight is to say, this committee that was just up here did an outstanding job but I want to thank the Camden County Board of Freeholders for what they did as well because that was no insignificant task and I know it cost a lot of money, a lot of time and a lot of involvement. We really appreciate that. Now, why do we appreciate that? At The Chapel of The Four Chaplains, which is over in the Navy Yard in Philadelphia, I work with a lot of veterans. A lot of veterans are suffering from things like post-traumatic stress disorder, childlessness, homelessness and substance abuse. As a result, we are dealing with a lot of issues. Vietnam vets are still dealing with those issues. I want to tell you from the bottom of my heart and thank you guys because there was some genuine healing going on when we had that event so thank you very very much. I also want to tell you that there are two people in particular who I am going to give our Command Coin to. A Command Coin is given by the commanding officer for excellence or for good behavioral. I would like to call up two people here who work for the Camden County Board of Freeholders who did an excellent job organizing the Vietnam Wall event and that would be Kara Maxwell and Frank Filipek. Chaplain Cavaliere asked everyone to stand as he presented the coins to Kara and to Frank. He said, please, both of you continue in the excellent service that you are providing, not only to veterans but also to the community at large. Thank you all very much.

YOUNG COMMUNITY LEADER

Freeholder Young said as we travel throughout the County each month, we like to make sure we have the opportunity to celebrate our youth and make sure they understand their value. Each month we ask the municipality to pick a youth in our community who is doing outstanding work. This month's Young Community Leader is Angela Nguyen. Angela is a senior at Pennsauken High School. She is ranked 5th in her class with a 4.3 GPA. She excels academically and has 7 AP classes. She scored a 1380 on her PSAT and 1390 on her SAT. She is the recipient of the AP Honors Award and the Teacher's Choice Award. She is also a Renaissance Super Student, 21st Century Stem Summer Program participant, a nominee for Rising Critic for South Jersey Cappies, and winner of South Jersey Cappies for Best SFX. Angela is a National Honor Society member, a Peer Tutor, President of Leo Club, Editor-in-Chief of the Penndian, Director of the Fall Play and Stage Manager for the School's Musical. She has participated in Junior Achievement, South Jersey Cappies, Poetry Out Loud, United Nations Association, Princeton Summer Journalism Program and more. Angela also volunteers at the library. For the great and outstanding young adult that you are now and for the great and outstanding adult you are going to be and the contributions you are going to make, you are this month's Young Community Leader.

Angela said this award is not just my award. Its an award for the community that raised me. I am a product of all of the teachers at Pennsauken High School that encouraged me to learn and to think for myself; my family, who taught me to be better and always strive for better; for my friends who were always there to support me and in general, Pennsauken, the community where I was raised for offering me so much compared to what life could have been. Atop of the Washington Post is a phrase "Democracy Dies in Darkness". As long as the torch continues to be passed down to the youth, democracy will never die and society will thrive, especially our community here. Thank you.

SUSTAINABILITY AWARD

Freeholder Young said I also have the honor of being the liaison to the Office of Sustainability. We in Camden County take sustainability very seriously. We are the only county in the State of New Jersey with a Department of Sustainability. Freeholder Young asked Chris Waldron, Director of the Office of Sustainability, to come forward. The Freeholder said, later this evening this Board is going to do something that is pretty spectacular. We are going to vote on a plastics ban in Camden County. What does that mean? Anything that Camden County, as a government, has control over, we will not be using plastics as of January 1, 2020. That means straws, utensils, Styrofoam, and plastic bags. It has been a very long process. The Freeholder thanked Chris Waldron, AnnaMarie Wright, Laura Paffenroth and Imani Fussell. They have been working on this for months, talking to our vendors to find out what the alternatives are and how we get back to natural products. Freeholder Young asked Chris Waldron to explain the process.

Chris Waldron acknowledged the Board of Freeholders and the leadership of Freeholder Young for this ambitious effort. We will be the first county in New Jersey to do this sort of ban. Atlantic County has a smaller one, but we are doing the whole scale. As Freeholder Young mentioned, this takes effect in 2020. There is going to be a lot of coordination between our vendors to make sure that it happens. You can imagine how long and how wide the County stretches in terms of the College, our Detention Center, our Library System and all the departments and agencies that we oversee. It is a credit to the Freeholders to see that this is an important step for everyone. Plastic pollution, if you look at the news, it is happening everywhere, not just in this area but around the world. We are learning that what is really happening is that microplastics are invading all parts of our life, especially in waterways. Now we are seeing microplastics show up in fish and other seafood that we eat. We are re-ingesting those things. A lot of those things are from single use plastics. Plastic bottles, plastic utensils, plastic bags. Things that wind up in the waste stream in some way. We are taking a step to make sure we are now using natural products. We haven't flushed out what all of those things are, and it is going to determine which vendors we are working with and which agencies we are working with. All the products that the County will using will be based in some natural form whether it is bamboo, wood or sugar cane. Some product that can naturally break down in the environment and not become a microplastic. We are really excited to move forward with this program.

Freeholder Young said I would like to thank my colleagues for taking such a bold step along with us. I often say that we, as elected officials, have a responsibility. That responsibility is to leave this place better than when we found it. This award tonight will do that.

This month's Sustainable Champion is Karina Istvan. Karina volunteered to join the Pennsauken Shade Tree Commission two years ago and has truly re-energized the membership. She has an extensive background in landscape design and has been an asset to the Commission. She has facilitated Pennsauken's efforts to come back into Active Status with its Community Forestry Management Plan. This significant task would not have been successful without her. Karina has also promoted project ideas for this year and into the future that would engage the community to help maintain our tree canopy. She is always looking for innovative ideas for the Commission as she strives to improve the tree planting program, minimize impact on the community and engage the residents of Pennsauken. We are proud to recognize Karina as our Camden County Sustainability Champion for the month October.

Karina thanked everyone for the award. She said I am honored on behalf of the entire Shade Tree Commission of Pennsauken. It has been wonderful to be part of a community that is so involved and interested in helping. In Pennsauken, where we have a lot of older trees, we are focusing on new plantings because our shade canopy is diminishing, as is in much of Camden County. I would encourage everyone to remember the importance of trees and what they do for us. As you have older ones that need to come down, think about replacing them with new ones so they can live on and we can continue to have canopy over us.

PROCLAMATION

Deputy Director McDonnell said I have a real honor tonight. I have a long-time friend, a very special friend of mine who the Board of Freeholders would like to honor. He is Camden County College Professor Dr. Jack Pesda. The Deputy Director asked Jack to come forward. The Freeholder Board wanted you to be here tonight because we wanted to pay special recognition to your almost 50 years as a professor of history and political science at Camden County College. The Deputy Director asked for a round of applause. If you run into people, as I have, Jack and I worked together for about 20 years, you run into people all the time, whether it be at the mall or on the street. In fact, we ran into someone tonight at this meeting who told us that he took many of Jack's history courses when he was at Camden County College. Everyone you talk to, whoever had Jack as an instructor, just loves him and thinks he is the best lecturer and most informative, interesting professor they have ever had. Jack, you are a great tribute to Camden County College and, of course, all of Camden County. There is another thing we wanted to honor Jack for tonight and that is, about 30 years ago Jack had this idea that Camden County College should do something to engage the public of Camden County in learning beyond what we do in school and in classrooms. He created the Camden County College Center for Civic Leadership and Responsibility. The Center initially had occasional lecture series and speakers so people in the community could come in and talk about what it means to be a good citizen and what ways people could get involved. Over time, the program has evolved under Jack's leadership so much that we now just call it the Center and it is becoming well-known in South Jersey as a great Center for intellectual stimulation and conversation. Jack has brought to Camden County College, first only at the Blackwood Campus, and then eventually to all three of our campuses, Camden and Cherry Hill, and now all over the county, scholastic experts in all kinds of fields to either do programs or lectures and he has classes of all kinds. He offers mini courses in the sciences, music, film, television, famous artists, literature, intellectual theories, and medicine. I have been to a lot of these lectures and they are simply amazing. I know Ross Angilella has been to a lot of them and I hope some of you have had the opportunity to be there, too. The Center partners with the University of Pennsylvania, the Worlds Affairs Council of Philadelphia, The Benjamin Franklin Institute, the Pennsylvania Academy of Fine Arts, the New Jersey Council for the Humanities, the Autism Society of S.W. Jersey, The Cherry Hill Jewish Community Center, and the New Jersey Holocaust Commission. I thought tonight, and the Freeholder Board agreed, that we should honor Jack not only for his great service as a professor at Camden County College, but for the Center which now is indeed a Center of cultural enrichment in Camden County. Jack is going to take a minute to tell you about the Center and how you can become involved.

Jack thanked Deputy Director McDonnell. He said I am a history professor and I never speak for under an hour and a half. Our Center has a motto, "We share the World with You" and we want you to share it with us as well. We have programs on a whole range of different topics. I tell some of my speakers when you look at my audience you will find it is a grey audience but not in terms of interest, but rather in terms of appearance. We also serve people of all ages and in fact, we have free programs coming up for public school students, NJ Leadership Program, which involves Rutgers-Camden, Camden County College, and the World Affairs of Philadelphia and we are also doing a sustainability project next year and, with the assistance of Freeholder Young, were able to make contact with the Office of Sustainability right here in Camden County. We serve all the residents of Camden County and, as Freeholder McDonnell pointed out, we are trying to have programs in communities throughout the county. If your community might be interested in this and you can provide us with a venue, we would be happy to accommodate the interests of your students. Jack again thanked Deputy Director McDonnell and the entire Board of Freeholders for their continued support of his programs as well as this award.

PROCLAMATION

Deputy Director McDonnell said I would like Jack to remain up her with me so he can meet the next generation of great educators in Camden County. Jack is of one generation and this is the next generation. Ladies and Gentlemen, I would appreciate if you would join me in welcoming the 2019/2020 New Jersey Teacher of the Year, Haddonfield High School teacher Kimberly Dickstein-Hughes. The Deputy Director asked Kimberly's family and friends to come forward and join her. To really appreciate Kimberly's accomplishment, you have to know that there are 200,000 educators in New Jersey and guess who is the #1 educator in the State of New Jersey? Kimberly. Kimberly was educated in Voorhees Township Public Schools. She has a bachelor's degree in English and Political Science and a master's in English Secondary Education at Rutgers University. Kimberly has taught English Language Arts at Haddonfield Memorial High School for 11 years. She recently got married at Haddonfield Memorial High School. Four days after she got

married, she got the announcement that she was the New Jersey Teacher of the Year. That's a pretty exciting week. She is also a 2019 Princeton University Distinguished Secondary School Teacher and Camden County Martin Luther King Jr. Freedom Medal Award recipient. She is an amazing advisor of Model United Nations, Shakespeare Troupe, and Stand With Camden; all of these activities that encourage scholarship and service. In 2017 South Jersey Magazine named her a South Jersey Super Woman. Since 2002, Kimberly has been committed to creating awareness and improving the quality of life for hospitalized teens. She is a member of the Alicia Rose Victorious Foundation's Community Advisory Board and advises the Youth Leadership Council. She will present on critical global literacies at the National Council of Teachers of English Annual Convention in November. Kimberly is a superb representative of all that is great about Camden County. Congratulations, Kimberly.

Kimberly said thank you. My name is Kimberly Dickstein-Hughes and I am the 2019-2020 New Jersey State Teacher of the Year. I wouldn't be standing here without everyone here in this room, especially my parents, Howard and Kathleen Dickstein, my husband Phil Hughes, my sister and my students. These students here are my officers for our club at Haddonfield High School "Stand with Camden". I want to thank the Freeholders for welcoming me, again. I met many of you last year at the Freedom Medal Awards and that was an incredible honor. Martin Luther King, Jr. once said, "the time is always right to do what is right" and I really hope to do right by the 200,000 educators serving the 1.4 million students and their families in the great State of New Jersey. I am a proud product of Camden County. I went to ET Hamilton Elementary School, Voorhees Middle School and Eastern Regional High School. From there I went to Rutgers University in New Brunswick I am also a proud product of a public institution. I then returned to Camden County to teach English Language Arts. What was really clear to me tonight is the endless productivity in Camden County. The connections we make here at home are infinite and we are capable of making anything possible in Camden County. My students prove that every single day. We have a club at Haddonfield Memorial High School called Stand with Camden. It is really about standing with Camden County. It is very important that we give back every single day. Angela is a product of that at Pennsauken High School. Something I always say is that if you want to give back, you become a teacher. If you want to give back to your community, you become a teacher in your community. Thank you very much for allowing me to be here tonight. I will be presenting my platform as New Jersey State Teacher of the Year at the NJEA Convention. It is called Lift Every Voice New Jersey. NJ Teaching wins because we have everyday victories that we need to share with the country, and we need everyone to know that we are #1.

PROCLAMATION

Freeholder Shin Angulo said I have the privilege of introducing a ton of people who have done an amazing job throughout Camden County and they are called the Tri-State Canine Response Team. She asked Janice Campbell, the CEO and President of the Team, as well as all team members and their canines to come forward. Janice founded the Tri-State Canine Response Team in 2015. She has certified, trained dog handler teams who provide emotional support to families, neighborhoods and First Responders. The Crisis Response Team provides comfort, stress relief,

emotional support and crisis intervention services. Tri-State has 51 affectionate canines and 55 professional handlers. The handlers are trained in FEMA's Incident Command, Psychological First Aid, Mental Health First Aid, and CPR. Tri-State has served over 103,972 people since its start. They partner with Red Cross, Office of Emergency Management, First Responders and community Disaster Response Services. Tri-State's Founder, Janice Campbell, is proud of the time and dedication of her team. She will present them with The President's Volunteer Service Award. The Bronze, Silver and Gold awards acknowledge the tremendous number of service hours performed by the teams in a year. The Bronze represents 100+ hours; the Silver is 250 hours and the Gold is 500+ hours. Freeholder Shin Angulo said congratulations to the canines as well as to their handlers.

Janice thanked the 13 volunteers who were in attendance and their dogs and also to the handlers here with pictures of their dogs. These are dogs that were in service but have passed. Our group is a group of all volunteers. We have 51 team members and they commit their time to work in the community and to give back. We work in schools, with autistic children, any time there is a suicide in a school, the death of a student or a teacher, we will all go out and provide emotional support and resiliency to that school. We also go when we are called upon by the Crisis Intervention team or Office of Emergency Management. Many of our team members just came back from El Paso, Texas. We have gone to mass shooting areas in Las Vegas and Southerland Springs, Texas, and Parkland, Florida. Our First Responders are the people we want to make sure we support first. A lot of times the people on the front line who are the police officers, the EMTs, the 9-1-1 call operators work through and we forget to realize that they also need support. Many of our team members have full-time jobs and they volunteer. They are crisis counselors, grief counselors, dog walkers. Dr. Hoffman always says he retired his stethoscope for a leash. We have a great committed group. We would not be able to do it if they did not commit their time. We are here for the community and are here any time you need our help.

PROCLAMATION

Freeholder Rodriguez said we are coming to the close of the Hispanic Heritage Celebration. Last Friday we celebrated our 37th Prominent Latinos Award here in Camden County, the only county in the State of New Jersey that has an Office of Hispanic Affairs. Freeholder Rodriguez asked Senator Nilsa Cruz-Perez to come forward, as well as Mayor McBride, Director Cappelli and Captain Alexandro Ibarrando. Freeholder Rodriguez said you are very special and very important to our Camden County community and that is what Prominent Latinos is about. It is about people who have made a difference within the Spanish/Latino community throughout the County. Captain Ibarrando's law enforcement career began in 1998. He started out with the Camden City Police Department as a Detective on the Narcotics and Shooting Response Team. In 2008 he became Detective Sergeant. He served on the Governor's Crime Plan, Task Force Overarch and Task Force Landing Strip. In 2013 he joined Camden County Police Department as a Lieutenant. He also served as Commander of the Community Safety Division and the Real Time Tactical Operational Intelligence Center. He was later assigned as Commander of the Professional Standards Bureau and became Captain in 2015. Captain Ibarrando earned his bachelor's degree from Fairleigh Dickinson University in 2017 and has numerous special certifications. He also served in the U.S.

Army Reserve from 1998 through 2004 as a Sergeant and Staff Sergeant and was at one time deployed to Guantanamo Bay, Cuba and Iraq. On behalf of the County of Camden Board of Chosen Freeholders, we would like to present you with this award.

Captain Ibarrando said it is an honor and a privilege to be chosen for this award. I look forward to continuing to serve the community of Camden City in my law enforcement capacity. Thank you to everyone.

PROCLAMATION

NO MOTION MADE – FAILED

Director Cappelli opened the meeting to any member of the public who wished to address the Board of Freeholders. The Director declared the hearing open.

Bernie Kofoet, Pennsauken Township. Mr. Kofoet said one of my responsibilities during the Welcome Home Ceremony was to arrange the speakers bureau for Saturday's event. The idea was to have Vietnam veterans there to share their stories with the public. About two weeks prior to the event I had an email forwarded to me from Kara Maxwell. She had received an e-mail from a young lady who thought the Vietnamese community side of the war deserved a place there. The contact information was in there, so I reached out to this person and we talked on the phone. She explained to me that she was a member of a predominantly Vietnamese church community. She had a lot of elderly gentlemen in her community who fought alongside Americans in Vietnam and she thought their story deserved to be told. I told her at this point I have all of my speakers lined up but if you want to approach some of them and they want to come out we will fit them in. I didn't hear anything more from her. Friday night at the Vigil, Angela came up to me. Angela was the young lady I was speaking to on the phone. She said she had three gentlemen who wanted to come out. I told her, by all means. On Saturday afternoon she showed up with three gentlemen. The senior gentleman was a Major and an Intelligence Officer in the South Vietnamese Army. He showed up in his South Vietnamese uniform with all his medals. Very impressive. The Vietnam in-country vets who were there, we had a number of them, they recognized this gentleman as being a friend and they just went over and embraced him and took him over to their displays. That is a part of Angela that wasn't talked about tonight, but it just goes to show you the character and quality of this young lady. She actually had two other gentlemen with her. We brought them over to the speakers and she had an opportunity to introduce them and they spoke for a few minutes. It was important to her and her community to be heard. I was so thankful that she stepped forward. I just wanted to acknowledge her for that.

Seeing no other members of the public wishing to comment, Director Cappelli asked for a motion to close the public hearing. Freeholder Nash made a motion with a second by Freeholder Shin Angulo and all Freeholders voted aye.

The Director opened the floor to the members of the Board of Freeholders for their comments.

Freeholder Nash said I want to congratulate my colleague Jon Young for introducing the Ordinance that is going to prohibit the use of plastics in Camden County facilities. I think it is a monumental message that the County is sending for something that is so important. Jon, I congratulate you and Chris and your office and all of the attorneys who worked on it. I know it was extremely complicated, but it is going to send an enormous message to our community. Freeholder Nash said I also want to congratulate Freeholder Kane and all of the people on the committee that put together a remarkable show to say thank you to veterans; a thanks that is long overdue. It was a spectacular program. For \$8,000 we should probably buy the wall. There was a program that occurred a couple of weeks ago that we did not mention tonight and that is we dedicated a bocce court to play bocce ball at Cooper River Park. I learned through reading about it that bocce is the 3rd most popular international sport in the world played by over 25 million people around the globe and most importantly that court was dedicated in memory of Lou Cappelli, Sr. We talked a lot about educators tonight and there is certainly a lot of people to recognize but there is no greater education icon in our community than Mr. Cappelli. He was a remarkable man and any time you meet anyone from Triton High School they will sing praises about this great educator. Congratulations to the County, to everyone who was involved in the creation of that Court. It was really a very special occurrence. Moving forward, on November 2nd, Camden County is going to rededicate Challenge Grove Park in the memory of Congressman John Adler. We are going to send invitations very soon to a sign ceremony and the Adler family, all four of her boys from Harvard. They are a remarkable legacy that John left behind. We are going to do our part by renaming that Park which touches Haddonfield on one end and Cherry Hill on the other which is the two communities from where John came and we hope to see everyone come out to remember John Adler and the service that he provided to all of us for so many years. Thank you to Pennsauken.

Freeholder Young said before we get started, if you get some time between now and riding home, please take a couple of minutes to say some prayers. We lost a very great warrior today, Elijah Cummings. He was a man who stood on principle and moral and was an all-out good dude. Freeholder Young thanked Pennsauken for having us this evening. Another part of my responsibilities is overseeing the Animal Shelter. We are having our big last event this Saturday at 11:00 at the Camden County College. It is our last big push of the year to make sure our animals have a forever home. I will be there at 11:00 and we will start parading the dogs out. We have over 200 walkers who are going to come down there as well. If you have nothing to do on Saturday, come on down. If you are looking for a dog, I am sure we can find you one there. Again, I want to thank my colleagues for all their support on the plastics ban. It is very important to us and to our community. I never thought I would become such a sustainable champion when I first took this

department over. It is something that really gravitated to me and I found it to be very important to us as we go forward.

Freeholder Shin Angulo thanked Mayor McBride and the community members and said Happy Boss' Day yesterday to all of our Department Heads, the Freeholder Director, Lou Cappelli, Deputy Director Ed McDonnell, Ross Angilella – Happy Boss' Day. Thank you for all your hard work and commitment to Camden County. Construction is still going on throughout Camden County so please give yourself enough time to get from point A to point B.

Freeholder Kane thanked everyone for coming out and all that have stayed. As our NJ Teacher of the Year had pointed out earlier, this meeting is just filled with endless productivity. Just sitting here and listening to the accomplishments of so many it just shows you the power of what our residents and the County is capable of. I know the room is a little chilly tonight, but it gives me chills listening to what we have heard. It is just remarkable. I am very proud to be a resident of Camden County and a Freeholder. I would like to remind everyone that November 10th at 1:00 PM we will be holding our Veterans Day Ceremony at Veteran's Island and we will be honoring those who have served and who are currently serving.

Freeholder Rodriguez as Freeholder Kane said, we really do have amazing individuals in this County. So many outstanding accomplishments were celebrated today. Very impressive. I do want to stress as well the importance of the employees of Camden County. They really make a difference in our lives and in what we do. Last Wednesday we were at Camden County College for the Local Board of Health Summit. At the Summit we saw our Director, Ann Biondi, Sr. Donna, Caryelle Lasher who was presenting and did an amazing job, and Rachel Honrychs. They did such an amazing job, especially our two younger members who are up and rising leaders within our department. I would like to thank you for what you did last night. It was one of the most beautifully done Board of Health Summits that we have had in Camden County. We had over 100 people there learning about what the Board of Health does, what a Health Department is. I would be remiss if I did not mention that we have the best County College in the United States. We were ranked 3rd which is an amazing accomplishment. We also have an amazing Technical School. Two buildings that do really good work with kids, getting them skills and getting them jobs. We are very much leading the way. Tonight, we have our superintendent, Pat Fitzgerald, here. They are leading the way with programming and innovative programs, many of them in partnership with the College.

Deputy Director McDonnell asked that we all keep praying for Rick Taylor. We talked a lot about educators tonight and among all of the other great things about Rick, what a great public servant he was, what a great friend he was, he was also a great educator. He is going through a very rough time so any prayers going his way would be a great thing. Bernie, thank you for your comments. I am glad. I did not know that story. Thanks for all you do for the veterans of Camden County and what you did for the fabulous veterans' remembrance ceremony. To all of our employees in Camden County, thanks for all the great work you do every day.

Director Cappelli said it really was a great night. I think the best part of the night was Ross Angilella singing who let the dogs out. On behalf of my family I would like to thank the Board of Freeholders and all the employees who were involved in the education of the bocce court. It meant a lot to my family and it was a great morning and a great celebration of heritage here in

Camden County. Thanks once again. Freeholder Kane, you and everyone else involved in the Vietnam remembrance event, did a wonderful job. Thank you. The Director thanked the employees of Camden County for the great work they do day in and day out for our residents.

The Director asked for a motion to adjourn. Freeholder Young made a motion with a second by Freeholder Rodriguez and all Freeholders voted aye.

The meeting was adjourned at 8:42 p.m.
