## Work Completed Week of August 8, 2020

- Lexa placed concrete sidewalk, curb, and curb ramps along Chapel Avenue
- Techna-Pro installed PED push button foundations at intersection with Hanover Drive

### Summary of Work Completed Week of August 8, 2020

Lexa Concrete (Lexa) continued work along Chapel Avenue. Lexa placed concrete sidewalk, curb, and curb ramps on Chapel Ave at the intersection with Hanover Drive. At the same intersection, Techna-Pro installed PED push button foundations. Cherry Hill Township continued cherry tree trimming work on Chapel Avenue. Maintenance and Protection of Traffic (MPT) is set up before each work day and taken down at the end of each work shift. Flaggers are being utilized and continuously coordinated with the Cherry Hill Township Police Department. Uniformed Law Enforcement Officers are additionally utilized for traffic control. The project will continue as planned despite the current pandemic. The project is approximately 75% complete. An onsite progress meeting was held on August 4, 2020 to review all project related activities.

#### Anticipated Work for Week of August 15, 2020

Lexa will continue with preparation for paving operations on Chapel Ave. Daily traffic control will continue to be implemented for the duration of the project. A Pre-Paving Meeting is scheduled for August 11, 2020 to discuss the paving operations on Chapel Avenue.
