Work Completed Week of July 24, 2020:

- ➤ Contractor mobilized
- > Daily detour of traffic on Kresson Road
- ➤ Installation of storm drainage culvert pipe resumed July 20, 2020
- ➤ Installation of Manhole, 4' Diameter at Sta. 144+94
- Reconstruction of storm drainage inlet at Sta. 142+00 and Sta. 144+94
- Construction of 9" x 18" concrete vertical curb along with 8" HMA and topsoil

Quantities Week of July 24, 2020:

- ➤ Item C6- Reconstructed Inlet, Type B, Using New Casting- 2 UN
- ➤ Item C22- 15" Reinforced Concrete Pipe- 15 LF
- ➤ Item C23-18" Reinforced Concrete Pipe- 181 LF
- ➤ Item C51- Manhole, 4' Diameter- 1 UN

Summary of Work Completed Week of July 24, 2020:

The contractor mobilized on site and setup traffic control for a daily detour to allow construction to commence. Traffic police directors are on site assisting with traffic control daily. The installation and backfill of storm sewer work from Sta. 140+67 to Sta. 141+99 was completed. The installation and backfill of storm sewer work for lateral drainage at Sta. 144+94 was started. A field modification at Sta. 144+94 was needed as a 15" reinforced concrete pipe was used to fit under the existing gas main instead of the proposed 18" reinforced concrete pipe. Reconstruction of storm drainage inlet at Sta. 142+00 and Sta. 144+94 were completed. The installation of manhole, 4' diameter at Sta. 144+94 was completed. Installation of concrete vertical curb, addition of topsoil, and HMA application at Sta. 104+95 have begun. Contractor moved inlets at Sta. 113+39 and Sta. 117+03 back to meet new curb line. Contractor began connecting underdrains from McNaughton's Garden Center to storm drainage inlets.

Anticipated work for Week of July 31, 2020:

There will be a detour with one-way traffic setup daily. Traffic police directors are on site assisting with traffic control daily. Additional traffic police directors may be needed if multiple contractors are working on site, which will complicate the traffic control. Contractor will continue storm sewer work for lateral drainage at Sta. 144+94. Contractor will continue to lay concrete curb, apply HMA, and spread topsoil along WB Kresson Road.
