From Susan Quinn: "I've been meaning to drop a note to everyone as well about the Fallen *Tribute Towers visit. To sum it up in one word – WOW! Prior to County deciding on bringing the* towers, I didn't even know they existed! I thought the towers were a very moving tribute to all those that have lost their lives post 9-11 and the inclusion of the PTSD towers really added special meaning. Being able to see the photos of these men and women was very powerful and really brought it home. Very impressed with it. Although there wasn't much in the way of ceremonies due to COVID - the Press Event/Laying of Wreaths was nice - a wonderful tribute to our fallen heroes. The escort went well, kudos to all involved (CHPD, CHFD, Pennsauken PD, Motorcycles, etc). For those who may not have seen it, CHPD made a tremendous video with clips from the drones they were using that day. I was fortunate enough to arrange my schedule so that I could spend some time every day at Veterans Island – helping at assistance table, taking photos, readinglooking at all the men/women on the towers and did an overnight as well. The driver, Dave, a Marine, was a wealth of knowledge, friendly and a joy to be around. (we were able to make sure he got a little taste of "South Jersey" with visit to Mission BBQ, Donkeys Cheesesteaks, etc). A very memorable experience and a reminder of the sacrifices that are made for our freedom. Lest we ever forget."

Director Cappelli opened the meeting to any member of the public who wished to address the Board of Freeholders.

The Director said we had a few comments submitted. The first one is from **Dennis** Gormley of Voorhees thanking the Board for looking into the issue of the transport of fracked LGN through Camden County with all the attendant risks and dangers. He went on to say that he did make a clerical error regarding where the plant would be located. His letter said Gloucester Township, but he meant to say Gloucester County. The Director said, certainly this will not distract us from looking into this.

<u>Kathryn DeAngelo from Voorhees</u> also wrote in. She said, pursuant to issue that has been raised by the general public in the last two meetings with regards to the proposed LNG

facility on Camden County's doorstep in Gibbstown, the Board says it has been looking at it. As one of those concerned Camden County residents, I ask the Board to read in today's Philadelphia Inquirer what has been happening in PA with regard to the Mariner Pipeline and the lack of transparency with regards to safety protocols and procedures coming from the industry and state oversight agencies on what local first responders could do, might do, in the event of a catastrophe. How will residents be notified about an emergency? How do you even evacuate schools, nursing homes and other very vulnerable populations? Every county on Gloucester County's doorstep needs to create safety plans. These needs to be considered now, before anything moves forward. See how badly it being done in PA? See how people are left in the lurch? Will the Board be studying this issue? The Director said Ms. DeAngelo provided a link to the article which we will read.

Kate Delaney sent in the following: At the recent public opening and reading of county solid waste disposal contracts, I was told that there would be a resolution approving a county solid waste disposal contract on this month's Freeholder agenda. Is there a reason it isn't being voted on this month, as planned? When will this resolution for solid waste disposal be voted on by the Freeholder Board? Chris Orlando responded that it is currently under review and we anticipate the Board listing it on the November Agenda.

Lorraine Devine of Haddonfield. As a resident of Camden County, I have grave concerns about the risks posed by the proposed Gibbstown Logistics Center/port. I understand that the Delaware River Partners has filed legal action maintaining that that FERC does not have jurisdiction to address issues presented by this project. As a result, I think the Camden County Freeholders must take action to prevent or prohibit the project – unless and until the serious safety risks that the project poses to the people of Camden County and what, if any, measures can be taken to eliminate that risk have been more carefully studied. This "Center" would store and transport highly toxic and flammable natural gas liquids from fracking brought by freight trains. The storage and transportation of these gases present significant risk of spillage, seepage into our water source, and explosions. Given the serious risk to the citizens and homes of Camden County, the Freeholders should address the matter. At least to ensure that all necessary safety measures have been complied with. This site is already still being cleaned up for toxic contamination of groundwater from Dupont's use of the property. Let's learn from the mistakes of the past. It would be better, and more economical in the long run, to assess, plan and address serious safety risks being imposed on Camden County citizens rather than cleaning up the mess, and possibly mourning lives lost, after the fact. Freeholder Nash said the public expressing its concern about this project is correct. I am very concerned about it as well as I know my colleagues are. In order to properly address this, we are reaching out to the Department of Environmental Protection in the State of New Jersey and the Delaware River Basin Commission, which are two very integral parts of this project, to answer the questions that the public has raised and to let us know if our community is at risk as suggested by these comments. We are concerned about this and we want full answers to these questions before we make a definitive decision whether to support or oppose the project or to stay neutral on it. We need the experts to answer those questions.

Seeing no other members of the public wishing to comment, Director Cappelli asked for a motion to close the public hearing. Freeholder Young made a motion with a second by Freeholder Nash and all Freeholders voted aye.

The Director opened the floor to the members of the Board of Freeholders for their comments.

Freeholder Nash said I had the pleasure of meeting two members of the Health Department at the COVID update and they described for me the work they are doing both for the flu shot program, which has been very well received, and with respect to the pandemic. The flu shot numbers are extraordinary, as you might expect. I also met an employee who heads up the contact tracing operation and she described an amazing effort by these unsung heroes who are doing the contact tracing – which everyone knows is a critical component to tamping down the pandemic. I want to thank everyone involved in that effort for their work.

Secondly, we got great news yesterday. The NCAA has awarded Camden County and the Cooper River the NCAA women's rowing championships, which is quite an honor. The nation's eyes will be on the Boathouse and Cooper River in 2023. There will be thousands of people coming here. The economic impact will be extremely positive. My compliments to everyone who was involved in submitting that bid. It was very well received by the NCAA and we are very pleased by that.

Freeholder Young said congratulations to Freeholder Nash. It is a great honor. Anytime we can continue to show off our parks to the nation is good stuff. Today at 1:30 we have a COVID update on Facebook Live. There are some CARES Act money left over for our renters and our small businesses. Go to our website to apply. Food insecurity continues throughout Camden County. Tomorrow we will be in Parkview at Collingswood Apartments, located at 700 Browning Road in Collingswood at 10:30 a.m. First come first serve. This is a walk-up only site due to the logistics. Congratulations to Touch NJ for their honor from Philabundance. They received the highest award, called the Hunger Hero Award. Since we have partnered with Touch NJ during this pandemic they have distributed over 900,000 pounds of food just in Camden County. It has been a really good partnership with them.

As we come towards the beginning of the year, we are planning our first major awards ceremony, which is the MLK Freedom Awards. Starting on Monday you can go to our website and fill out an application to nominate someone for that prestigious award.

Freeholder Young thanked the County employees for doing a great job, as well as the Director and Ross for their leadership.

Freeholder Kane made note that this year Veterans Day is Wednesday, November 11. Unfortunately, we will not be able to have our ceremony so we will be hosting a virtual Veterans Day ceremony. It will be a medal ceremony in conjunction with Jefferson Health System. I want to thank the various organizations who are involved with this, Jefferson Health System, Samaritan Hospice, Jewish Family & Children's Service, the Jewish War Veterans and various military Veteran organizations within our community. That ceremony will be available on the Camden County website prior to Veterans Day. I also wanted to thank Sue Quinn for her correspondence regarding the Fallen Tribute Towers and also to make note that in Cherry Hill, the American Legion Post 372, which is behind Cherry Hill West, will be hosting the Towers on November 6 through the 11th. For anyone who did not have the opportunity to see the Towers on Veterans Island, they will be available to view again.

Finally, I want to thank the Camden County Office of Veterans Affairs for their continual hard work and dedication to the almost 30,000 veterans within Camden County and their families. Those in the office work diligently to make sure the needs of our veterans are serviced and serviced very well.

Freeholder Rodriguez thanked the Health Department. She said we have a very skilled and highly talented Health Department who has been able to, with very minimal resources, make a difference in this pandemic. We are ready if a vaccine comes through. Freeholder Rodriguez said I have to acknowledge all the people on the ground for their amazing work as well as the staff at the Department of Children's Services and the Board of Social Services because they have also been a critical part of dealing with COVID. We know we have children who require childcare and that has been very challenging. They pulled through to make sure the emergency personnel have the daycare that they need. We are now expanding our programming. Same thing with the Board of Social Services. They have managed to keep up with their programs despite all the challenges that they have faced.

I am very excited because I received a call from our local coordinator for the Census. He said between self-reporting and enumerators, we have covered the entire City of Camden and surrounding areas. We have basically 100% coverage between self-reporting, which is ideal, and the enumerators. We encourage people to self-report because we know those numbers are much more accurate than an enumerator coming to your home. 2020Census.gov is the website and you have until October 16th at 6 AM which is the unfortunate situation we have due to the Supreme Court ruling.

Finally, one thing we have not been able to do because of COVID is recognize Hispanic Heritage Month which we normally do with a dinner recognizing individuals who have contributed greatly to the Hispanic community here in the city. Today is the end of Hispanic Heritage Month because is runs from mid-September to mid-October. I do want to recognize all those individuals in the past who have done so much good and a lot of the unsung heroes that we have because there are people in the community who have not been recognized but have contributed greatly to the success of members of the Hispanic community and the integration of those individuals.

Freeholder Holcomb said, as Freeholder Nash and Freeholder Rodriguez mentioned it is flu shot seasons. Over the last 10 days or so I have had a chance to visit a few of our drive-through flu sites and I have to tell you that I am really impressed at how well they are coordinated with the level of safety precautions that are taking place, particularly in light of our current pandemic. I want to give a shout out and a thank you to our Health Department and Senior Services and to all of the employees and volunteers who are participating and making our drive-throughs a success and also to those who will continue to volunteer between now and the end of the flu shot season which ends on November 24th,

Freeholder Holcomb said, while I certainly did not play, I did have the opportunity to participate in the awards ceremony for this year's Public Works and Employee Connections charity golf outing. As you all know, this event raises money for the distribution of food baskets so that families across our County can have a blessed and bountiful Thanksgiving. Deputy County Administrator Vesper always does a nice job with the coordination of this event and this year certainly was no different even though we had to follow social distancing guidelines. I am told with the funds we raised we should be able to distribute in excess of 400 baskets. That will

certainly be a blessing to the many Camden County families who will be receiving them. I wanted to just say a nice job to Dominic.

Deputy Director McDonnell said I would like to urge all our residents of Camden County to take a look at the communication that was sent out from the County government today. It went out in press release form and in email form and it lists all the many activities that have been carried out by the County government in support of all our residents during this terrible COVID experience. The reason I wanted to highlight that particularly is because it really is a way of acknowledging the great work that so many of our employees have done so diligently for such a long time. This has been going on so long now that you would think the patience and the enthusiasm of our employees would diminish but it has not at all. Congratulations to all the employees who every single day work to make sure that our residents have all that they need to survive the pandemic.

Director Cappelli said I echo those comments and thoughts.

The Director asked for a motion to adjourn. Freeholder Young made a motion with a second by Freeholder Holcomb and all Freeholders voted aye.

The meeting was adjourned at 12:32 p.m.
