RESOLUTION # 26 OF 2019

Whereas the Municipal Tax Assessor is required to file the Added and Omitted tax lists with the County Board of Taxation on or before October 1 of the tax year;

Whereas the Camden County Board of Taxation certifies the Added and Omitted tax lists as representative of a complete record of the taxes assessed for new construction, exempt to ratable property, return of abated assessment, farmland rollbacks and any omitted property not on the tax list in the districts within Camden County; now therefore, be it
