RESOLUTION # 23 OF 2019

Whereas according to N.J.S.A 54:4-52, the county tax administrator calculates the tax rates when all the applicable budgets for that municipality are certified and transmitted to the board. However, the Board shall take appropriate action to certify the general tax rate for each municipality. The abstract of ratables is completed when all municipalities in the county have certified rates;

Whereas the county tax administrator has calculated tax rates on all certified budgets that have been transmitted to the board;

Whereas the Borough of Tavistock (sending district to Haddonfield School) received an adjusted certified budget after prior certification;

Whereas a "revised" certified A4F form has been re-submitted by the School Board of Haddonfield (receiving district of Tavistock students) and that amount differs from the prior certification now therefore, be it

Resolved, that the Camden County Board of Taxation does hereby amend and certify the school and general tax rates for the Borough of Tavistock the adjusted budget has been used and the revised tax rates have been so calculated by the tax administrator.
