The Bond Ordinance published herewith was introduced and approved upon first reading at a meeting of the Board of Commissioners of the County of Camden, New Jersey, held on April 22, 2021 in the City of Camden. It will be further considered for final passage after PUBLIC HEARING thereon at a meeting of said Board of Commissioners to be held virtually on May 20, 2021 at 12:00 noon, at the Camden County Courthouse, 520 Market Street, Camden, New Jersey. Due to the current State of Emergency and Public Health Emergency declared by Governor Phil Murphy pursuant to Executive Order and in an effort to prevent the further spread of COVID-19, the general public will be excluded from attending the Public Hearing in person. BOND ORDINANCE AMENDING A BOND ORDINANCE FINALLY ADOPTED JUNE 15, 2017, BY THE COUNTY OF CAMDEN, STATE OF NEW JERSEY, IN ORDER TO PROVIDE FOR A CHANGE IN THE IMPROVEMENTS AUTHORIZED BY SUCH ORDINANCE

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF CAMDEN, NEW JERSEY (not less than two-thirds of all the members thereof affirmatively concurring), AS FOLLOWS:

Section 1. Exhibit A which is referenced in Section 3(a) of a bond ordinance finally adopted on June 15, 2017 (the "Original Ordinance") entitled "**BOND ORDINANCE OF THE COUNTY OF CAMDEN, NEW JERSEY APPROPRIATING \$12,375,000 FOR THE REPAIR AND/OR REPLACEMENT OF CERTAIN COUNTY INFRASTRUCTURE PROJECTS IN ACCORDANCE WITH THE PROVISIONS OF N.J.S.A. 40:14B-40.2 AND AUTHORIZING THE ISSUANCE OF \$11,756,225 BONDS OR NOTES OF THE COUNTY FOR FINANCING PART OF SUCH APPROPRIATION**" of the County of Camden, New Jersey (the "County"), and attached thereto, is amended to read in its entirety as set forth in Exhibit A attached hereto.

Section 2. All other details of the Original Ordinance shall remain the same.

Section 3. This bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by the Local Bond Law.
