- To acquire owner, mailing address or deed book and page information, you must complete a request and sign a confirmation that you have received and read a copy of “Daniel’s Law P.L.2020 c.125”.
- Requestor has a right to challenge and appeal any denial of this request. Appeal instructions will be provided with such denial.
