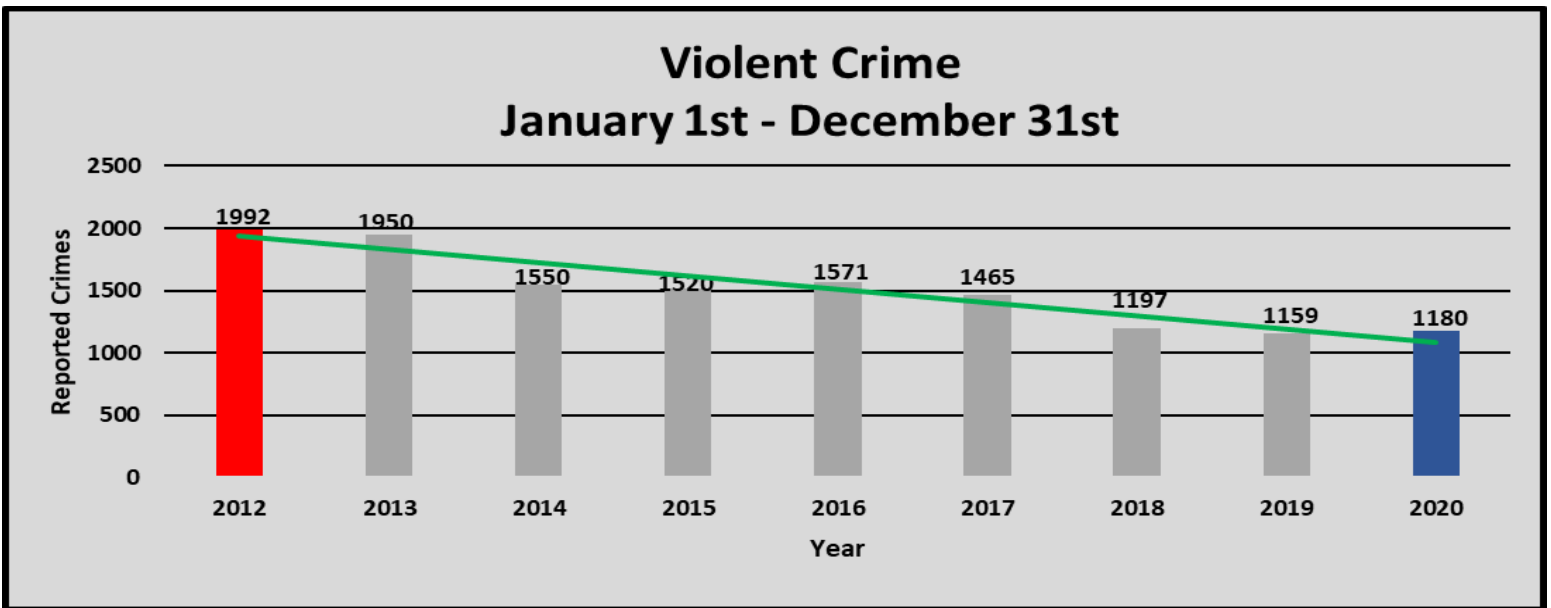

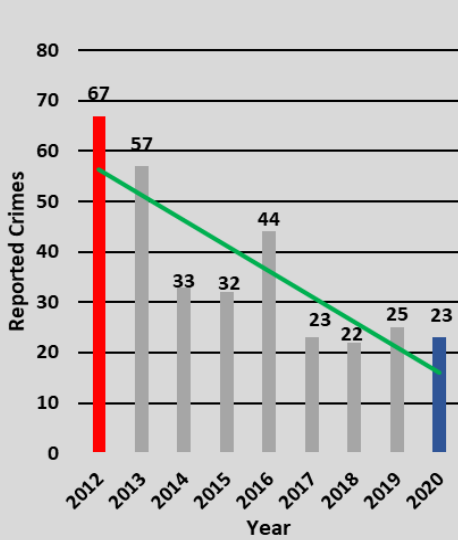

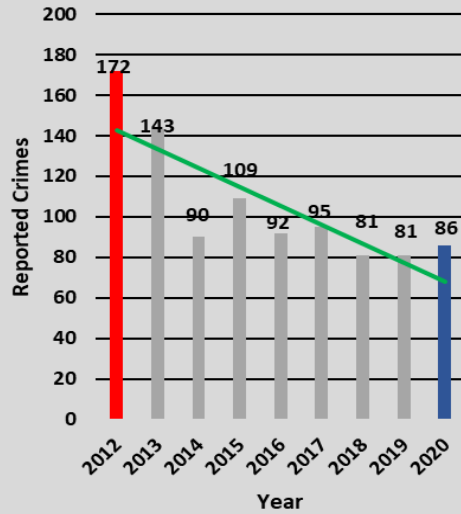

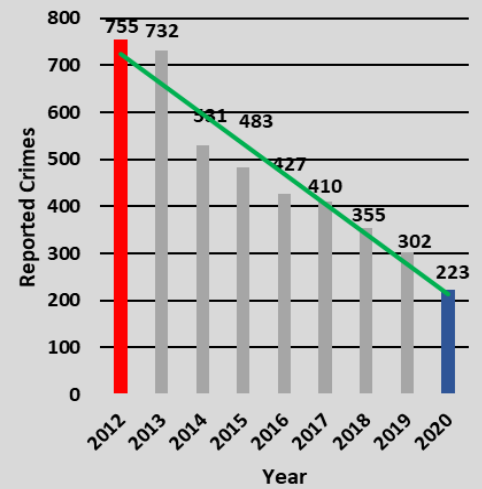
Murder January 1st - December 31st



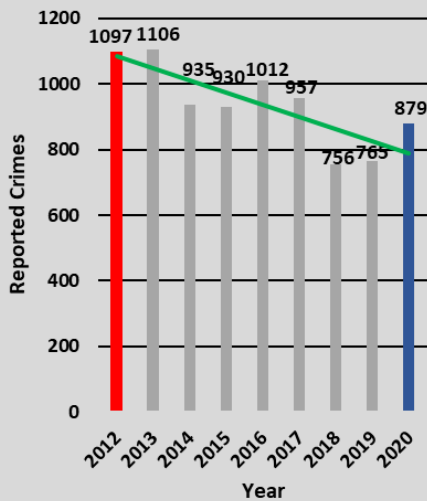
Non-Fatal Shooting Incidents January 1st - December 31st



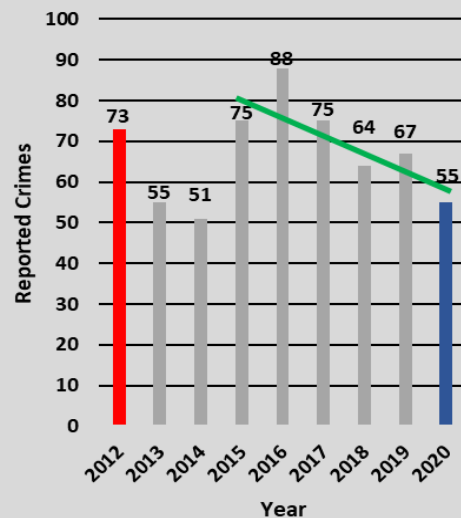
Robberies January 1st - December 31st



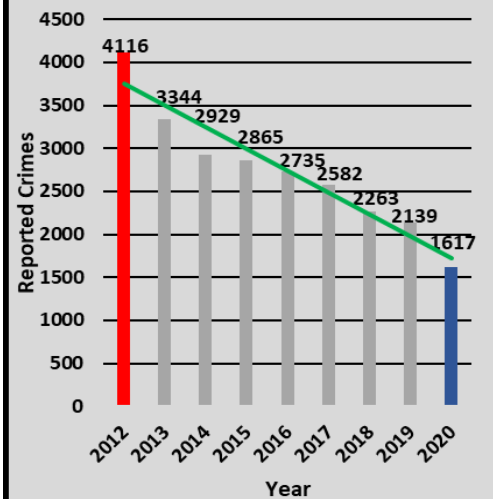
Aggravated Assault January 1st - December 31st

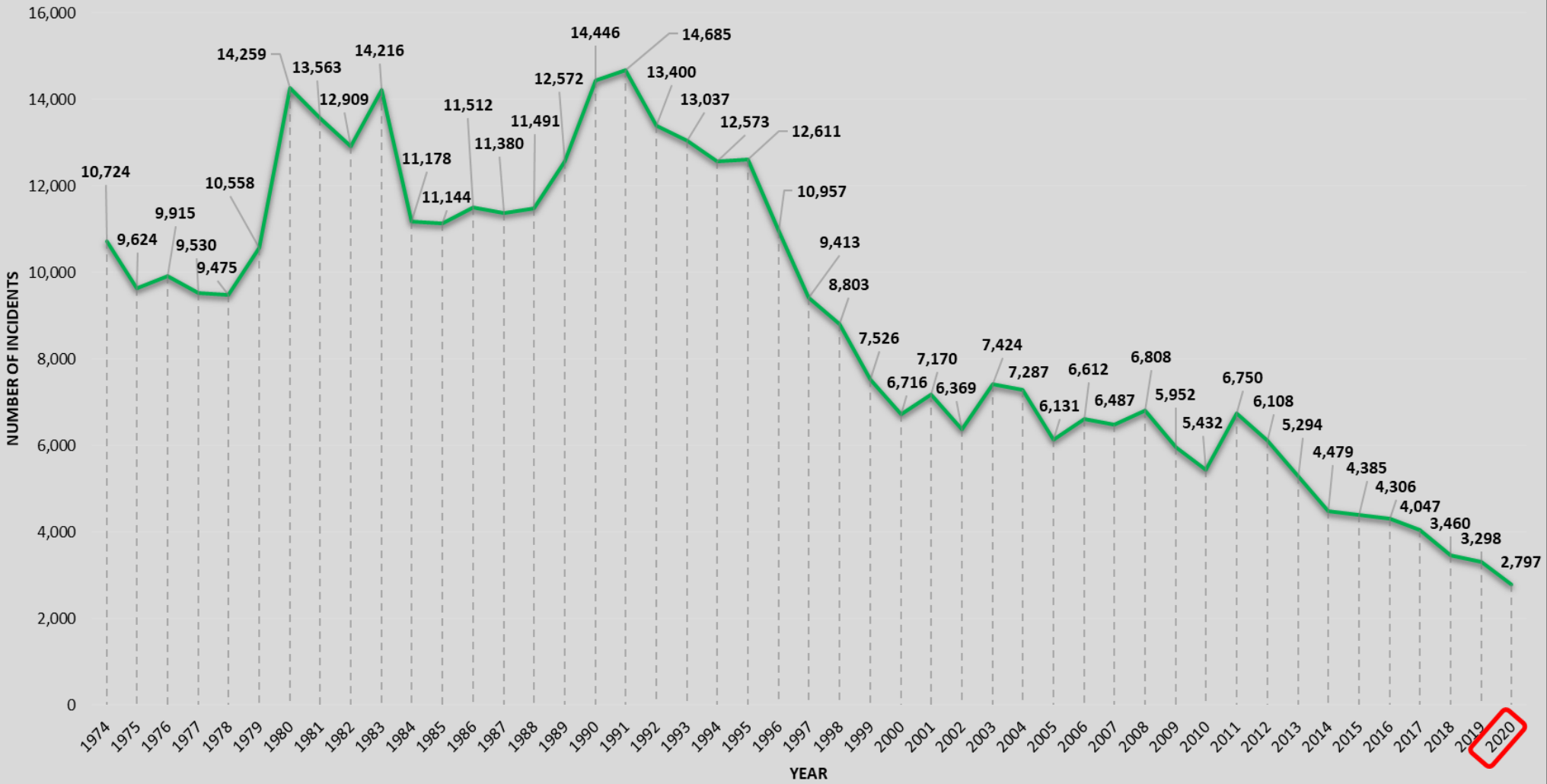
Property Crime January 1st - December 31st

Total Crimes CY 1974 - CY 2020

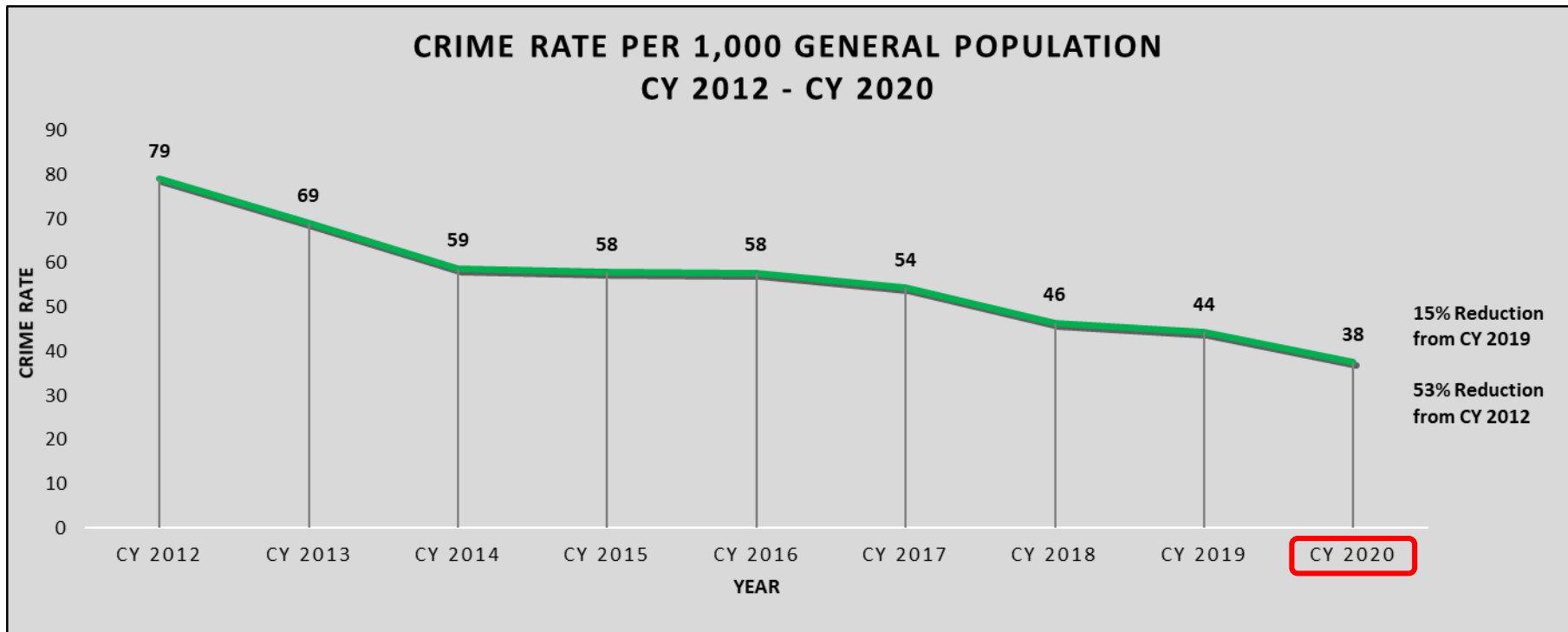
