Director Cappelli called the meeting to order at 12:00 p.m. and the following Commissioners answered to their name:

The Director said this meeting has been properly advertised in accordance with the Open Public Meetings Act.

Following the Pledge of Allegiance, which was led by Commissioner Kane, the Director proceeded with the Caucus Agenda.

The Director said we will have three First Readings on Bond Ordinances at Thursday's Commissioners' meeting. Public Hearings on all three Bond Ordinances will be held on August 19, 2021 at 12 noon at the Camden County Courthouse, 520 Market Street, 6th Floor Meeting Room, Camden.

First Reading Bond Ordinance #1

Amending a Bond Ordinance finally adopted June 15, 2017, by the County of Camden, State of New Jersey, in order to provide for a further change in the improvements authorized by such Ordinance.

First Reading Bond Ordinance #2

Bond Ordinance amending a Bond Ordinance finally adopted July 16, 2020, by the County of Camden, State of New Jersey, in order to provide for a change in the improvements authorized by such Ordinance.

First Reading Bond Ordinance #3

Bond Ordinance of the County of Camden, New Jersey appropriating \$25,940,000 for the repair and/or replacement of certain County Infrastructure Projects in accordance with the provisions of N.J.S.A. 40:14B-

40.2 and authorizing the issuance of \$24,643,000 bonds or notes of the County for financing part of such appropriation.

The Director called upon each Commissioner individually to present his or her Resolutions.

Resolutions and discussion of proposed Resolutions by or on behalf of Commissioner Dyer
