The meeting was called to order by Director Cappelli at 12:00 p.m.

The Director stated that adequate notice of this meeting has been provided in accordance with the Open Public Meetings Act.

The Director asked everyone to rise for the Pledge of Allegiance.

The Director said good afternoon ladies and gentlemen. Welcome to the meeting of the Camden County Board of Commissioners. We will have two (2) Public Hearings this afternoon.

PUBLIC HEARING #1

Resolution of the Board of County Commissioners of the County of Camden, New Jersey Providing the County's Consent to (i) the refunding of certain outstanding County Guaranteed Loan Revenue Bonds of the Camden County Improvement Authority originally issued to finance and/or refinance the acquisition, construction, renovation or installation of certain Capital Projects of the County; (ii) the issuance by the Authority of a series of its "County Guaranteed Loan Revenue Refunding Bonds (County Capital Program), Series 2021B" for the purposes of refunding such outstanding County Guaranteed Loan Revenue Bonds; (iii) the Loan And Security Agreement by and between the County and the Authority in connection with the refinancing authorized hereby; and (iv) certain other matters related thereto and pursuant to N.J.S.A. 40:37A-56.

Director Cappelli opened the public hearing to anyone who would like to comment. Receiving no comments, the Director asked for a motion to close the public hearing. Commissioner Rodriguez made a motion with a second by Commissioner Nash and on roll call all Commissioners present voted aye.

Director Cappelli asked for a motion to adopt the Resolution. Commissioner Nash made a motion with a second by Commissioner Rodriguez and all Commissioners present voted aye.

COMPTROLLER'S REPORT

The Director asked for a motion to adopt the Comptroller's Report. Deputy Director McDonnell made a motion with a second by Commissioner Nash and on roll call all Commissioners present voted aye.

CORRESPONDENCE

The Director asked the Clerk if there was any correspondence. The Clerk responded that there was not any correspondence this month.

The Director said the next portion of the meeting is open to the public for discussion of resolutions to be acted upon this afternoon. There will be another public hearing later in the meeting at which members of the public can ask any questions they want regarding the business of the County of Camden. This portion is limited to the discussion of those resolutions to be acted upon. The Director opened the public hearing.

Susan Drunkenrod, 162 Valley Run Drive, Cherry Hill asked a question regarding Resolution No. 20 prohibiting wildlife feeding on property owned and operated by Camden County, New Jersey. Question: Please explain the resolution. How will you prohibit ducks and deer from feeding on County land? Director Cappelli said we are not preventing them from feeding on County land. We are trying to prevent people from feeding wildlife on County land. Ms. Drunkenrod said I was concerned if you were going to take measures against the wildlife or if this directed towards the people. Director Cappelli said this is directed solely towards people.

Kate Delany, 126 E Palmer Avenue, Collingswood asked the following questions regarding the Resolution rejecting Bid A-32/2021 Extradition Services for the Camden County Sheriff's Department. Question – I would like more information about the county's extradition services. Who does the county usually contract with? Where could I find the written copy of the county's extradition process? Does the county use a private extradition service? Does the county engage in competitive bidding? What processes are in place to make sure that the extradition company safely transports prisoners? Director Cappelli responded we have competitive bidding, and it is through the Sheriff's Department. All extradition is in accordance with State law.

Susan Drunkenrod, 162 Valley Run Drive, Cherry Hill said I had asked in July about the supermarkets in Camden and am wondering if there is any movement to bring supermarkets back to Camden. Director Cappelli responded this is an issue that has concerned all of us. We are now working very closely with the City of Camden and with Copper's Ferry and reaching out directly to supermarket owners and operators to try to attract them to come to Camden City. Will you be able to use any of the economic development money to sweeten that deal? If the project qualifies under any of the programs made available through the State, County or Federal government we will use those tools to try to entice supermarkets to locate her in Camden City. Have you thought about setting a goal, such as we would like to have a supermarket in 6 months, in 12 months? Director Cappelli said we would like to have a supermarket yesterday, but the problem is that we have to rely on the private sector to make the investment in the City. Ms. Drunkenrod said I encourage you to use the monies that you have available to make it happen. Director Cappelli said we are going to use every tool in our toolbox.

Hearing no further members of the public wishing to comment, the Director asked for a motion to close the public hearing. Commissioner Nash made the motion with a second by Commissioner Rodriguez and all Commissioners present voted aye.

The Director closed the public hearing.

NO MOTION MADE – FAILED

Director Cappelli opened the meeting to any member of the public who wished to address the Board of Commissioners.

Garren Steiner, 439 King Avenue, Apartment G-3, Collingswood, NJ. Question: You list the allocation of ARPA Funds for 7 distinct categories, none of which are hazard pay for the County's Employees. What is the rationale for the County not to use some of the hundreds of millions received and compensate those employees who have worked since start of the pandemic, putting theirs and their families lives at risk.? Director Cappelli responded we certainly do appreciate all the great work that our employees have done and continue to do throughout this pandemic, month after month. They were the shining star in the State of New Jersey in providing services to our residents and did a tremendous job. In terms of what we did, we made it is flexible as possible for all our employees to continue working during the pandemic. There were no layoffs. There was great flexibility in being able to work from home. We also made testing and vaccination available to our employees and hopefully our employees took advantage of those things we offered. The Board has not at this time decided to consider what you are calling "hazard pay". Everyone has been paid according to the contracts and we made sure we did not hurt anyone during the pandemic. Now we have a lot of the private sector that is in need of funds to protect jobs. We also have residential tenants who are in need of funds in order to avoid being evicted from where they are living. We have a tremendous amount of need for the funds that have been allocated.

Kate Delany, 126 E. Palmer Avenue, Collingswood, NJ 08108. Question #1 has to do with the Contract for solid waste disposal for the County. I know around this time last year there was a one-year contract with Covanta. Since that was a one-year contract I was wondering what the plan was for solid waste disposal. Commissioner Nash responded that it is complicated because several of the towns have gone out to bid on their own, including Cherry Hill, Gloucester Township and Winslow Township. That takes a sizable amount of the trash from the group, so we are exploring at this time whether the remaining towns will go out to bid or accept the secondyear option on the existing contract. Ms. Delaney asked what the timeline on that decision is. Commissioner Nash said the decision must be made in the next 30 days. There is a coalition of the municipalities that get together and they work with Brian Constantino, the Director of Solid Waste and some of the representatives of some of those towns. The greatest concern, as you are aware, is that the incinerator does not have the state-of-the-art environmental protection equipment that we would like to see and we have encouraged Covanta to make that investment. Secondly, we are concerned that the smaller towns need a place to take its trash at a reasonable cost. We are trying to sort through those issues and hopefully within the next 30 days the municipalities will have made a decision.

Question #2 I know there was an issue with toxic dumping in the Bergen Square neighborhood of Camden and was wondering what is going on to address that, to test residents who might have exposed, test air filtration systems that can monitor air quality in the neighborhood? Commissioner Nash said the State of New Jersey, to their credit, DEP and the Commissioner were down with the State Attorney General and have made it very clear that they are going to actively pursue the owners of that mound of toxic dirt and have made arrangements to have it safely removed from that site. I do not know if the State is testing residents for that. I know that such testing would be available through the DEP. I could find out for you if you would like. Ms. Delaney said, if the State wasn't able to do the testing would that be the County Commissioners' purview to take action on that? Commissioner Nash said the County would not

test individuals. DCA Vesper added unless the State Health Department directs our County Health Officer to do that and that has not happened at this time.

Ms. Delaney said my final thought is I think it is important to go through the Agenda. The Commissioners control a giant budget so I would appreciate not having all those items passed on a giant block without hearing you present them.

Rhyan Grech, 17 Pemberton Road, Southampton, NJ Question: There has been a vacancy on the NJ Pinelands Commission. The representative from Camden County, Jordan Howell, resigned last month. I was hoping to get some information about the process that the Commissioners will go through to choose a new representative. The County webpage states an application deadline of November 2017 so that is obviously out of date and referring to the last time there was a vacancy. I was hoping to get an update on that process and ask what opportunity will the public have to give feedback on candidates before the County Commissioners make their appointment? Commissioner Nash said thank you for your interest and thank you for your work in the Pinelands. In terms of environmental priorities, it is certainly on the top of our list. I live in the Pinelands so I know how important it is to preserve the Pinelands. Having said that, I spoke with Dr. Howell about two months ago and he advised me that he was intending to resign but I have not received his resignation letter. I also appreciate you telling me he has resigned from that Commission. We will update the website and seek applications from people who are interested. We will also reach out to the mayors who represent towns within the Pinelands, such as Winslow and Waterford and that would be important to us as well. At the end of the day, hopefully we will find somebody as qualified as Dr. Howell to represent our interests. How you can be involved? If you have people that you know, they must live in Camden County and not have a conflict in any way with the Pinelands Commission. If you have a person with that objectivity and expertise who lives in Camden County, we would welcome receipt of that. I will speak with our County IT folks to make sure the website is updated.

Seeing no other members of the public wishing to comment, Director Cappelli asked for a motion to close the public hearing. Commissioner Nash made a motion with a second by Commissioner Rodriguez and all Commissioners voted aye.

The Director opened the floor to the members of the Board of Commissioners for their comments.

Commissioner Nash said I would like to compliment the County Administrator and his team on doing a great job everyday but in particular with the money that has been allocated by the Federal Government through the American Rescue Plan. Commissioner Nash made special mention of David McPeak's contribution to the process.

Commissioner Nash welcomed Eme back to the home team. Eme obviously was with County Counsel for several years and went to Cherry Hill Township where she did an outstanding job but when this opportunity became available, I was thrilled that she wanted to come back. She is an outstanding attorney and the County is going to be very well served.

Commissioner Nash said I do want to express my condolences to the family of Madeline Dolance. I missed Caucus on Tuesday because I was at the funeral for Madeline who was my first

Aide when I was first elected to this Board thirty years ago. For ten years Madeline was my Aide. I was young and I thought I knew everything. She told me on day one, "trust me, you are going to need me", and she was 100% correct. She raised not only me as a young official, but people like Dom Vesper, who was an intern at the time, and maybe Holly. She was a mentor, a teacher and to me a second mother. Her passing was very sad, but she is in a better place now. Her very large family from Gloucester City, the Holy City as she called it, were present and it was a wonderful tribute to an amazing woman.

Commissioner Rodriguez said I want to thank all our employees who make this job worthwhile. You always focus on our residents in doing what's right for the community at large. I am grateful for all the Commissioners who support this initiative, always keeping the residents first. We need to protect our children and make sure they are safe. We need to understand that as parents, when we go out, we bring home whatever we encounter so our children are now exposed by us. Keeping that in mind is important to protect our children whether you are vaccinated or not. You can carry pathogens with you and expose others to it. Thank you to the Health Department for going a great job in getting a large number of residents in Camden County vaccinated. It is probably the one thing that has helped us and helped the hospitals so we can continue to take care of our residents. Be mindful that we still have a battle going on. It is still going to be a couple of months, at least, depending on what boosters come out or what potential variants could come out.

Commissioner Dyer said I would like to commend the Department of Public Works for everything they have been doing this summer. I meet with the team monthly so I can get updates on projects and stay informed. There are some completed projects, projects still under construction and also projects beginning. The Haddonfield-Sorrell Road project is nearing completion and paving on Evesham Road in Voorhees is completed as well. Under construction we have Lower Landing Road in Gloucester Township and the widening of Cross Keys Road in Winslow Township, Berlin and Pine Hill is on-going as well as Park Avenue in Pennsauken, Centre Street in Merchantville and the Kaighn Avenue Dam. Beginning phase projects include the Somerdale Road Bridge, Evesham Road between Route 30 and Burnt Mill Road, and the South Park and Cuthbert traffic signal improvement project. In closing a good friend of mine has always attended the Hope Memorial in Timber Creek Park. This year was my first year attending. This young lady had three family members who she lost. We spoke on the phone about it and she wanted to give the County event folks a big shout out and I agree with her. It was somber and sad but it was good to allow people to remember their loved ones.

Deputy Director McDonnell said congratulations to Commissioner Nash. We concluded our summer concert series and it was a spectacular success. We had so much positive feedback from residents who had missed the concerts last year and really enjoyed them this year. Deputy Director McDonnell welcomed Eme Arzon back and said we are glad to have her as County Counsel. He thanked all the County employees for the great work they do every day. He also thanked Director Cappelli and said throughout the pandemic and all the difficulties and all the loss of revenue the County experienced, we did not lay off a single County employee through the entre pandemic. I know the employees appreciate that. We know that was not true everywhere. Many municipalities and counties around the State did have to lay off employees but thanks to you we made sure we did not do that in Camden County. Again, I know our employees appreciate that and we appreciate our employees for all they do for us and the citizens of Camden County every

day.

Director Cappelli said thank you Deputy Director. They are kind words but everyone in this room deserves the credit because we all work together to make sure, including our County leadership, that no one was laid off and at the same time that our residents received the services they required. We are not over this yet. We still have this Delta variant so please be careful. We will be making some announcements in the near future about our plan moving forward with the pandemic.

Director Cappelli said I would like to publicly congratulate my Aide, Digna Townsend, who was recognized by S.J. Magazine as a Woman of Excellence. I can confirm she is excellent. She has been an excellent Aide and does great work. It was a really nice night. Digna, I am so happy for you. It is certainly a well-deserved recognition.

Director Cappelli said the concerts this year were phenomenal. The parks never looked better. Commissioner Nash, tremendous job. Unbelievable crowds all summer. We will be starting concerts at the Scottish Rite soon for our winter concerts, in consultation with our Health Department. Commissioner Kane did a great job with the 9/11Remembrance. Another great job for the Opioid Addiction Overdose Awareness event. Everyone did a great job. Just tremendous work by all of our employees.

Thank you to all our employees in Camden County for the hard work they do day in and day out on behalf of our residents.

The Director asked for a motion to adjourn. Commissioner Rodriguez made a motion with a second by Commission Nash and all Commissioners voted aye.

The meeting was adjourned at 12:35 p.m.
