#### **RESOLUTION 140**

#### **NO MOTION MADE – FAILED**

Director Cappelli opened the meeting to any member of the public who wished to address the Board of Commissioners.

**Rhyan Grech, Pinelands Preservation Alliance**. Q: *Will the Board of Commissioners be considering a nomination or appointment to the Pinelands Commission. If not today, when might we expect for the Board to take that action.* Commissioner Nash said thank you Rhyan for your call. I did receive your letters of recommendation. I met with the candidate that you had recommended, and I was enormously impressed. We will make the final recommendation for Board consideration at the January meeting.

Galen Giosa, Berlin. Thank you for allowing me to speak and attend today and thank you for your service. A quick question on some of the resolutions, specifically under Commissioner Young. Can I get a total for Resolutions 68 through 91 to see if my total matches yours? I am coming up with a little over \$5 million. Is that correct? Commissioner Young said I do not dispute the math. Is there a reason for the question? Mr. Giosa replied, I was trying to see how much was being spent today. So that is correct? A little over \$5 million for Public Safety? Commissioner Young said Resolutions 68 through 91 are not all Public Safety resolutions. Mr. Giosa said I apologize. I will specify Resolutions 68 through 91. Director Cappelli said I am looking at a resolution that is \$511,000 for Human Services, another one for software, and a transportation plan. Mr. Giosa said I am not trying to cause any problems I just want to make sure that everything went through. I did not catch when you guys voted earlier. Director Cappelli stated, that is correct. They were all approved. Happy Holidays.

<u>William Schneider, Brigantine</u>. I have a rental duplex in Haddonfield and that is what I am here for. I have been speaking with Commissioner Nash and a few other people he has forwarded me to regarding the Rental Assistance Program. I understand it is now under consideration for revamping to some degree and I would like to bring to the Board's attention the lack of cooperation that some of the tenants are doing. In my case, which I think is probably typical, it is required that the tenant file for the Rental Assistance Program leaving the landlord without rent. Currently tenants cannot be brought into an eviction hearing because of the number of evictions that are trying to be heard in Landlord Tenant Court. I have spoken with a court

representative and have been told they are at least 9 months behind. That means before you can even get to an eviction hearing the landlord has to wait 9 months of a tenant not paying the rent. I think the misperception of the purpose of the Rental Assistance Program is that all tenants have some huge motive to file for the County Rental Assistance Program. There is a State Rental Assistance Program, and this is also true in Pennsylvania and New York, and in all three cases, including New Jersey, the landlord can file. In the County, the landlord can't file and again there doesn't really seem to be a motive for the tenant to file if in fact they know that evictions are months off. The downstream problem is that months of unpaid rents are going to be lost and is it going to be probably impossible for the tenants to catch up. If the tenant doesn't have a motive to file for the assistance now, months down the road when they finally get an eviction and the eviction is successful for the benefit of the landlord, there is probably not going to be any way for the tenant to pay the back rent. If they Rental Assistance Program allowed the landlord to file and allowed the purpose of the program to be for the back rent and of course take the need of the tenant into consideration, then the program would be much more successful. Director Cappelli said we are aware of your frustrations, Sir. With regard to the tenant eviction process, that is State law and we have nothing to do with that. As of January 1, 2022 you can file for eviction and there is going to be a special effort by the Courts to move as many cases as possible. With regard to our program, the person who oversees that is Anthony Bianco who is here this afternoon.

Mr. Angilella reported that we have been working with Mr. Schneider. We are aware of Mr. Schneider's issue and have a great deal of sympathy for him because his tenant has been nonresponsive. Anthony reached her once and she hung up on him. We have not been able to reach her since. You are not barred from suing the tenant, you just can't evict the tenant. Mr. Angilella advised Mr. Schneider to get a lawyer and sue the tenant for back rent. You can't evict her until the end of the moratorium which is at the end of this year. You have asked us to change the law, we can't do that. You have asked us to use our "influence" with the Courts to get more mediators to hear these cases faster. I have spoken to the Assignment Judge. That is an AOC matter. We will continue to try to reach this tenant in order to explain to her that applying for this program does not hurt her, it is not income imputed to her. All she is doing is helping the landlord, as she should. That is where we are at. Mr. Schneider said I understand that. I am not asking the Board to consider changing any law. The issue that I am bringing in front of you today is about the Rental Assistance Program guidelines. Currently only the tenant can file for assistance and apparently the primary goal is, if they are in need, to help them pay the back rent. My suggestion and recommendation is to allow the landlord to file for the program and that the basis of the program be not only need, but the requirement that it be shown that the rent is in arrears rather than just the need of the tenant. The landlord's needs need to be addressed as well. Mr. Angilella said, Mr. Schneider we absolutely understand your point and, frankly, I agree with it. We do not set the regulations or the law that currently says that the tenant has to apply for this. I think that is a bad part of the law. I think that you, as the landlord, should be able to apply. I think the reason that they do that is because when the tenant applies they go through some information gathering from the tenant. We can't change the law. Mr. Schneider responded, I did not realize it was a law. I thought it was a requirement in the program that the County had control over. Anthony Bianco said the regulations come out of the Treasury Department. Mr. Angilella said it is the US Treasury that writes the regulations, not the County of Camden nor the State of New Jersey. We absolutely understand and share your frustration. I went to Anthony when your case was first presented to me and said let's take care of this guy, lets apply and do what we can. We can't do it under the regulations.

Commissioner Nash said you have been speaking to the County Administrator, you have been speaking with other Administrators and they have gone, in my view, very far to try to accommodate and to resolve your problem. I would like to thank the County Administration for doing that. I believe the federal regulation is requiring the tenant because the tenant needs to certify that the loss of payment is a consequence of COVID. That certification needs to come from the tenant, not the landlord. I do agree that it is very unfortunate that tenants for whatever reason are not paying landlords because you have obligations. No one is giving you a pass on paying your property taxes which I presume are coming from the proceeds of rent. It puts you and many, many other landlords in a very difficult position especially during the pandemic. We have sympathy for your position but we are guided by the federal regulation. Mr. Angilella said, I don't want to give you legal advice but I suggest you hire a lawyer. I don't think you would be barred from suing the tenant for back rent. You can't evict her right now but I think you could proceed with a lawsuit to get a judgment. Docket the judgment and then try to collect. The Director and I are lawyers, so we are giving you that advice. Director Cappelli added, so is Commissioner Nash. *Mr. Schneider said I have hired a lawyer and we are proceeding. I do appreciate the attention of the Board*.

<u>Galen Giosa, Berlin</u>. I would like to say I agree with Mr. Schneider's comments. I have been down that road with the federal regulations. If I can make a recommendation, check out all of your paperwork in terms of the COVID relief for landlords. There should be a CFR or an actual law listed there somewhere that you can reference. To get back to my earlier conversation. This is my first time using WebEx. I wanted to clarify that all I was asking for 69 -91 was did they all pass? Director Cappelli said yes, they all passed.

Seeing no other members of the public wishing to comment, Director Cappelli asked for a motion to close the public hearing. Commissioner Nash made a motion with a second by Commissioner Young and all Commissioners voted aye.

The Director opened the floor to the members of the Board of Commissioners for their comments.

**Commissioner Nash** said I want to wish everyone a very happy and healthy holiday season and Happy New Year. I would be remiss if I did not once again say thank you to the employees of this County, especially those who are directly involved in the pandemic response. It was an amazing job that was done by not only Administration, but the Health Department and those that assisted in that effort, especially at Camden County College. It has been a very difficult year and they have been just remarkable. I saw on TV that Camden's first basketball game is going to be nationally televised on ESPN at Camden High. Commissioner Dyer said yes, the game is tomorrow. Commissioner Nash said Happy New Year everybody.

**Commissioner Kane** said I would like to wish everyone Happy Holidays and to be mindful of so many families within our community whose lives have been severely impacted by COVID and who have lost a family member or have dealt with a traumatic illness due to COVID. Reach out to your neighbors, especially those who have experienced a loss, as well as the elderly. I wanted to make note at the end of the year to thank Col. Ted Gallagher and the staff at the County's Veterans Affairs Office who have done a remarkable job this past year and had four major programs: Veterans Day, Memorial Day, 9/11 20<sup>th</sup> Anniversary, Pearl Harbor and countless

medals ceremonies. I would like to thank them for their dedication to our veterans within the community. I would also like to thank those who have been instrumental in planning all those programs, including Special Events. I would like to thank Linda Devlin for trying her best during a pandemic to keep the library programs going and the celebration of the 100<sup>th</sup> Anniversary of our library system. There is much to be proud of. I would like to thank Bob Harris and his staff for keeping all our buildings up and running and operating well. Finally, I would be remiss if I did not thank my left hand, my right hand, Jeanette Alverez who has done a great job helping me this year. To all my fellow Commissioners, have a wonderful holiday and New Year and I will see you all at the basketball game tomorrow.

**Commissioner Young** said I would like to thank all the employees of Camden County and especially my departments. Holly and Jim, thank you for all that you do for us. To all my departments, Warden Taylor, Chris Waldron, Rob Blaker, Sam Spino, Frank and Nidia at the One Stop, I would like to thank all of you for doing a terrific job. Happy retirement Sam, we are going to miss you. I would also like to thank Imani for always being there and doing all the things that you do. I love this part of the season because it is a great time to give back and to help other people. I want to take this time again to thank our employees at Camden County, especially Employee Connections. They do a fantastic job. They run a fundraiser and from that fundraiser we were able to feed over 350 families at Thanksgiving. With what Dom would call a mack daddy Secret Santa we were able to take care of some families in the County. Also, we had three employees who were hit with some uncertainties in life and Employee Connections came through in a big way. We were at a presentation yesterday and you could just see the effect that it had on them and their extended family was there for them. It is remarkable and I am so very very proud to say that I am a Commissioner in Camden County. Thank you very much for all that you do. Everyone have a fantastic holiday and we will see you in the new year.

**Commissioner Dyer** said I also want to thank all the County workers, as well as Administration, Aides, Directors and the Board of Commissioners for everything you do. December 20<sup>th</sup> is approaching and will be my first full year as a Commissioner. I can honestly say that Camden County is a well-oiled machine. I want to personally thank Ed for helping us out, all three of us at one point. You do a great job at keeping everyone on point and giving me all the information I need. December 20<sup>th</sup> of last year the Director swore me in and I had no idea what I was about to get into. I can honestly say Camden County does a great job. We do tremendous work for folks. We are there. We are helping and we are doing everything we can to move this County forward. Happy Holidays to everyone. Be safe. Enjoy this time with family. This is a special time of year for some people, but it is also not the greatest time of year for others.

**Deputy Director McDonnell** said I have a wonderful Christmas story for our taxpayers. As you will recall in 2013 the County sold our psychiatric hospital in Lakeland having determined that it would be better for a private entity to buy the property from us and operate it. Back in 2013 as we made that decision and with all the complicated paperwork with the State of New Jersey, we were told at that time by the State of New Jersey that we would owe them as we closed out this sale almost \$22 million. David McPeak, our CFO, went to work on that and began negotiating with the State as to what he thought was the real close out cost. When all was said and done about a week ago, David got to the point where the State of New Jersey will be paying Camden County \$3.5 billion. That is a great Christmas story and a great benefit to our taxpayers. David we thank you for doing that. To all our employees in Camden County thank you all for everything you do every day for all our citizens.

**Director Cappelli** said I would like to take this opportunity to thank all the frontline workers in Camden County. We have now been in this pandemic for 22 months. Those of you on the frontline, especially in healthcare and in public safety, day in and day out you have put your lives on the line. Without all of you we truly would not have survived the past 22 months and unfortunately it looks like we have more months to go. To all of you frontline workers, we cannot thank you enough. Thank you to Team Camden County, who has been dealing with this pandemic under the leadership of our Administrator, Ross Angilella, Deputy County Administrators, the Department of Health, the College and Special Events and everyone on Team Camden County who continues to come together. We continue to do testing and give the vaccine. We just increased our hours down at the College beginning next week. It is going to be a cold week. All these folks will be out there in cold windy weather giving tests, giving boosters, giving vaccines. We cannot thank you enough. We just wish more of you folks out there would get the vaccine and the booster because that is the only way we are going to start seeing a decline in cases. In the meantime, we will continue to do our best on behalf of our residents to provide as much safety as we can and as many services as we can. To our residents who have been so supportive throughout this process, thank you because without your cooperation things would be a lot lot worse in Camden County.

I too would like to thank my aide, Digna who just came back from maternity leave. Congratulations on little Troy. Thank you, Jeanette, for your help while Digna was out. To all the employees of Camden County, thank you so much for the hard work you do day in and day out for the residents of Camden County. Happy holiday season. Happy, healthy and prosperous New Year to all.
