NOTICE OF ADOPTION

The Ordinance published herewith has been finally adopted after a PUBLIC HEARING held on May 19, 2022 at 6:00 P.M., at the Camden County Courthouse, 520 Market Street, 6th Floor Meeting Room, Camden, New Jersey. A First Reading was introduced and approved on April 21, 2022, by the Camden County Board of Commissioners in the City of Camden, County of Camden, New Jersey and the 20-day period of limitation within which a suit, action or proceeding questioning the validity of such Ordinance can be commenced, as provided in the Local Bond Law, has begun to run from the date of the first publication of this statement.

CAPITAL ORDINANCE PROVIDING FOR VARIOUS IMPROVEMENTS IN, BY AND FOR THE COUNTY OF CAMDEN, NEW JERSEY

WHEREAS, the Board of Commissioners (the “Board”) of the County of Camden, New Jersey (the “County”) has adopted a budget for the expenditure of public funds for capital purposes to give effect to general improvement programs; and

WHEREAS, the capital improvement appropriations have not heretofore been ear-marked for specific purposes; and

WHEREAS, the County has reserved funds in the capital improvement appropriations for the various capital improvements set forth in Section 1 below (the “Purposes and Improvements”) and needs to make capital improvement appropriations for the costs of the Purposes and Improvements; and

WHEREAS, there is money available for the costs of the Purposes and Improvements in the Capital Improvement Fund of the County (the “Capital Improvement Fund”); and

WHEREAS, the County has determined to appropriate capital improvement funds in the amount of \$10,000,000 towards the costs of the Purposes and Improvements.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF CAMDEN (not less than two thirds of all the members thereof affirmatively concurring), AS FOLLOWS:

Section 1. The County is hereby authorized to (i) acquire voting machines for the Department of Elections; (ii) upgrade the radio system for the Public Safety Department; (iii) make various improvements for the Parks Department, including trail and site improvements, gazebo replacements, general improvements; (iv) conduct various engineering services for projects for the

Parks Department; (v) acquire various equipment and vehicles for the Parks Department; (vi) make various improvements, including emergency road repairs, bridge and culvert priority repairs, road project design, construction management and inspection, dam repair, non-participating road improvement project costs and roof and garage door improvements for the Public Works Department; (vii) repair, replacement and acquisition of new signals and equipment for the Public Works Department; and (viii) acquire dump trucks for the Public Works Department.

Section 2. The County hereby appropriates the sum of \$10,000,000 from the Capital Improvement Fund for the purpose of financing the costs of the acquisition of the Property.

Section 3. The Purposes and Improvements described in Section 1 of this capital ordinance are lawful capital purposes of the County, and no part of the cost thereof has been or shall be assessed against property specially benefited thereby. The average period of usefulness of said Purposes and Improvements is 14.75 years.

Section 4. The capital budget of the County is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board of the Division showing all detail of the amended capital budget and capital program as approved by the Director of the Division, are on file with the Clerk of the Board and are available for public inspection.

Section 5. This capital ordinance shall take effect after final adoption and publication as required by applicable law.
