NOTICE OF SUBSTANTIAL AMENDMENT TO FY 2018
ANNUAL ACTION PLAN

The purpose of this notice is to present substantial amendments to the Camden County FY 2018 Annual Action Plan to revise the HOME Investment Partnerships (HOME) projects.

In accordance with program regulations, the County is allowed to make substantial amendments to its Annual Action Plan and budget in accordance with its Citizen Participation Plan. This Substantial Amendment is necessary because the County is proposing to create a new HOME Project. Specifically, the County is creating a project to represent the mandatory set aside of HOME funds for Community Housing Development Organizations (CHDOs). This is considered a substantial amendment under the County's Citizen Participation Plan, as it is a decision to create and allocate HOME funds to a new Project.

On Monday, June 27, 2022, at 12:00 PM Camden County will conduct a virtual public hearing to solicit comments from the public. All interested persons, groups, and organizations are encouraged to attend this virtual public hearing and will be given the opportunity to present oral or written testimony concerning the proposed amendment for the FY 2018 Annual Action Plan. A link to access the virtual public hearing will be posted on the webpage shown above. Written comments, as well as requests for special assistance related to limited English proficiency or disabilities, should be directed to tracy.wilson@camdencounty.com.

On July 21, 2022, Camden County Commissioners will consider a resolution approving the Substantial Amendment and authorizing its submission to the U.S. Department of Housing & Urban Development.
