BOND ORDINANCE FURTHER AMENDING A BOND ORDINANCE FINALLY ADOPTED JUNE 15, 2017, AS AMENDED BY A BOND ORDINANCE FINALLY ADOPTED AUGUST 19, 2021 BY THE COUNTY OF CAMDEN, STATE OF NEW JERSEY, IN ORDER TO PROVIDE FOR A FURTHER CHANGE IN THE IMPROVEMENTS AUTHORIZED BY SUCH ORDINANCE

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF CAMDEN, NEW JERSEY (not less than two-thirds of all the members thereof affirmatively concurring), AS FOLLOWS:

Section 1. Exhibit A which is referenced in Section 3(a) of a bond ordinance finally adopted on June 15, 2017 (the "Original Ordinance") entitled "BOND ORDINANCE OF THE COUNTY OF CAMDEN, NEW JERSEY APPROPRIATING \$12,375,000 FOR THE REPAIR AND/OR REPLACEMENT OF CERTAIN COUNTY INFRASTRUCTURE PROJECTS IN ACCORDANCE WITH THE PROVISIONS OF N.J.S.A. 40:14B-40.2 AND AUTHORIZING THE ISSUANCE OF \$11,756,225 BONDS OR NOTES OF THE COUNTY FOR FINANCING PART OF SUCH APPROPRIATION" of the County of Camden, New Jersey (the "County"), as amended by a bond ordinance finally adopted on August 19, 2021 (the "Amending Ordinance" and together with the Original Ordinance, the "Amended Ordinance") entitled "BOND ORDINANCE AMENDING A BOND ORDINANCE FINALLY ADOPTED JUNE 15, 2017, BY THE COUNTY OF CAMDEN, STATE OF NEW JERSEY, IN ORDER TO PROVIDE FOR A FURTHER CHANGE IN THE IMPROVEMENTS AUTHORIZED BY SUCH ORDINANCE and attached thereto, is amended to read in its entirety as set forth in Exhibit A attached hereto.

Section 2. All other details of the Amended Ordinance shall remain the same.

Section 3. This bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by the Local Bond Law.
