

**COUNTY OF CAMDEN
NOTICE OF SUBSTANTIAL AMENDMENT
TO FY 2019, FY 2020, FY2021 and FY 2022
ANNUAL ACTION PLANS**

The purpose of this notice is to present substantial amendments to the Camden County FY 2019 – FY 2022 Annual Action Plans to revise the Community Development Block Grant (CDBG) funding for previously approved projects.

In accordance with CDBG program regulations, the County is allowed to make substantial amendments to its Annual Action Plan and Budget in accordance with its Citizen Participation Plan. The County of Camden proposes to amend its 2019, 2020 2021, and 2022 Annual Action Plans in order to revise the Community Development Block Grant (CDBG) funding for previously approved projects. The 2019 Annual Action Plan was approved with a budget that included \$2,418,965 in CDBG funds, along with \$200,000 in Program Income. The 2019 Annual Plan was amended to also include \$3,647,038 in CDBG-CV funds and \$2,147,746 in ESG-CV funds. The 2020 Annual Action Plan was approved as part of the 2020 Five-Year Consolidated Plan, with a budget that included \$2,470,397 in CDBG funds, along with \$19,392 in prior year CDBG funds. The 2021 Annual Plan was approved with a budget that included \$2,532,716 in CDBG funds for 2021 along with \$1,133,695 in HOME funds; and was amended to include \$30,000 in prior year 2020 funds. The 2022 Annual Plan was approved with a budget that included \$2,372,185 in CDBG funds; \$1,279,027 in HOME funds; as well as \$427,804 in CDBG Program Income, \$229,723 in HOME Program Income and \$40,000 in recaptured HOME First Time Homebuyer Program funds.

An amendment of the Annual Action Plans is necessary because the County is proposing the following changes in funding:

1. They will not be carrying out the 2019 Winslow Township School Crossing System project funded for \$38,922 or the 2020 Winslow Township ADA Parking Improvement project funded for \$34,000. These funds will be redirected to a new 2020 Winslow Senior Center public facilities project. This project will be used to reconstruct hardscape and landscape of the Winslow Township Senior Center at 33 Cooper Folly Rd, Atco, NJ 08004.
2. The County will be reallocating \$419,000 of CDBG-CV3 funding from the County Homeless Shelter to the construction of the County Nutrition Hub, a new CDBG-CV project.
3. The County will be reallocating \$550,149.69 from 2020 and 2021 CDBG Admin to the County Nutrition Hub, a new CDBG-CV project.
4. The County will be reallocating a total of \$1,348,033.92 in 2019, 2020 and 2022 HOME funds to future affordable housing projects through existing 2022 project, HOME Housing Development.

Under the County’s CDBG Citizen Participation Plan, a decision to not “carry out an activity for which funding is approved” and a “change the purpose, scope, location, or beneficiaries of an activity” constitute a “substantial change” necessitating a Substantial Amendment to a Five-Year Consolidated Plan or Annual Action Plan as applicable.

This substantial amendment will include the following reallocations:

This document will be available to the public for a period of thirty (30) days – from Thursday, November 10, 2022, through Friday, December 9, 2022, after which time the Camden County Board of Commissioners will consider a resolution to authorize its submission to the US Department of Housing & Urban Development.

On Wednesday, Nov, 30th at 10am the County will conduct a virtual public hearing to solicit comments from the public. All interested persons, groups, and organizations are encouraged to attend this virtual public hearing and will be given the opportunity to present oral or written testimony concerning the proposed amendment for the FY 2019-2022 Annual Action Plans.
