The meeting was called to order by Director Cappelli at 12:00 p.m.

The Clerk called the roll and the following Commissioners answered:

The Director stated that adequate notice of this meeting has been provided in accordance with the Open Public Meetings Act.

The Director asked everyone to rise for the Pledge of Allegiance which was led by Commissioner Kane.

The Director said good afternoon ladies and gentlemen. Welcome to the meeting of the Camden County Board of Commissioners.

Director Cappelli said we will begin our meeting with two (2) Public Hearings pertaining to County capital financing.

PUBLIC HEARING NO. 1

Director Cappelli opened the public hearing to anyone who would like to comment. Receiving no comments, the Director asked for a motion to close the public hearing. Commissioner Nash made a motion with a second by Commissioner Betteridge and on roll call all Commissioners present voted aye.

Director Cappelli asked for a motion to adopt the Resolution. Commissioner Young made a motion with a second by Commissioner Dyer and all Commissioners present voted aye.

COMPTROLLER'S REPORT

The Director asked for a motion to adopt the Comptroller's Report. Commissioner Deputy Director McDonnell made a motion with a second by Commissioner Kane and on roll call all Commissioners present voted aye.

CORRESPONDENCE

The Director asked the Clerk if there was any correspondence. The Clerk responded no, there was none with month.

The Director said the next portion of the meeting is open to the public for discussion of resolutions to be acted upon this afternoon. There will be another public hearing later in the

meeting at which members of the public can ask any questions they want regarding the business of the County of Camden. The Director opened the public hearing.

Kate Delaney, Collingswood, NJ asked about Resolution No. 74 from the Caucus Agenda amending Resolution No. 54, adopted September 15, 2022, establishing program and funding categories relating to Camden County's allocation of American Rescue Plan Funds. Can you read the resolution and explain what changes have been made as far as funding categories. Commissioner Deputy Director McDonnell said on my Agenda it is Resolution No. 74. Each month you may have noticed, we adopt this Resolution because as needs develop, we will move money from one category to another in order to fill that need and take it from a category not so much needed. For example, recently we developed a program for direct care providers; people who work in nursing homes, group homes, and who change diapers and feed patients and clients. We wanted to devote some funds to help them because of their work during the pandemic. When all of us were home working remotely, there they were every day doing those duties. So we moved some funds from one account to another to make sure we helped those folks who completed an application and received \$1,000 each. That is what we do each month depending on where the needs are. If we need more money in rent assistance, we may take it from another account that hasn't used all its money. It is all the same ARP money. It is a question of simply reallocating as time goes by where the needs are fulfilled and in other cases where the needs are not yet met. Ms. Delaney said thank you for your response.

Ms. Delaney said my next question is with respect to Caucus Agenda No. 113 amending Resolution No. 2, adopted January 3, 2022, establishing Committees, Committee Appointments, Committee Departmental Assignments, Departmental Organization, and Commissioner Responsibilities and Assignments. If you could speak to the changes you are making in this Resolution from the current formulation of committees and any changes you are making to assignments and responsibilities. The Commissioner Director asked DCA Holly Cass to explain. DCA Cass responded the only change we are making this month is to assign co-liaisons to the Camden County Technical School. Jon Young and Ed McDonnell are co-liaisons to the Technical School.

Hearing no further members of the public wishing to comment, the Director asked for a motion to close the public hearing. Commissioner Deputy Director McDonnell made the motion with a second by Commissioner Young and all Commissioners present voted aye.

The Director closed the public hearing.

Director Cappelli opened the meeting to any member of the public who wished to address the Board of Commissioners.

Kate Delaney. Ms. Delaney said I want to speak to something that Susan wants to speak to as well. A great many people in the area were impacted by yet another scrap yard fire over at EMR. I could smell it in the air in Collingswood. I have lost count as to how many fires there have been at EMR. As elected officials I want to know what you are doing to hold EMR accountable. This is a huge environmental injustice issue. This is an air pollution issue and we need our representative democracy to work here and we need representatives who are going to represent us in this issue. There needs to be some consequences from EMR repeatedly causing these fires. Commissioner Director Cappelli said Kate, I can tell you that I met with EMR two weeks ago and they recognize this problem. They acknowledged at that meeting that there could be additional fires. They are in the process of developing a plan. The plan as explained to me would eliminate these types of fires from happening in the future. It is a significant investment in the city. They have not made the plans public yet because they are still developing the plans. I know that EMR is concerned about the situation and I think they will be announcing a plan publicly sometime in the near future on how to deal with this problem.

Susan Drunkenrod, 162 Valley Run Drive, Cherry Hill. I was reading the article in the Courier Post. EMR has gotten tons and tons of taxpayer money to set up this scrap yard. Camden County's air quality continues to be an "F" rated air quality. I would like you to not just have polite meetings with them. This should not be happening again. I don't know why we would want to bring a scarp yard to Camden. It is a really dirty business. I appreciate your comments. Commissioner Director Cappelli said historically it has been a scrap yard and there have been many scrap yards in the City of Camden. One thing you do have to remember is that EMR employs approximately 168 Camden residents in very good paying jobs with health insurance and retirement benefits. We cannot ignore that fact. They recognize this as a problem. I know you are calling the meeting a polite one. It was somewhat polite, but I also told them these conditions cannot continue to exist. When they do go public with their plan, I think that everyone will be, number one impressed and secondly satisfied with the measures they will be taking to remedy the situation. Ms. Drunkenrod said ok, I hope that happens. Commissioner Director Cappelli said I hope so too.

<u>Kate Delanev</u> said this is the line that we hear time and time again. These terrible polluting facilities in Camden provide jobs. You are not going to find that kind of deal in Cherry Hill and Collingswood. I think it needs to be flagged that we are saying the people of Camden

have to live with these facilities because they get jobs. Why can't they have jobs and not these facilities? This is the line that has been put out there again and again. They should still be held responsible. It doesn't matter if there is job creation going on. There should still be some responsibility from EMR and their plan should be public. They should be meeting with constituents. I know they had a meeting last year, but it seemed like just a PR gesture. The Commissioner Director said meetings with residents and the public will be part of their plan moving forward. That is my understanding. You are right, it is unacceptable to continue to have these fire, I will not disagree, however I will disagree with you on the fact that if you tell the 168 residents of Camden that these jobs no longer exist, that will have a significantly negative impact on the residents of Camden City. The fires and the problems that have come from that yard are unacceptable. Ms. Delaney said, again I think it is a false dilemma that we have either jobs or this facility. We can have both jobs and facilities that don't pollute and poison the air in Camden and surrounding areas.

Seeing no other members of the public wishing to comment, Director Cappelli asked for a motion to close the public hearing. Commissioner Young made a motion with a second by Commissioner Betteridge and all Commissioners voted aye.

The Director opened the floor to the members of the Board of Commissioners for their comments.

Commissioner Nash said I want to recognize and express my condolences on the passing of Governor Florio. It was a remarkable memorial service and I thank you, Director. You and your partners did an amazing job recognizing a great leader in our community.

I also want to recognize the passing of Rosa Ramirez who was a tower of strength in Camden City for so many years. We worked together during that 1990s and 2000s and she was a force to be reckoned with. She cared deeply for the residents and was motivated for that reason alone. You had to respect and admire her tenacity and dedication to Camden City. She also had a very special memorial in her memory.

Commissioner Kane and I participated in the March of Remembrance which was sponsored by the Jewish Federation. It was a very rainy day but the Jewish Community in particular, came out. The March of Remembrance is to always remember the tragedy of the Holocaust.

On a positive note, thanks to the help of the DEP and other officials in the State of New Jersey, the City of Camden and the Mayor of Camden they are beginning to remediate the gigantic dirt pile in Bergen Square. Hopefully that will resolve a long-standing environmental problem in the City of Camden. I want to give a shout out to Dominic Vesper and the Parks team for the creation of the Piazza which had its ribbon cutting a couple of weeks ago. That is a spectacular addition to Cooper River Park to honor the Italian Americans who built this community. It is already a very popular destination for people who are getting married and using it for photographs, but it is really a terrific addition to the park to celebrate the diversity of our great County. Last but not least, earlier this week there was a film introduced for many of the environmental committees and organizations in Camden County. Over 200 people showed up at the Camden County Boathouse to watch the movie that was sponsored by National Geographic called Search for the Cooper River. It is the story of four young residents of Camden County who actually took kayaks

and searched for the source of the Cooper River. I could share with you where it is, but you should actually watch the movie to find out. These four young men and women found the source. It was a wonderful environmental addition to the County's repertoire. I have to give credit to Maggie McCann Johns who is actually paddling as we speak on the Cooper River. Commissioner Director Cappelli asked how he could obtain a copy of the movie and Commissioner Nash said he would send it to him.

Commissioner Kane said there have been a lot of activities and programs in the community this Fall. One of them was last Saturday evening celebrating the 25th anniversary of the Betty Milton Katz JCC in Cherry Hill at which I presented a proclamation to everyone there. They are a huge part of our community providing many services as is the Jewish Federation which on Sunday will be celebrating their 100th year anniversary being in South Jersey and providing many services to the residents of Camden, Burlington and Gloucester County.

Also last Saturday, the American Legion in Atco donated Purple Heart parking spots for wounded veterans in their community. It was a beautiful ceremony and very meaningful. On Tuesday evening, I attended a very meaningful ceremony sponsored by Voorhees Township and Samaritan Hospice honoring comrades, veterans, first responders and families to help them heal from experiences they have had as first responders and as veterans. I salute Samaritan and Voorhees Township for having that program.

Veterans Affairs has been very busy within the County. Right now they are overseeing approximately 500 claims from residents. Some of the claims have been ongoing for five years. On September 30th we held a medal ceremony on the Battleship New Jersey which is always a wonderful place to have medal ceremonies and is very meaningful for the recipients and family members. We are gearing up for Veterans Day on the 11th of November. Camden County is doing a new program this year. We will be honoring our Veterans at the Peter Molnar Veterans Day Breakfast and Ceremony at the Collingswood Ballroom beginning at 8:00 a.m. until 11:00 a.m. All county residents who are veterans and their families are encouraged to attend. I also encourage all of you to attend.

Finally, I want to wish my colleague, Al, a speedy recovery from his surgery.

Commissioner Young said, as always, I would like to thank my departments for doing a fantastic job. There are a couple of events going on this month. This month is Camden County History Month. The Peter Mott House in Lawnside celebrated its 32nd anniversary as an underground railroad museum. Also, in Berlin Township, they will be placing a marker on the location of the Snowflake School which was a school for colored pupils back in the day and is no longer there.

I want to give a big shout out to Rob Jakubowski. Rob will be receiving his roses and be honored for his work with the homeless population.

Tonight, we are having food waste composting event at our Sustainability Campus. It will teach you how to compost your food waste instead of sending it to the landfill. Our Camden County certified gardeners Fall Make and Take Class will be teaching you how to grow and maintain succulents.

Commissioner Dyer said I want to thank the County workforce for the work they do day in and day out. It is a true pleasure to see the work being done throughout Camden County under the leadership of Dom Vesper. We have a lot of road projects going on in the County. Drainage and handicap ramp work is being done at Berlin-Cross Keys Road, as well as roadway improvements on Almonesson Road. I appreciate Bob Harris who stepped right in. He is doing a great job. It is good to be here to acknowledge you and what you do. Last but not least I had the opportunity this morning to attend an athletic make-over at Woodrow Wilson High School, which is now East Side High School. The community came out to provide some TLC to the athletic program and fields. They were painting bleachers and fences. It was a great event. I thank Mayor Carstarphen and Superintendent McCombs for putting that together. There were some students out there supporting that endeavor. It was great to see Woodrow Wilson getting a make-over. There is a lot of work that needs to be done. It was good to go back to my roots in East Camden and hang out with some folks that I have not seen in a while and lend a hand to some much needed work.

Commissioner Betteridge said this month has been extremely busy. We provided many COVID and flu shots to Camden County residents in the southern, central and northern parts of the County. This morning I had the opportunity to stop at the Kroc Center. Every time I walk into that building, I am just amazed at the community programs that are happening there. Seeing the little children in the daycare center is a good way to start the morning. I commend the staff at the Camden County Health Department for their diligence and everything they are doing to keep people inoculated and safe during this time.

My colleague and I visited the Peter Mott House over the weekend and on behalf of the Board of Commissioners we presented a proclamation. Yesterday I had the opportunity to attend the Municipal Coordinators meeting from the Office on Aging, part of the Health and Human Services and I was just really pleased that so many representatives from around the County came to listen to the programs and the new initiatives that Senior Services will be providing to our seniors. Everyone is coming back out again and it is really a good feeling. We were also able to secure several nights throughout the month to do a ceramics class at the Carol Norcross Senior Center. If there are any seniors listening and watching this meeting, you can go to camdencounty.com or directly call the Camden County Health and Human Services to sign up for those classes. Typically, the participants participate during the day, but these classes begin at 4:00 or 4:30. From what I was told yesterday we are having a successful amount of people coming forward and saying they want to do a ceramics piece. The cost is \$10 for the entire 3-week class.

On Monday, I am going to be doing a Spanish interview with Telemundo on the Camden County Vineyards, the harvest and the contributions we are making throughout the State of New Jersey with the wine industry. I am very excited to do that and will keep you all posted.

Commissioner Deputy Director McDonnell said I am glad Commissioner Betteridge mentioned the flu shot program. She and I have been going all over the County to the flu shot sessions and the staff has just been terrific. They treat the folks who come in with tremendous respect and assist them greatly. We are trying to protect all of our citizens in Camden County and I want to thank Commissioner Betteridge for organizing all of that. I would also like to thank all our employees for all the work they do for County Camden.

Commissioner Director Cappelli said, Kate and Susan, I was just reminded by Deputy County Administrator Rhodes that the County Public Emergency Management and HazMat teams were on site for the fire at EMR monitoring the air quality and preparing to relocate residents if necessary. No residents needed to be relocated. Appropriate enforcement action will be taken if any violations are found.

The Commissioner Director said I want to thank everyone who helped in the memorial service for Governor Florio. Frank, Kara and everyone at Special Events. It was a fitting tribute to someone who was such an inspiration to so many of us here in Camden County. Commissioner Nash mentioned Rosa. Unfortunately, I could not make that service, but I can tell you eleven or twelve years ago when we first started thinking about the possibility of a County police department, one of the first persons we met with was Rosa. We asked her what she would like to see in the police department. She laid out many different things she would like to see happen and thankfully many of them did. She was a great leader and certainly a great asset to the City of Camden. She will be missed. Thank you to everyone who worked on the Italian Festival and related activities. It was another great event celebrating the Italian culture.

Al Dyer, you mentioned a couple of the road projects, but you have many more this month; Haddon Avenue in Haddon Township and Collingswood and Kings Highway in Haddonfield. Great job by you and your team.

Thank you to all the employees of Camden County for the great work they do day in and day out.

The Director asked for a motion to adjourn. Commissioner Young made a motion with a second by Commissioner Nash and all Commissioners voted aye. The meeting was adjourned at 12:40 p.m.
