# **WALK-ON** by Commissioner Kane:

Resolution Ratifying a month-to-month Contract (Bid A-32/2020 – First One Year Option), by and between the County of Camden (Department of Buildings and Operations) and Northeast Mechanical Services, Inc., for HVAC maintenance services for Camden County Departments and various outside Agencies and Authorities, under the Camden County Cooperative Pricing System, ID #57-CCCPS, on an "as-needed" basis pending reprocurement of these services.

The Director called for a motion on Resolution No. 102 acknowledging personnel actions requested by or on behalf of Constitutional or Statutory Row Offices.

## **RESOLUTION 102**

## **NO MOTION MADE – FAILED**

Director Cappelli opened the meeting to any member of the public who wished to address the Board of Commissioners.

Jennifer Rivera, 211 Delaware Avenue, Sewell. Ms. Rivera said I am here due to concerns regarding Homeward Bound Pet Adoption Center. There have been several reports of inspections dating back to 2020 regarding the shelter and ventilation issues which affect not only the employees but the animals as well. In 2021 there was no isolation room for dogs that needed isolation. On July 6 and July 21 of 2022 there was two incidents were dogs tested positive for parvo. Instead of them going to a hospital to begin treatment they were placed in cat isolation which is still an issue because employees are still around these dogs. They stayed there the entire time during the Director's shift and when she left at the end of the day these dogs were then taken to her home. The issue is that they were just in a crate. It is not like they were put in a big area where it was away from everyone. They were combined in a small crate. There was no feeding

and no watering, and the staff could not touch them. On July 21, one of the two dogs that had parvo passed away. If the dogs had been treated immediately instead of sitting in the shelter for over 8 hours the outcome could have been different. Also, cat drop off was in violation on July 22<sup>nd</sup>. There is no ventilation in cat drop off so there has been a lot of panleuk in the shelter over the past several months. Without proper ventilation, housing and isolation it is going to spread like wildfire. These have been noted on the inspections by the County as violation since 2020. Hallways were found to be nonventilated. Dogs are not housed in these hallways, but humans are clearly working there. I also feel that for these things to be corrected, changes must be made. If dogs have proper isolation, they have a chance to get better. Employees are taking panleuk home. Several employees took panleuk home and all their fosters died because they caught panleuk. I am actually a former employee. I was a development manager. During this past summer panleuk was worse than I have ever seen. I have been at the shelter volunteering and fostering for about 6 years. I have taken in hundreds of animals. A lot of corrections need to be made.

My other concern is that a lot of the animals we thought went to employees were actually cremated. It turns out they are picked up by M&S Cat Removal Services, taken to the Salem Landfill and just dumped with the trash. Anyone who loves animals, we understand it is just a body, but these animals don't deserve to be dumped in a landfill.

Director Cappelli said thank you for bringing these maters to our attention and asked Commission Young to comment. Commissioner Young said we know we have had ventilation and air conditioning problems for quite some time. Our HVAC company has been down there consistently to try to correct the problem. We have a fix for the cat area and the area up front. We ordered new air conditioning units, but they are a few months out. Temporary units have been installed. If there is one calculation wrong on the size of a unit it can affect the area.

As far as taking animals to the dump, I have no knowledge of that. Ms. Rivera said I used to sign off on the removal. One day I questioned M&S and asked them what happens to these animals. I was told that they used to render them. I don't know if you know what rendering is. It is kind of graphic. They grind them up and they go back into the soil as fertilizer or as meat byproducts. M&S told me they no longer render. They take them to the Salem County Landfill where they are dumped. I worked very hard for the place. Even money that I would raise online through Facebook for specific items such as kitten supplies, I raised thousands of dollars, I could not use. This is part of why I felt I could no longer be there because I felt immoral, and I felt like I was stealing. They would not allow me to spend that money on supplies. I had meetings with Michelle, the President, Liz, and Hazel and I brought these concerns up over and over. If I am raising this money, I should not be told that it goes into one big pot and to keep soliciting online for these items to come in. People bought memorial benches a year ago. \$1,500 for one memorial bench. Big corporation donate for these benches and I kept getting pushed back and told I can't spend that much money on a bench. So, I asked them then why are we raising money for them?

Commissioner Young said what year was that? Ms. Rivera said the money was donated in September 2021. Up until I resigned July 20, 2022, I kept getting push back that we should not spend that kind of money on benches, yet we kept soliciting them \$1,500 per bench.

Director Cappelli asked which DCA oversees the Shelter? Commissioner Young replied, Jim. Jim said we have Chris Waldron, Lisa Boston, the Director and Michelle who is the Chair of the Board all online. I know Buildings and Operations has been working on the HVAC system for awhile now. With regard to the fundraising issues, I am not aware of any of those. Director Cappelli asked are the fundraising issues with the third party? Jim said, yes, it is run by a third party, Homeward Bound and they are online to answer questions right now. Commissioner Young asked Ms. Rivera if she was there when Vicky was there. Ms. Rivera replied, no but I know Vicky because I was a foster volunteer. I came in as an employee after Vicky left. I was with Jill and then Rose and then Lisa. Commissioner Young said there is a reason there were a couple of directors after Vicky. I am not afraid nor embarrassed to say it. There were a couple of not so good choices. We figured it out and now we have Lisa. I know there have been some issues down there and talking with Lisa I am confident that we have the right person in place. I do appreciate your comments and we will address these issues. I am an animal lover myself. Dead or alive, they deserve respect. We will address that. Lisa has only been there for a month or so and I need to let her get her hands around the issues and start to figure it out. I met her a couple of weeks ago and I am very impressed with her and her plans. As the liaison over the Animal Shelter, I can tell you we will address the issues. I am the last person that wants to see the County on the front page of the newspaper. We worked very hard to get the status of where we are down there. There is a standard that has been set and we expect that standard to stay where it is.

Seeing no other members of the public wishing to comment, Director Cappelli asked for a motion to close the public hearing. Commissioner Young made a motion with a second by Commissioner Betteridge and all Commissioners voted aye.

The Director opened the floor to the members of the Board of Commissioners for their comments.

## **Commissioner Nash** said I want to wish everyone a Happy End of Summer!

Commissioner Kane said I was not here last month to formally welcome Ginny to the Board of Commissioners and I look forward to working with you in the future on upcoming events. I also want to congratulate the new Department Head of Buildings and Operations, Michael Billingham. Good things are happening in the County and he will be overseeing those good things and projects. Also, on August 10th, President Biden signed the PACT Act for Veterans. For those of you who are not aware, PACT stands for Promise to Address Comprehensive Toxics. This is for toxic exposure that veterans have been dealing with since Vietnam and more recently in Iraq and Afghanistan. We encourage Camden County veterans to reach out to our Veterans Affairs Office. In many cases veterans have put in claims and have been denied as much as up to 90% of claims for toxic exposer. We can revisit those claims as now 23 illnesses have been identified as being part of toxic exposure. Veterans Affairs is here to assist you.

**Commissioner Young** I would like to thank all our employees here in Camden County for doing a fantastic job. We have one of our major events, Clear the Shelter, coming up on August 27<sup>th</sup> from 11 AM to 4 PM. As always, we are full so please come down and adopt a pet. Have a great rest of the summer and remember to thank a carpenter on Labor Day.

Commissioner Dyer said I want to thank our workforce for the great job they do. This is my second summer as a Commissioner and you guys do a wonderful job all summer. For all those folks who are advancing, I am proud of you. I want to commend two student athletes from Camden County who played in the 17 and Under World Cup this summer. It is rare that New Jersey has two athletes that play in this World Cup; Camden County had two athletes. One young lady was Hannah Hidalgo from Paul VI High School; she had goal against Spain. They won 84-62. Camden's own DJ Wagner played against Spain and they won 79-67. This is a phenomenal accomplishment for our student athletes in Camden County.

Commissioner Betteridge said it has been a very pleasant month. Thank you all for welcoming me so warmly and taking me under your wings. I know that very soon I will be flying but without your help I would not be here one month later. I would like to recognize the communities I visited on National Night Out. I had the pleasure of visiting Chislehurst, Williamstown, Runnemede, and Lindenwold They all did an outstanding job. The community and the volunteers are to be commended for their efforts to bring such an awareness to the constituents of Camden County. They were just the four towns that I visited but all the municipalities had their own activities and festivities. I would be remiss if I did not recognize my Deputy County Administrator. I have known him for a long time, and we have had some really good, energized meetings and together with the Directors of the Department of Health and Human Services and we are planning great programs for the future. I know that sometimes with the health programs they are not as exciting as having the two County students represent us, but it is still work that must be done to safeguard the health and well-being of everyone here in Camden County. Joan, I could not have survived the last 6 or 7 weeks without you. I have no other words to say but thank you. Last Friday when Commissioner Kane and I attended the CAMcare recognition I had the pleasure of meeting Dennis Gonzalez who is the Executive Director for the Health and Human Services on the federal level.
