Applicants must also provide documents that will be used to assist with confirming their identity. Examples: Current or expired driver's license or state issued identification card, military ID, birth certificate, passport, social security card, prisoner ID card, EBT card.

Level I Identification Card (1-2 points): The applicant provided some documents or proof of his/her identity. However, Investigators cannot confirm with complete certainty the identity of the applicant.

Level II Identification Card (3-5 points): The applicant provided some documents or proof of his/her identity and a search of databases are consistent with information provided by applicant. Investigators are fairly confident of the identity of the applicant.

Level III Identification Card (6+ points): The applicant provided numerous documents that proved his/her identity.

Investigators are certain of the subject's identity.
