## Camden County Identification Card Terms and Conditions

To assist investigators with confirming their identity, applicants must complete the application form to the best of their ability. Applicants must also provide documents that will be used to assist with confirming their identity. Examples: Current or expired driver's license or state issued identification card, military ID, birth certificate, passport, social security card, prisoner ID card, EBT card.

### Four (4) Point Documents - Proof of Identity/Residency

- State of New Jersey Motor Vehicles Driver's License or Permit
- State of New Jersey Identification Card with photo

OR TWO of the following:

### Three (3) Point Documents - Proof of Identity

- Consular ID Card with photograph
- Visa (current) or Current U.S. Work Permit
- National identification card (Must have photo, name, address, date of birth and expiration date)
- Camden County Identification Card (information change or renewal)
- Birth Certificate (U.S.)
- US Permanent resident (Green -Card)
- U.S. Citizenship and Naturalization Certificate
- U.S. Federal Government or Tribal issued photo ID
- State Veterans ID with photo
- Temporary Protected Status (TPS) Card with Photo
- U.S military identification card
- U.S. or Foreign Passport
- USCIS-Temporary I-551 Stamps and MRIVs (Immigration letter)

### Two (2) Point Documents - Proof of Residency

- Utility / Cable bill with name and address
- Original documents from any of the following: Health or Social Services organization such as Social worker, Churches, Shelter or Family Member (In Care Of) letter confirming applicant is a county resident, (Must be notarized)

### Two (2) Points - Proof of Identity

- Proof of a minor enrolled in a Camden County public or private school
- Expired U.S. or Foreign Passport (up to 2 years)
- Foreign Driver's license
- Prisoner ID card
- Face Sheet (formerly incarcerated released form)
- Foreign military identification card
- Birth Certificate (Foreign)
- Original documents from any of the following: Health or Social Services organization such as Social worker, Churches, Shelter or Family Member (In Care Of) letter confirming applicant is a county resident, (Must be notarized)
- Detailed Database Search

### One (1) Point - Proof of Identity

- IRS issued ITIN card (must be accompanied by an ID with a photograph)
- Social Security Card
- Electron Benefit Transfer (EBT) card - 1 point
- Foreign Driver's license (if- expired)
- High school or College Diploma
- Voter registration card
- One Stop Photo ID Card
- Single Database Search

### One (1) Point Documents - Proof of Residency

- Insurance bill, bank statement, check book
- Employment pay stub
- Local property tax statement
- Proof of a minor enrolled in public or private school
- Income Tax filing form (1 year)
- Hospital bill or Ward letter
- Auto insurance card
- Notarized residential lease
- Phone bill (Landline)

### Identification cards issued:

**Level I Identification Card (1-2 points):** The applicant provided some documents or proof of his/her identity. However, Investigators cannot confirm with complete certainty the identity of the applicant.

**Level II Identification Card (3-5 points):** The applicant provided some documents or proof of his/her identity and a search of databases are consistent with information provided by applicant. Investigators are fairly confident of the identity of the applicant.

**Level III Identification Card (6+ points):** The applicant provided numerous documents that proved his/her identity. Investigators are certain of the subject's identity.
