CAMDEN COUNTY BOARD OF COMMISSIONERS CAUCUS MEETING FEBRUARY 14, 2023 6th FLOOR CONFERENCE ROOM 520 MARKET STREET, CAMDEN, NJ 08102

Director Cappelli called the meeting to order at 12:00 p.m. and the following Commissioners answered to their name:

Director Cappelli said good afternoon. This meeting has been properly advertised in accordance with the Open Public Meetings Act. The Director asked everyone to stand for a moment of silence to be followed by the Pledge of Allegiance which was led by Commissioner Young.

Kate Delaney, 126 E. Palmer Avenue, Collingswood. Ms. Delaney had a question regarding Resolution No. 32 authorizing the appointment and reappointment of members to the Camden County Solid Waste Advisory Council. She said I have been to these meetings in other counties, but I do not see any information online about Camden County SWAC as to when they meet or who is on the Council. Can you provide the meeting schedule and who sits on that Council? I know in some counties, for instance, Burlington County, they have a citizen representative, some environmentalists, people who work for the county. I am wondering if the people you just appointed or reappointed speak to your criteria. Again, how could citizens who are interested in this conversation, obviously you have folks here today who are very concerned about what the County's long-term plans are for our solid waste, so I think this is an area where

we could use more information. Director Cappelli said we can provide that information if it is not already on our website.

Seeing no other members of the public wishing to comment, the Director asked for a motion to close the public portion. Commissioner Betteridge made a motion with a second by Commissioner Young. All Commissioners present voted aye.
