The meeting was called to order by Director Cappelli at 12:00 p.m.

The Clerk called the roll and the following Commissioners answered:

The Director asked everyone to rise for a moment of silence and asked everyone to keep in their prayers a good friend to all of us who passed away this past week, Sue Discher. Sue was a resident of Haddon Township for many years. She grew up in Camden and was a very active community member who always tried to make her community better in so many ways.

The Pledge of Allegiance was then led by Deputy Director McDonnell.

Director Cappelli asked for a motion to adopt the 2023 Budget. Deputy Director McDonnell made a motion with a second by Commissioner Young and all Commissioners present voted aye.

Director Cappelli asked Deputy Director McDonnell to say a few words about the Budget. Deputy Director McDonnell said thanks to the work of Steve Williams, our CFO, Yolaika Gonzalez and their team, all under the leadership of Ross Angilella we have created an outstanding budget this year. We have lowered the tax rate by 6° from 72° to 66° per \$100 of evaluation. This is the lowest tax rate in twelve years. Part of that was made possible by the fact that the tax base in the County of Camden went up by \$5 billion in 2023. That is the value of all Camden County property. Those ratables going up like that is a message that things are good in Camden County. Everyone's property, whether it is their home or a business, has increased in value and that benefits everyone. Thank you everyone, including my fellow Commissioners for all your discipline in working on this budget. We are very proud.

Director Cappelli said thank you Deputy Director and I know I speak on behalf of the entire Board when I say thank you for your leadership on the budget year in and year out. The fact that it is the lowest rate in twelve years is a reflection of your dedication, hard work, and leadership, as well as the teamwork of our employees. You are to be commended.

COMPTROLLER'S REPORT

The Director asked for a motion to adopt the Comptroller's Report. Commissioner Betteridge made a motion with a second by Commissioner Nash and on roll call all Commissioners present voted aye.

CORRESPONDENCE

The Director asked the Clerk if there was any correspondence. The Clerk responded yes, Director, we have two this month.

The first piece of correspondence is from Pine Hill Mayor Chris Green: On behalf of the Pine Hill community, I wanted to take a moment to personally thank you for your efforts and assistance with the W. Branch Ave. storm sewer and paving project. To date, we continue to receive positive feedback from our residents and those from surrounding communities who routinely travel the road. The improvements are vital to the flow of traffic in our community and your attention to our Borough is greatly appreciated. The roadway improvements have improved the daily commute of our residents, our children going to school and those traveling to town to do business. Once again, thank you for making our community a priority.

The second piece of correspondence is from Jim Hanna, President of the Dad Vail Regatta Organizing Committee: From the very first meeting with you and your Camden County Officials, back in December 2022, convened to begin to plan to stage at Cooper River Park the Jefferson Dad Vail Regatta, until the end of the day, late last Saturday when the Regatta was over, it was a virtual pleasure to work with every single person! Every single encounter began, proceeded with, and culminated in an encounter which was very friendly, helpful, instructive, and left a lasting impression of exceptionally warm welcoming Camden County hospitality! Moving our Regatta to Cooper River Park, the Dad Vail Regatta Organizing Committee would face daunting challenges considering the distance from Philadelphia to Cooper River amounted to just seven miles! New vendor relationships, new driving directions, changing the Local Organizing Committee, requesting new contact information, establishing credit, and revamping the Regatta budget were but some of the challenges. The communications challenges alone, to constituencies to include rowers, coaches, athletic directors, parents, spectators, colleague Board members, long-term dedicated volunteers, and an array of Philadelphia politicians were manifold, so the ease with which the change was augmented by your people was especially appreciated! Every time I would call you, Karen Gilmore would arrange for you to promptly respond facilitating my ability to cross off a check list detail and record one further accomplishment on the pathway to staging one most successful 84th Annual Regatta! A truly surprising number of advantages more than offset these challenges such as the well-buoyed 2000-meter racecourse, the beautifully preserved Cooper River Park, the immaculately maintained Camden County Boathouse, ever-present assistance onsite at the Boathouse, along with the most helpful culture deeply embedded in Camden County all conspired to truly make a difference! It is a pleasure to report we experienced astonishingly numerous compliments from rowers, coaches, spectators and first-time visitors to a regatta, as well as receiving any number of accolades from our very own volunteers! On behalf of the Dad Vail Regatta Organizing Committee, please accept our heartfelt thanks and please extend this expression of appreciation to all of the Camden County dignitaries and every single involved employee for all of their demonstrated teamwork which culminated in staging a successful Jefferson Dad Vail Regatta!

Director Cappelli opened the meeting to any member of the public who wished to address the Board of Commissioners.

Seeing no members of the public wishing to comment, Director Cappelli asked for a motion to close the public hearing. Deputy Director McDonnell made a motion with a second by Commissioner Dyer and all Commissioners voted aye.

The Director opened the floor to the members of the Board of Commissioners for their comments.

Commissioner Nash said as you mentioned at the beginning of this meeting, the community lost Sue Discher who was a terrific community advocate from Haddon Township, and also a dear friend of mine and to most of us. She had some medical issues, but her loss was shocking. Her services are Sunday and Monday. I want to pay my respects to her and pray for her family.

Commissioner Nash said, as you also mentioned, we had some outstanding events in May. I want to thank the members of the Parks Department and Special Events who did an amazing job, not only getting the parks pristine and prepared but also with respect to the logistics involved in those activities. I had so many comments from residents who said how clean the parks were. I also would like to recognize Dan Keashen who did a great job with public relations. The press covered these events in mass. Dan, I want to thank you for getting us that shout out. We had the Dad Vail, the Down and Derby Festival and the Best of Class Festival. The concert season gets under way after Memorial Day. Everyone in Camden County will receive a Parks Guide. We have a great line-up of concerts for this season. I think it may be our best season ever.

Commissioner Nash said finally I would like to congratulate those who worked on the budget, Deputy Director McDonnell, Ross Angilella, Steve Williams and their teams for preparing a budget that is not only accomplishing so much in terms of infrastructure and operations in the county but holding the line on taxes. I think residents recognize that taxes are a critical issue and for you to make sure that we accomplish our goals while holding the line on taxes is very important.

Director Cappelli said, Commissioner Nash, I want to congratulate you. Commissioner Nash next week will be receiving the Sister Peg Hynes Service Award from the Heart of Camden organization. A very well-deserved award. Jeff's long-term dedication to improving the lives and quality of life of the residents of Camden is certainly worth the recognition. Commissioner Nash said it is an honor because Michael Doyle was my hero and inspiration so to receive that recognition from the Heart of Camden is truly special.

Commissioner Young said congratulations Jeff. You are a true public servant. I too would like to thank the Parks Department. I had an opportunity to go to the Dad Vail and it was phenomenal. If there is one thing that Camden County does well, it is putting on a good show. I am pretty sure we gave Philadelphia a run for their money. The Dad Vail is going to have a tough decision whether to stay here next year or go back to Philadelphia.

At the beginning of the month, we attended the NJAC Conference. I want to congratulate Lou Cappelli for being inducted into the NJAC Hall of Fame. One of the great things about the NJAC Conference is a vocational school student cook-off. It is a competition among all the vocational schools in New Jersey. Before the competition started, I challenged our students to bring home as much hardware as possible and they showed up. We received two gold medals, both in the Pro Chef challenge which was based on presentation and taste. They received a silver

medal and a \$750 scholarship for the People's Choice Award and a bronze medal for the Judge's Award.

Our Department of Corrections is hiring. If anyone wants to become a correctional officer we are holding a virtual info session on May 23rd at 10 A.M. You can go on our website to sign up.

Commissioner Young said to Ed, Ross and Steve thank you for delivering a great budget.

Commissioner Kane said first I want to say how proud I am to work with all these wonderful Commissioners and the County staff who work very hard to make Camden County something to be immensely proud of. Thank you for all these accomplishments. The Commissioner said I want to particularly mention Commissioner Young who is the President of the New Jersey Association of Counties and did a phenomenal job with planning this year's conference where so many counties were educated about what is going on in the State. I want to thank him for his leadership, guidance, and countless hours of hard work.

The libraries have been selected to receive the 2023 Innovative Program Award in recognition of Camden County Library System's "Personal Care Pantry" program. This award is being given by the New Jersey Library Association and will be presented to the County on June 1st at its conference in Atlantic City. Congratulations to Linda Devlin and her staff.

This past Saturday in Roosevelt Plaza Moms Demand Action held a very powerful rally with residents throughout the County demanding action on gun control. The County was very helpful in organizing the event and making sure it went off without a hitch. Attendees walked the Ben Franklin Bridge and met moms from Philadelphia where we joined forces to show our dismay with gun violence in this country.

Last but not least, it is May which means Memorial Day. We are preparing for Memorial Day throughout the County. The County's Office of Veteran's Affairs has distributed over 30,000 flags in preparation of flagging all the cemeteries within the County. This coming Wednesday, the City of Camden, along with the County, will be cleaning up New Camden and Evergreen cemeteries and then we will be flagging them on Friday, May 26th along with Harleigh Cemetery. At the event on Friday will be County employees who will be on hand to assist in honoring the veterans and those who have died in combat. The County Memorial Day Ceremony is on Memorial Day, May 29th at 10 AM. This year it is being held at the Battleship New Jersey because there were some scheduling complications with having it at Veterans Island. As a side note, next Tuesday at 11 AM it is the Battleship New Jersey's 80th Year Commissioning Ceremony. The ship is the most highly decorated Naval ship in the country. Many Camden County residents are being honored this year with their banners being put up on the walkway. I encourage residents to come out to see the new banners. My son's banner is being added to the walkway this year along with my banner.

Director Cappelli said thank you Commissioner Kane for all the great work you do with the veterans. Thank you for your leadership.

Commissioner Dyer said I would like to thank the county workforce for the tremendous job they do for our County residents. I would like to give a special acknowledgement to the

Highway Department for preparing the roads for the Camden County College graduation. They did a great job getting that together and they worked well with other agencies.

With respect to the May events, while we are Commissioners, we are residents of Camden County as well. You can see the tremendous work that our staff does to prepare for these events. It was my first time attending the Down and Derby and it was a well-attended event. The weather was perfect, and everyone enjoyed themselves. I had a few family members with me who have attended similar events and they said this event was far better than any they had ever attended. As an athlete, a coach, and a fan I thought the Dad Vail Regatta was absolutely tremendous. I met an Olympian whose name was Aquil Abdullah. He was the first African American male to qualify for the summer Olympics in rowing. We had a great conversation. Ginny and I spoke with him, and he provided me with some grant information to help bring rowing and crew to Camden County. He showed me pictures of when he competed in the Olympics, and he had on his Olympic jacket which was very nice. He was a great guy. He is from D.C., and he is going to come down to help me get rowing and crew started. It was a great day for me.

I also attended Camden County College's graduation. Over 500 students walked in graduation. As an educator it was great to see the students that come from different backgrounds and who faced a lot of trials and tribulations to get their degree. Camden County College is the best bang for your buck. I always push students to go to Camden County. A four-year institution may not be for everyone. Over 1,000 graduated and 500 walked.

Finally, I have a neighbor in Pennsauken and he and his family just opened the Da'Villas Creme and Cookies in Merchantville. If you have not been there, please give that small business a visit. His name is Eddie Da'Villas, and he works for Pennsauken Township.

Commissioner Betteridge said as we can all see May was a very busy month for all of us. As a former Mayor and my first time going through the budget process here on the County level, it is just unbelievable the fact that you were able to reduce the levy by 6^C. That is a tremendous help for our residents. Thank you, Ed, for your hard work and everyone around this table who made it happen. May is Mental Health Awareness Month and the Department of Health and Human Services has certainly been busy in preparing and bringing awareness to residents in Camden County. We started the month on May 2nd at Camden County College where, under the leadership of John Pellicane, we had a tremendous workshop for community members and providers. We talked about getting rid of the stigma and how it affects people who, when they are stigmatized with mental health, don't want to or are not able to seek services. We are also in the process of working with Commissioner Dyer and the City of Camden to identify a new clinic location here in the city. We will keep you posted but if anyone needs free services that are provided through the Camden County Health Department, they are available at the Bellmawr Clinic which is located close to the intersection of Browning Road and Black Horse Pike right where the Bellmawr Municipal Complex is. There is an array of free services offered and I encourage residents to avail themselves to the clinic.

On May 9th we had a successful partnership meeting with all Camden city non-profits. Our goal is to map services to see who is providing what type of services and how we can work together. We had over 100 attendees at the meeting, and we are going to continue the conversation in the Fall. It was very refreshing to see the agencies that provide services to the most vulnerable here in Camden City and throughout Camden County who are willing to roll up their sleeves and

come together to have real conversations, so I thank everyone who helped put the event together.

There is proposed legislation related to Xylazine, which is a drug being added to narcotics. It is used for veterinary purposes, primarily as a horse tranquilizer. Unfortunately, it has reached Camden County and our country. Our Mental Health experts/Health Department experts under the leadership of Caryelle Lasher are working diligently to bring messaging to the community about the effects and consequences of adding Xylazine to illicit drugs on the market. One of the facts that I recently learned through the Health Department is that when this drug is ingested it attacks your flesh. Cooper Hospital, working in conjunction with the Health Department, has already released some data from the last year or two on the number of amputations that are being caused by the additive Xylazine. We soon hope to be distributing Xylazine test strips, but we are waiting for the pending legislation in the State of New Jersey. When legislation passes, we will be able to take a proactive approach in the community and provide test strips.

Finally, this Saturday I welcome everyone from Camden County to join me at Wiggins Park at 10 AM for the "Not All Wounds are Visible" walk. I hope and encourage the citizens of Camden County to join us in bringing mental health awareness to their community and work together to provide services with dignity and respect to all those who are suffering with mental health.

Director Cappelli said thank you Commissioner for putting that event together with all the agencies in Camden City. A lot of good will come from that.

Commissioner Deputy Director McDonnell said I want to thank all our employees for the great work they do every day.

Commissioner Director Cappelli said if you look back at this month and what is to come, I don't think there are too many other counties in this State that have had a Derby Day, kicked off a Miracle League, had the Dad Vail Regatta, Best of Class, Memorial Day Services to come and at the same time dropped the County tax rate to the lowest in twelve years. Our employes have done just a tremendous job and we cannot thank all of you enough. Getting the Dad Vail was a big big deal. The economic impact is significant. We already know that these regattas, prior to having the Dad Vail, probably result in about \$12 - \$15 million in economic activity in Camden County and now we have the Dad Vail, the biggest one in the nation. Everyone associated with that regatta was so thrilled. Not just the letter that Karyn read but we have received phone calls and emails. Great job everybody. We look forward to having that back again next year. In particular, in addition to Dominic and his team and everyone at the Parks and Special Events, Kristen Cass and Joe Calendo, our road director, are certainly deserving of credit for the work they did for the Dad Vail.

I also want to recognize and thank Agnes Walls who is retiring from the Camden County Clerk's Office after 34 years of service. Agnes, I hope you are watching. Thank you so much. Another person who is retiring at the end of this month from running Camp Sunnyside, another tremendous program that we provide, is Judy Franchi. Judy refuses to be recognized or come forward to receive a proclamation but certainly the work she has done at Camp Sunnyside is something we will appreciate forever as do many residents.

The Director asked for a motion to adjourn. Commissioner Young made a motion with a second by Deputy Director McDonnell and all Commissioners voted aye. The meeting was adjourned at 12:24 p.m.
