Work Completed this Report Cycle:

- The subcontractor installing storm pipe worked Monday through Friday setting inlet structures and installing the corresponding 15" RCP pipe at Stations 138+15L, 141+40L, 144+60L, 150+40L, 147+40R and 150+40R.
- The tree subcontractor worked Monday and Wednesday continuing to remove the crown and trunk of the tree at Station 128+75L.

Changes to the Initial Contract items:

- As previously documented in Progress Report #1, a No Cost Change Order #1 was submitted to and approved by the Camden County Commissioners. The change order incorporated Supplemental Items S-1 through S-12 for Pay Items that were not anticipated due to unforeseen conditions during the Design Phase of the project and also included Supplemental Pay Items in order to adjust unit costs of original pay items caused by the delay in construction which had resulted in higher material and labor costs.
- Bach Associates submitted a letter to the County on August 11, 2023 with cost estimates provided by the Contractor for five (5) Work Directives related to unforeseen conditions that arose during construction attributed to utility conflicts as follows:
