#### **Work Completed this Report Cycle:**

- There was no activity onsite this past Monday, Tuesday and Friday due to inclement weather.
- Wednesday and Thursday the pipe subcontractor continued to install the dual 12" DIP storm pipes to the proposed 'B' inlet at Station 121+80L. They set the precast concrete pad and built the inlet structure. They installed the 18" RCP pipe from the inlet at Station 121+80L to the proposed double 'B' inlet at Station 122+75L and then tied into the existing manhole. They set the pad and built the new double 'B' structure. At this point, the storm/drainage improvements are substantially complete.
- The pipe crew will return Monday and begin pouring concrete for the flow channels at each new structure, adjust the cast iron curb pieces at each inlet and complete asphalt trench restorations where necessary.
- The tree subcontractor worked on Wednesday only of this week grinding the tree stump at Station 131+00L. They still have 2 stumps remaining.

> The two Variable Message Signs (VMS) were replaced with VMS Boards supplied by the County since the rental units provided by the contractor had satisfied the terms of the contract.

### **Changes to the Initial Contract items:**

- As previously documented in Progress Report #1, a No Cost Change Order #1 was submitted to and approved by the Camden County Commissioners. The change order incorporated Supplemental Items S-1 through S-12 for Pay Items that were not anticipated due to unforeseen conditions during the Design Phase of the project and also included Supplemental Pay Items in order to adjust unit costs of original pay items caused by the delay in construction which had resulted in higher material and labor costs.
- As previously documented in Progress Report #13, the County approved Work Directives #1 Through #5 on August 16, 2023. The approved Work Directives add approximately 2.95% to the contract value.
