After review of the Operating and Project expenditures, Chairman Rohrer asked if all expenses were in budget to which Ms. DiMattia confirmed.

Chairman Rohrer opened the floor to the public at 8:27 a.m. Mr. Sean Brown inquired about the CCIA's role in dealing with empty buildings in Camden City and who he could reach out to. Mr. Lex responded that the CCIA has taken down approximately 3,000 abandoned buildings over the past few years, allocations are received from the state. A list is provided from the City of Camden of abandoned and vacant buildings. Mr. Jim Rizzo is the Camden City Building and Code Official.

Mr. Brown also brought up the Supreme Court case on property taxes in 13 states including New Jersey of violating citizens amendment right on properties being foreclosed. Mr. Lex responded that the CCIA does not get involved in any foreclosure actions, only property demolitions on the list provided by the City.
