The meeting was called to order by Director Cappelli at 12:00 p.m.

### **NO MOTION MADE – FAILED**

Director Cappelli opened the meeting to any member of the public who wished to address the Board of Commissioners.

Seeing no members of the public wishing to comment, Director Cappelli asked for a motion to close the public hearing. Commissioner Betteridge made a motion with a second by Commissioner Young and all Commissioners voted aye.

The Director opened the floor to the members of the Board of Commissioners for their comments.

**Commissioner Nash** said last month I gave recognition to Maggie McCann Johns who is leaving the County's employ at the end of next week but again she has done an outstanding job. I see that she is watching online, and I want to wish her well. She is going to be working for the State of New Jersey in a big job working with the Department of Environmental Protection heading up New Jersey's Urban Parks. She will be taking on new tasks that will include working in Camden County.

I want to give recognition to Steve Williams and his wife, Alexis. Yesterday they were the Ambassador Family at the March of Dimes luncheon in Philadelphia. They were featured, he and his two children, and received a rousing applause. Steve, you were great, and I congratulate you on that. I do want to thank Special Events for putting on a great program, the Made in New Jersey Festival, which was very successful. I want to congratulate Commissioner Director Cappelli for receiving recognition by CPAC as well as my wife Krista who was also recognized that night. It was a great night right before the Phillies 10-0 victory. Yesterday, Heart of Camden introduced its Neighborhood Revitalization Plan, receiving a \$1 million grant from the State of New Jersey to help with the Waterfront South Revitalization. That was also a really great event.

**Commissioner Young** said I would also like to congratulate the Director for his work with CPAC. I would also like to congratulate Commissioner Nash who also received an award at yesterday's luncheon from the March of Dimes. I am honored to be able to serve with two great individuals who are true public servants. I thank you. I would like to thank all the employees of Camden County, especially my departments, who always do a fantastic job.

**Commissioner Dyer** said I would like to commend Dominic Vesper for the great job he does with Employee Connections and the employee golf outing and banquet. Employee Connections is a great group. We don't always realize that we know so many folks that work in the County. I was talking to a colleague and saying how I can be at a light, and someone will pull up in a County truck and say Hi Mr. Dyer. These Employee Connections events are great because we get to see the people that are helping our residents on a daily basis. In closing I would like to

commend Jeff Nash and Director Cappelli for their recognition from the March of Dimes and CPAC.

**Commissioner Betteridge** said it has been a busy month at the Camden County Health Department and Board of Social Services. I urge everyone to go online and take a look at the County agencies, especially the Board of Social Services. They are asking for anyone who is currently enrolled in Medicaid to complete a redetermination. It is extremely important that everyone does complete the redetermination because as of the end of the pandemic the Department of Human Services is requiring that everyone completes a redetermination. In the years we were in the pandemic, all renewals were done automatically. Now that is not going to be the case.

Tomorrow I will be at a panel discussion held at Rutgers University in Camden regarding Methamphetamines. The discussion is related to methamphetamines, its presence in Camden County, the addictions and the evidence-based treatments. This panel that has been put together for tomorrow's event is, in my eyes, an AAA panel. They have been very relevant here in Camden County under the direction and leadership of the Camden County Addiction Awareness Task Force. I have only been a member for a few short months, but I have really been amazed at the work the Task Force is doing. I want to take a moment to thank the Director because it was his efforts ten years ago that formed the Addiction Awareness Task Force. The Task Force is doing tremendous work and tomorrow we will see some of the efforts and the work that is being put together to combat illicit drug use here in Camden County.

On November 17<sup>th</sup> we are going to be hosting another conference at Rutgers University in Camden. This conference is based on mental health and homelessness. We are striving to bring together all providers here in Camden County and Camden City to talk about the relevancy of what we are seeing as one of the number one crisis here in Camden County, which is homelessness. Together with the Department of Health and Human Services and the leadership of Caryelle Lasher, John Pellicane and Dr. Nwako we are bringing this group together. We originally met back in May. A 13-member core group has been invited. This 13-member core group is putting the conference together and I urge you to join us, even if just for a half hour or hour. The information is very compelling. The initiative is to collaborate and bring together all the agencies that are supporting these efforts here in Camden County and Camden City.

Director Cappelli congratulated Commissioner Betteridge on the great work with the Senior Health Fair.

**Commissioner Deputy Director McDonnell** said I want to join Jeff in congratulating Maggie McCann Johns on her new position and thank her for her service to Camden County. I wish her much success in her new job. I join with everyone else in congratulating Lou, Jeff and Steve Williams on their recognition this week. I have to also echo what Al Dyer said about Dominic Vesper and Employee Connections. I know there are lots of other people involved but it was Dominic's idea, and it has been an incredibly important and valuable service to our employees and the operation of our government. Thank you very much, Dominic. I also want to thank all our employees for the work they do for our citizens every day.

**Commissioner Director Cappelli** said it looks as though the weather is clearing for Saturday. We have our first annual Dominic Vesper Mummer's Parade this Saturday beginning at 2:00. The parade begins on Euclid Avenue in Haddonfield and goes down Haddon Avenue

towards Haddon Township. After the parade a lot of the bands will be going to different restaurants and other locations on Haddon Avenue to make a really fun family day in Camden County. We will have more bands than the actual Mummer's Parade. It is going to be a great parade and I hope to see you all there. I too want to congratulate Jeff and Steve on their March of Dimes award.
