Director Cappelli opened the meeting to any member of the public who wished to address the Board of Commissioners and asked that those wishing to speak limit their comments to three minutes to allow as many people to speak as possible.

Seeing no members of the public wishing to comment, Director Cappelli asked for a motion to close the public hearing. Deputy Director McDonnell made a motion with a second by Commissioner Nash and all Commissioners voted aye.

The Director opened the floor to the members of the Board of Commissioners for their comments.

**Commissioner Nash** said Director you did a great job today at the Battleship ceremony.

As Spring is upon us and you start to clean out your garage, think about donating your old tools to our Tool Saving Library where we can refurbish them and get them back out for use at no cost to our residents.

Commissioner Kane said I would like to thank my fellow Commissioners for being there and braving the cold on the Battleship today. I watched it on the live stream and Director Cappelli your remarks were excellent. Thank you also for your ongoing support of our military and our veterans. On March 10<sup>th</sup> Camden County held a new event at the Collingswood Ballroom called Empower Her which is geared toward addressing the needs of our female veterans. We had almost 50 different organizations present along with 100+ female veterans and men who support and love them attend the event and luncheon. The panel conversation dealt with recognizing the unique needs of women, the stigma of women serving, sexual trauma, self-care, wellness and a variety of other topics. It was very well received and is certainly an event we will be holding again in the future. I want to thank the volunteers of the Camden County Veterans Advisory Committee for helping to put the event together along with Frank Filipek and his staff at Special Events and the staff at Veterans Affairs led by Colonel Gallagher.

Commissioner Kane said the last thing I want to mention is the Prom Dress Giveaway that is going on currently at the Boathouse for young women in our community who will have the opportunity to pick out a beautiful prom dress. Thank you to the residents of Camden County who graciously donated dresses and to the County staff who are participating in the event.

Commissioner Dyer said great job Commissioner Kane with the Empower Her event. You were a great moderator and kept everyone engaged. Being that it is the last few weeks of Women's History Month, I want to mention a friend who has a small business in Camden County. Yesterday I had the chance to visit a young lady named Lashaun Drew, who has a restaurant in

Voorhees called The Original Hot Dog Factory. I encourage everyone to go there and support her. She also has a women's non-profit through which she helps a lot of women in Camden. Lastly, thank you to the County employees for all you do. Thank you, Dominic, and everyone for keeping Employee Connections going.

Commissioner Deputy Director McDonnell said today was an important day for us in many ways but particularly because we introduced the 2024 Camden County Budget. There are a lot of people to thank for this budget, the Board of Commissioners, Departments Heads, DCAs and the employees of Camden County. What we have been able to accomplish today with the direction of Ross Angilella, Steve Williams our Financial Officer, and Yolaika Gonzalez VinaMarte is a tremendous budget. It literally reduces the tax rate in Camden County by  $6^{\mathbb{C}}$  and that is down 12<sup>©</sup> since 2022. It is an amazing accomplishment. We will all be proud to know that the value of property in Camden County, called the tax base which reflects the value of all property, commercial and residential in Camden County, went up by \$5.5 billion in value this year. That is remarkable and is part of the reason we were able to lower the tax rate. \$5.5 billion is in addition to last year when our tax base, the value of all property in Camden County, went up by \$5 billion. We are up in value of property \$10.5 billion in Camden County. Now what does that mean? It means it is very much more manageable for us to maintain the great quality of services that we do, and without barely touching the cost to taxpayers. In fact, in Camden County most taxpayers will see a reduction in their county tax rate this year. That works because it is a great place to live and we are making it a better and better place to live every year and that is why the tax base goes up. Property becomes more valuable because the place where it is located is more valuable. Thank you to everyone in our government and in this room today, particularly Yolaika and Steve. Steve, you are doing an absolutely spectacular job as our CFO and we all very much appreciate it. We should also give a round of applause to Yolaika and to Ross Angilella for a great job. Congratulations to everyone and thanks to all our employees who work so hard for the citizens every day and do such a great job.

Commissioner Director Cappelli said thank you Ed. You are being humble because you lead this process year after year and holding the tax rate in check is not an easy thing to do. Not too many other governments do that but thanks to your leadership and everyone you mentioned we have been very successful. Thank you for your hard work. I too would like to thank the employees of Camden County for the hard work they do day in and day out for our residents.

The Director asked for a motion to adjourn. Commissioner Young made a motion with a second by Commissioner Dyer and all Commissioners voted aye. The meeting was adjourned at 1:47 p.m.
