The meeting was called to order by Deputy Director McDonnell at 12:00 p.m.

The Clerk called the roll and the following Commissioners answered:

The Deputy Director stated that adequate notice of this meeting has been provided in accordance with the Open Public Meetings Act.

The Deputy Director asked everyone to rise for the Pledge of Allegiance.

The Deputy Director said good afternoon, ladies and gentlemen. Welcome to the meeting of the Camden County Board of Commissioners. We begin this afternoon's meeting with the presentation of a Proclamation to recognize Parkinson's Awareness Month. The Deputy Director called upon Commissioners Betteridge and Kane to present the proclamation.

Commissioner Betteridge said thank you for joining us this afternoon so we can bring this proclamation forth in a time when we need to bring awareness to Parkinson's disease. The Commissioner asked Stephen Thurman and Megan Matis to come forward.

Commissioner Betteridge said the Parkinson's Foundation was founded in 1957 and through this organization individuals have access to community grants, a toll-free helpline and free educational resources for those individuals suffering from the disease of Parkinson's as well as healthcare professionals. Living well with Parkinson's disease means getting the support you need from tools that help you work alongside your care team to resources that empower you. The Parkinson's Foundation is a trusted ally for information that can assist in navigating through every stage of this disease that can provide life-changing support to individuals suffering with Parkinson's. The Parkinson's Foundation has received \$449 million in funding for research, funding to support 678 scientists, has provided 13,600+ people with Parkinson's with genetic testing and in 2023 the foundation hosted 787 community-based programs. The Board of Commissioner of the County of Camden does hereby declare April to be Parkinson's Awareness Month and urges the citizens of Camden County to strongly support Parkinson's Awareness initiatives.

Stephen Thurman thanked the Board for the Proclamation. He said I would like to share a couple of things with you just to give you an idea of the extent the disease is present. Nearly 1 million people in the United States have Parkinson's disease and the expectation is by the end of this decade there will be 1.2 million people. Worldwide there are approximately 10 million people with Parkinson's. There has been a significant increase in the number of people with Parkinson's.

This past year 90,000 new people were diagnosed. Three or four years ago we were talking about maybe 55,000 to 60,000 people so there has been an increase in the number of people identified. We are here today to make you aware of Parkinson's. It is the second most common neurodegenerative disease in the world behind Alzheimer's. It is very prevalent and most of us know someone who has Parkinson's or knows somebody that knows somebody. I really appreciate the Proclamation.

Megan Matis said thank you so much to the County Commissioners. This is actually their second year recognizing Parkinson's Awareness Month and we are so grateful. My name is Megan Matis, and I am the coordinator for the Parkinson's Connection for the JCC in Cherry Hill. We would not have the program that we have without the support from organizations such as the Parkinson's Foundation. We run 25 weekly programs for people with Parkinson's throughout our local community and beyond. We are so grateful to work with this population. We know now that exercise, physical activity and social connection are vital to people who are fighting Parkinson's disease. We facilitate programs that provide all of these services to our local community.

My name is Charles Kapulski and I am with the Parkinson's Foundation. I am the local representative and the Senior Director of Development for the northeast region. I want to thank everyone here and my colleagues. We cannot do what we do without their support and providing resources to people in our local communities. At the Parkinson's Foundation we advance clinical research and care and also fund community grants programs. As a proud local from the South Jersey area I am so honored to be here today with my colleagues to advance Parkinson's awareness.

Deputy Director McDonnell thanked everyone for coming out today and said next on the Agenda we will be taking actions related to the County's 2024 Budget.

PUBLIC HEARING

2024 Camden County Budget, as introduced and adopted.

Deputy Director McDonnell opened the public hearing to anyone who would like to comment. Receiving no comments, the Deputy Director asked for a motion to close the public hearing. Commissioner Dyer made a motion with a second by Commissioner Nash and on roll call all Commissioners present voted aye.

Deputy Director McDonnell asked for a motion to adopt the Resolution. Commissioner Nash made a motion with a second by Commissioner Kane and all Commissioners present voted aye.

The Deputy Director said I want to make a note for everyone and take special pride in thanking our Commissioners. This is a really great budget which drops the Camden County tax rate by $6^{\mathbb{C}}$. It also reflects what I think is really important and that is that the value of all property in Camden County has, for the second year in a row, increased by \$5 billion. Over two years the value of all property in Camden County, we call it the ratables, has increase by \$10 billion. That means properties are growing in value, people are pleased to be here, houses are selling when they are available and people continue to move to and enjoy Camden County. That is thanks to Ross Angilella who is not here with us today, our CFO Steve Williams, our Deputy County Administrators and Department Heads who work so hard every day trying to provide the best services we can while minimizing the impact on our citizens. Congratulations to everyone on the Board on a great 2024 Budget.

The Deputy Director said the next order of business is the introduction of a Bond Ordinance.

Bond Ordinance of the County of Camden, New Jersey, in connection with various improvements for Camden County College, appropriating \$3,095,000 therefor, and providing for the issuance of \$3,095,000 in Bonds or Notes of the County to finance such appropriation.

A Public Hearing on the Bond Ordinance will be held May 16, 2024 at the Camden County Courthouse, 520 Market Street, 6th Floor Meeting Room, Camden, NJ at 12 noon.

The Deputy Director called for a motion on Resolution No. 98 acknowledging personnel actions requested by or on behalf of Constitutional or Statutory Row Offices.

NO MOTION MADE – FAILED

Deputy Director McDonnell opened the meeting to any member of the public who wished to address the Board of Commissioners and asked that those wishing to speak limit their comments to three minutes to allow as many people to speak as possible.

Seeing no members of the public wishing to comment, Deputy Director McDonnell asked for a motion to close the public hearing. Commissioner Nash made a motion with a second by Commissioner Betteridge and all Commissioners voted aye.

The Deputy Director opened the floor to the members of the Board of Commissioners for their comments.

Commissioner Nash said Ed, let me congratulate you. You mentioned a group of people who helped with this outstanding Budget, but you excluded yourself because you are modest. We all know that you are enormously instrumental in this budget process. Most describe getting funding from the County as scraping chrome off the bumper thanks to your philosophy but as a taxpayer we greatly appreciate that so thank you. Thanks to Ross and to Steve and their respective teams that put together this outstanding budget for the residents. What I find remarkable about lowering the tax rate is that we are doing more and providing more government services with less. I think if more governments would take that approach people would be appreciative.

Commissioner Nash said, speaking of Ed McDonnell, this morning I went to the Larc School Appreciation Breakfast and Ed gave a terrific speech. There was a wonderful video presentation of the children of the Larc School which brought tears to me and everyone else in the audience. I was there with Commissioners Kane and Dyer and it was really special to see the great work that is done at the Larc School. Ed, you have been the Chairman of that Board for ever and you have done a remarkable job for maybe the most important thing we can ever do and that is help the children who are most in need. Commissioner Nash said we also had the opening of the Mirale League which Karen Weidner assists with. That was also a wonderful event.

The Commissioner said I want to give a couple of shout outs. First to Jim Rhodes. Jim has been working with the Animal Shelter in Camden County, Homeward Bound, for quite some time. I recently became the liaison. It is a wonderful shelter and Jim is the person who deals directly with the public on those issues, and it is a challenge. Good things are coming out of that shelter, but it is a challenge and Jim puts 24/7 into that effort. Thank you, Jim. I don't know what I would do if you weren't taking the lead on that.

Commissioner Nash said I would also like to recognize the Parks Department. There has been a transition over the past several months. Scott Traynor is now the Director and Ashley Pagan is the Deputy Director. The management team at Parks is juggling 60 parks projects in every corner of Camden County; too many to name. We all get notices about the ribbon cuttings when they are finished but it is a remarkable job and Scott you and your team have done an outstanding job. I want to tell you how happy I am and how proud I am of the work you have done. Dom Vesper is always there mentoring everyone and does a great job as well.

Finally, the summer concert season is upon us. We have a great line up and it all begins on June 3rd at all of our Parks.

Commissioner Kane said I want to start by noting the passing of Col. Al Bancroft who was a dedicated County employee at Veteran's Affairs for more than two decades. He passed away on March 26 of this year at age 84. For anyone who has been involved with the military community in the County, Col. Bancroft was the face of Camden County. Any event you went to he was there in his uniform as proud as he could be for being a Marine. He set the tone for the respect the County has for those who have served. We all mourn his passing and thank him for his three tours in Vietnam and his dedication to all those who have served following his return home.

The Commissioner said I would like to thank the staff of the Camden County Library System who, in preparation for the eclipse, passed out almost 6,000 pairs of glasses. Commissioner Kane said thank you for coming out today for Parkinson's Awareness. I have been a proud member of the JCC for many years and I know the JCC has been a leader in our community with the 25 programs offered weekly as well as support for families. Thank you for all your hard work and dedication and for bringing awareness to Parkinson's. The Commissioner said, finally, this morning Deputy Director McDonnell and Commissioner Dyer and I joined the Prosecutor's Office in the dedication of Investigator Jack McLaughlin Way who was killed 30 years ago as a Detective for the Prosecutor's Office. His family was there today at the dedication. The fact that almost 30 years later his name is said, and his dedication, service and sacrifice is remembered is

very meaningful to the family and to all of our brave men and women who put on a uniform every day to put themselves at risk. I thank the Prosecutor's Office for that dedication.

Commissioner Dyer said as a Commissioner, the events we attend can be enlightening, and sometimes we try to bring awareness to a particular situation. I attended an event in Haddonfield called "Preserving Black History Tour". As a former or retired educator, I am a lifelong learner and I love history. I have driven through this particular area several times but never knew the rich history. The tour covered 12 sites. One of the sites, which is a football field now, was called Centennial Field. The tour guide explained that the Negro League played on this field right in Haddonfield. Some of the decedents are still there, a lot of the businesses are still there, the houses are still here as well as a church that is 120 years old. We were able to walk through this neighborhood, which took us about 1 hour, as our guide explained everything to us. We have a lot of rich history in New Jersey and South Jersey but I did not know Camden County had such rich history with regards to where blacks had settled. The census in 1950 noted 234 black families that lived in Haddonfield. Now, 1% of black families live in Haddonfield. I went home, put my kids in the car and drove them through the area and I was their tour guide. Kids knowing their history and other histories is how we should go about raising our kids.

Commissioner Dyer said the 27th Street Ribbon Cutting was amazing. I grew up in East Camden. Mike Rozier, who the roadway was dedicated to, was there. I was a ball boy for him as a football player. He won the Heisman Trophy in 1983 from my alma mater, Woodrow Wilson. Being there and being able to speak and see his former teammates who I looked up to growing up were all there. His coach was there. His mom was there. She is 93 years old and for her to see us give him his flowers while she is still around, it was a perfect day. For me, I rode my bike, I used to walk on that street and as an adult I drove my car on that street. If you ever drove on 27th Street, you would drive your car and swerve to miss the potholes. It was like that since I was in middle school so you can appreciate the gratification of the neighbors. My second year as a teacher at Woodrow Wilson, I was a freshmen basketball coach, and I would put 5 guys in my car and take them home after practice. We would come down Federal Street, get on 27th Street and the rollercoaster would start. One day I pulled in front of one of the guy's house and sirens come on. There was a cop behind me. She pulls up to the car and says I need your license, insurance and registration. She asked me if I knew why she was pulling me over. I said no and she said because you were swerving. I said, well officer I was looking in the mirror and you were serving too. The cop started laughing with me. It was a great day celebrating getting 27th Street paved. We did the alleyways, the ADA sidewalks, and traffic signals. I want to thank Bob Harris, Dom Vesper, and the Camden City Department of Public Works. This was a project that took 2 ½ years. I had to talk about this because it is so gratifying.

Commissioner Betteridge said Commissioner Kane you brought back a time in my life that I recall the incident in Haddon Heights. I regret not being able to join you this morning, but I was very pleased knowing the Commissioner Board was well represented. The Commissioner said I am pleased to announce that on June 17th at Rutgers University, together with the Camden County Department of Health and Human Services and the Camden County Board of Social Services, we are going to be hosting a conference on maternal and child health. We have been trying to tackle and deal with these issues for many years but last year it came to my attention that out of 1,000 live births, 7.3 babies do not make it. We pulled together stakeholders who are committed to changing that trajectory and I am pleased to announce that on June 17th we will be

hosting a conference at Rutgers. Our keynote speaker will be First Lady Tammy Murphy. I extend to my colleagues a warm invitation and to the public that may be listening, this is geared toward service providers here in Camden County but certainly we will disseminate all the information that is gathered that morning to make sure that Camden County residents are aware of the services that are available before pregnancy, during pregnancy and post-partum. We have learned that post-partum for many moms comes with post-partum depression and that is not something we should just turn away from. Post-partum depression is a mental health issue, and we are here to stand by those moms to make sure they are getting the proper care. This is a huge undertaking and there are many departments here in Camden County that are assisting us that day but in particular the two departments which I am the liaison to which are the Department of Health and Human Services and the Board of Social Services. I am very appreciative of the help that the leadership and their teams are providing to make sure we have another successful conference.

Commissioner Deputy Director McDonnell said speaking of the events today, I have one shout out to our Deputy County Administrator, Dominic Vesper. I have apologized to him already but I think he deserves a public apology. This is the third event he and I have been to today and at the first two he was right there and I neglected to recognize him. He is here now so I am giving him recognition. Sorry Dominic, I apologize.

The Deputy Director asked for a motion to adjourn. Commissioner Nash made a motion with a second by Commissioner Kane and all Commissioners voted aye. The meeting was adjourned at 12:33 p.m.
